We agreed on the following three courses for Haida Gwaii EOC Basics, EOC Logistics and Emergency Evacuations further, we will feed the information gathered from our evacuation exercise planned for all island for April 2017 to the instructor for the Emergency Evacuation course so that hopefully they can build the knowledge learned from our local exercise into their scenario and training and enhance our local knowledge. Kim will advise Maurie Hurst of our training wishes for 2017/18.

Planning for Community Disaster Recovery – Saturday Jan. 21/17 – Port Clements ESS Site Management – Saturday Feb. 18/17 – Port Clements High Ground Hike – all communities invited to participate – week of April 9, 2017

4. Youth Representative

Shelley Termuende's engagement work with Youth is on-going. It was suggested that each community/area identify one youth to encourage to take part in EOC Basics Training when that course becomes available next year

5. Standardization and/or sharing of Forms

Shelley Termuende will work with Kim on setting up an All Island Emergency Planning "Drop Box" account where documents can be stored/reviewed/altered and discussed. The thought behind this is to save communities from reinventing the wheel when one community has a form or procedure that might be applicable/useful for other communities.

6. Check in by attendants

Lori Wiedeman updated us on the Tsunami Pole project for which an intern will begin work November 21, the Province will make an announcement about the project on November 22 and the target is to have the project completed by April 8, in time for the Hike to High Ground event island wide in 2017. Lori is looking for an individual from each community to be part of the steering committee for the Tsunami Pole painting project. Each community to forward a name to her ASAP.

Chris Ashurst updated on the two notification systems he uses (One Call & Connect Rocket) and will distribute a written report electronically. From discussion generated on this it looks like One Call may be a good alternative for the entire Island – the Regional District pays for this feature for the unincorporated areas of Haida Gwaii. He also updated on funding and projects in the works for the Archipelago Search & Rescue and Masset Marine Rescue in regards to vehicle and vessel acquisitions.

Marilyn Bliss and Aaron Cunningham updated on a very generous donation of emergency food donated to Port Clements Emergency program. Marilyn will be inventorying it and organizing it by expiry date but at quick glance it looks like the shelf lives of the products range from 15-35 years. There is enough food for approximately 1000 meals and there is great variety including spices, breakfast foods, meat, vegetables, fruits, desserts etc.

Kim Mushynsky reported that someone from Natural Resources Canada will be in Port Clements early in the new year to test some seismic equipment.

MIEDS Grant Writer Final Report

The Misty Isles Economic Development Society (MIEDS) Grant Writer position for 2016 was a full-year, part-time (~20 hour per week) position. The Grant Writer is required to write a minimum of \$600,000.00 in grants, approximately \$200,000.00 per municipality, and work 1200 hours by December 31, 2016.

Totals for 2016:

Total Applied Amount	\$1,550,121.94
Total Hours Worked	1,200

The Grant Writer works alongside municipal government staff to apply for funding that aligns with Council priorities. As time permits, the Grant Writer also works to assist non-profits with planning, grant writing and reporting activities. Non-profits that have worked alongside the Grant Writer in 2016 include, but are not limited to:

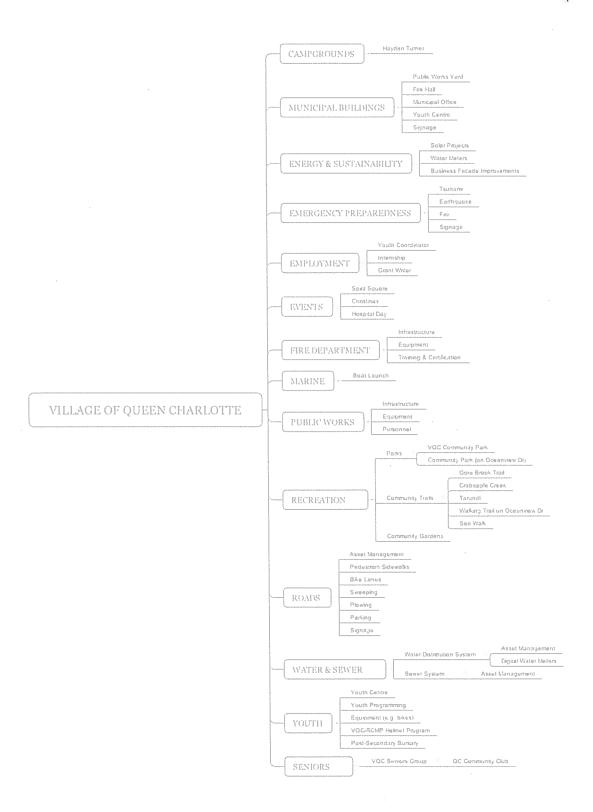

Key Recommendations

The Village of Queen Charlotte is full of active community and island-wide non-profits that run a variety of the programs or spaces, including the Visitor Centre, Literacy Haida Gwaii, Laskeek Bay Conservation Society, etc. Many of these organizations have in-house grant-writing capacity, but benefit greatly from having a Grant Writer to revise or edit their applications. Instead of offering to write grants for non-profits, in which case the Grant Writer acts as a surrogate employee of said non-profit, it's recommended that the Grant Writer work to mentor the non-profits and support them. The number of groups that have similar mandates and can partner for grant applications is high and these partnerships can reduce the amount of work placed on individuals.

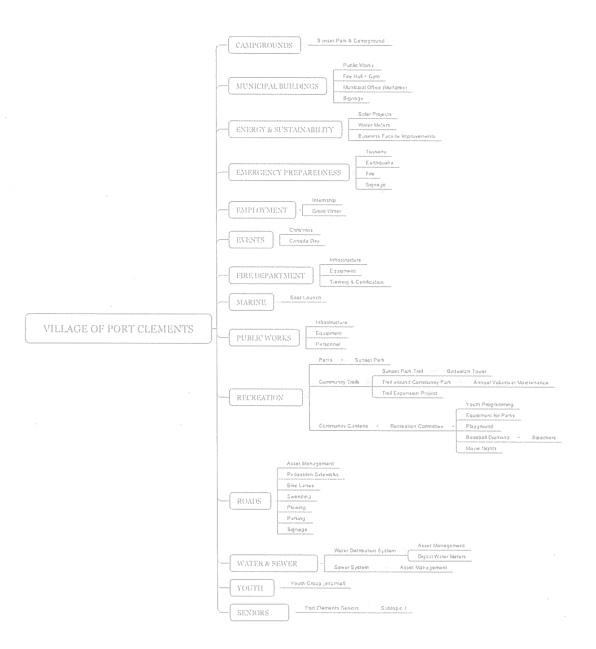

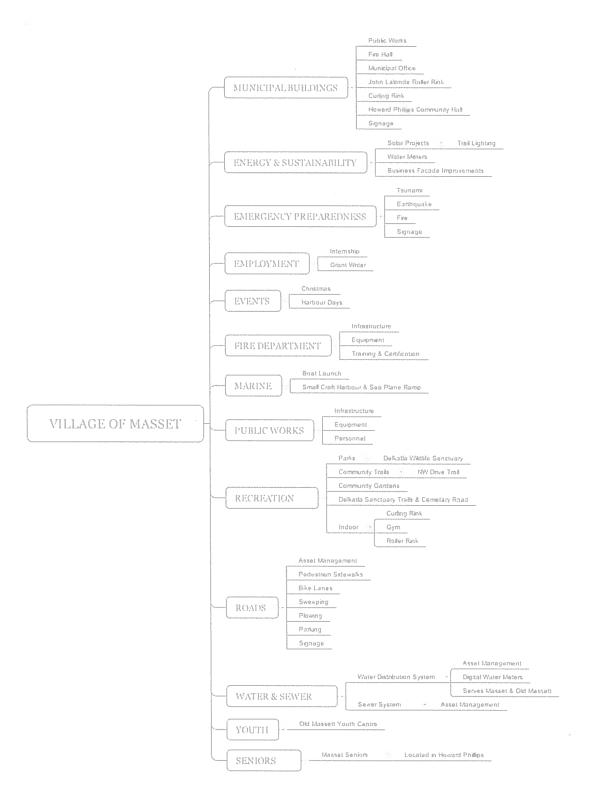
Key Recommendations

The Village of Masset owns a variety of buildings in the community that may be run by non-profits in other municipalities (i.e. Community Hall). Many groups approach the Village for assistance to improve facilities. These groups bring with them a passion to grant write, fundraise and assist, so long as direction and support is provided. Providing consultative advice to these groups will build grant writing capacity at the grassroots level and will provide autonomy to a group that may not own their infrastructure, but would love to see improvements. It is recommended that this process for project planning, grant writing and reporting be simplified, and written strategies to be made for non-profits to prepare and gather required documents.

Next Steps

As the current Grant Writer phases out, applications for the hiring of a new Grant Writer for 2017 have been submitted. It is estimated that MIEDS will fill the position by February at the earliest, once the grant has been approved.

Items for the new hire, based on priority level, include:

- 1. 1-Hour Training: orient to Google Drive, e-mail, grant database, local non-profits list, grant writing binder (Jan/Feb 2017);
- 2. Grant search and update grant database for 2017;
- 3. Create Grant Strategies for each municipality for 2017, aligning grants with Council priorities;
- 4. Outreach new hire meets with non-profits to discuss applications;
- 5. Understanding the transition requirements for the new BC Societies Act
 - a. Engage with community stakeholders who may require assistance for transition
 - b. Prioritize municipal applications and work alongside non-profits to ensure smooth transition and apply for non-profit grants (as required and as time permits)

Dear Respected Chief Councillor, Mayors, and Councillors:

I write this letter with two purposes, to advise of QCINet 2017 upgrade plans and to dispell odd rumors which seem to be circulating.

UPGRADE PLANS

As you may be aware the Federal Government has announced a \$500 million funding program called "Connect To Innovate", where they will assist in investing in both backbone extension and last-mile infrastructure ("last-mile" is delivery to the house).

QCINet will be applying for funding to replace all wireless gear everywhere with the newest technology called "LTE". LTE (which stands for Long Term Evolution) is precisely what cell phone companies have been upgrading to. LTE delives excellent penetration thru trees.

QCINet commenced an upgrade in mid 2015 to a lesser technology "MiMo" within the communities. For those who received that upgrade, speeds were significantly improved. Sadly MiMo technology does not like trees. Hence internet delivery to the outer "treed" reaches of QCINet coverage areas still remains challenging or impossible. The new LTE technology will both improve speeds rivaling what would be expected from fiber optic, and be able to deliver to the present problematic treed areas.

QCINet has looked at expansion via fiber, however there are high expenses and complexity with the launch of fiber which include:

- lashing fiber on all the poles
 - ongoing rental fees to Telus (for life!)
- the need to place metal cabinets and generators in neighborhoods
 - right-of-way agreements, rental/lease of space
 - more unsightly boxes in the neighborhoods
- new drops similar to hydro & telephone on each and every location
- multi millions of dollars
 - a recent GwaiiTel study determined that a phase 1 fiber project would only cover the dense areas of population and exclude the outer reaches. This is LESS than desirable!
- still considered an elite delivery method
- special training required for the simplest of maintenance

The launch of LTE will be as simple as placing new transmitters on the various towers and poles and replacing existing boxes on houses, making deployment and launch for all areas within the year of funding approval a reality. LTE will reach the corners of the QCINet coverage areas with speeds rivaling fiber, with far less cost and complexity, and none of the disturbance to the neighborhood that a fiber deployment would generate. LTE has the signal penetration capabilities so that every area of our communities will enjoy fast and reliable internet, not just the densest populated neighborhoods.

QCINet will be seeking letters of support from Councils, businesses, and residents to accompany its grant application.

RUMORS

- The biggest single rumor I hear is "the usage/excess fees are making QCINet rich". Nothing could be further from the truth. GwaiiTel presently charge the ISPs "by the byte" which is to say that the usage fees which the ISP charge the end user are passed on to GwaiiTel to cover the GwaiiTel monthly invoice. The charges are not pocketed by the ISP. As a matter of fact the QCINet monthly bill from GwaiiTel for November was \$29,430. December was \$27,558. It takes a lot of people's \$33 plus excess charges to cover this monthly costs, plus make a buck, plus retain a bit for upgrades and maintenance.
- "aren't you subsidized so that fees should be reduced". No. QCINet has never received a subsidy or grant. The application going forward to the "Connect To Innovate" program will be the first funding opportunity sought by QCINet.

 GwaiiTel is scheduled to re-visit their pricing soon and it is hoped they will reduce their charges to the ISP so that reductions can be passed on to the end users, but as it stands the ISPs do not receive any funding from any source other than end user fees.

- "Why does GwaiiTel set the ISP's prices". They do not. The ISPs are independent and privately owned. GwaiiTel can not dictate nor have they tried to suggest ISP prices. However, when the ISP gets a monthly internet bill from GwaiiTel approaching \$30,000 then GwaiiTel certainly has a significant influence on ISP pricing.
- "Aren't you mandated to provide internet everywhere". No. There is no law which states that an ISP must expand or cover any specific area. That would imply that a law exists which would force a private company to spend money for expansion. That said, once Federal or Provincial grant money IS received, certain stipulations ARE placed on the funding, including mandatory minimum speeds, maximum pricing, and coverage areas. Wouldn't it be nice if Telus could be forced to place a cell phone tower in Port Clements, or Esso place a gas station in Tlell.

I urge anyone with questions to ask me directly. I will always answer honestly and without any political bias. Rumors on Facebook or around the restaurant coffee table are usually speculation and usually very incorrect. I would be pleased to confirm or correct any bit of internet information you may have.

QCINet has always wanted to deliver a great signal to all customers. Indeed the formation of QCINet in July 1997 was to bring affordable and fast internet to the residents of Haida Gwaii. The logistics of this however is difficult. Technology has not been available to beat the trees, until now that is. LTE technology will solve the tree problem. Once and for all! Also, when LTE wireless internet is installed, it will be available to all the residents within the QCINet coverage areas, not just the elite in the densest neighborhoods like the GwaiiTel Fiber Expansion phase 1 planned for. That is QCINet's goal, that is *my* personal obligation. With success in my "Connect To Innovate" funding application, I personally commit to spreading fast reliable internet to all my coverage areas from Port Clements thru Tlell, Lawn Hill, Skidegate, Queen Charlotte and Sandspit.

Kim,

It is getting to be that time again and Masset is submitting a couple of projects for the upcoming Gwaii Trust Major Contributions Program. If possible we would appreciate letters of support from your community before the submission Deadline of January 27, 2017. The two projects are as follows:

- 1) Old Curling rink conversion to fitness centre. We are proceeding with the basic plan that Haida Gwaii Fitness had for that building but keeping space available for other programs like aerobics, Tai Chi etc. Our application this month will be for phase one of the project getting the basics of the building re-established, getting the heating system operational, electrical upgrades, washroom installation, dividing walls, additional exits, storage space etc. Our Project budget for this phase is \$150,000 and we are seeking 50% funding from the Major Contributions Program. We feel this project is beneficial to all communities in the North as it provides an additional indoor recreation facility and can even take pressure off some of the existing spaces that are being used now. This first phase will allow the Haida Gwaii Fitness Association to move into one part of the building and give them an increase in space to use. The next phase will be working with Haida Gwaii Rec and other users to finalize the remaining space for future programs.
- 2) Water meter upgrades for our Commercial users. We are submitting this application again (we were turned down last year) and our project budget is approx. \$115,000 subject to final quotes and we are again seeking 50% from Gwaii Trust. We feel this project is beneficial as it provides us with better monitoring of our commercial users and the electronic meter reading would be of great assistance in detecting leaks or sudden changes in usage. Because we are on a shared water system, the efficient use of water is important to both Masset and Old Massett and helps us reduce costs and protect this valuable resource.

Any assistance you can provide with letters of support for these projects would be appreciated.

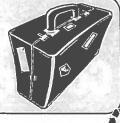
