Dear Mayor,

We are contacting you as the Mayor of the Village of Port Clements to ask you to join our Canada-wide mobilization to get our federal government to re-introduce a strict separation (firewall) between commercial banks and investment banks, known in the 1980's in Canada as the « four pillars » policy and in the United States as the Glass-Steagall law that came in existence in 1933 under President Franklin Delano Roosevelt and was repealed, unfortunately, in 1999.

It is obvious that what we are now facing is not just a cyclical economic crisis. What we are witnessing in southern Europe and in Detroit are the advanced warnings of the coming disintegration of the system. What is therefore required are bold decisions that have to be taken soon to rebuild the physical economy for the benefit of all Canadians and generations to come. The solutions exists but time is pressing if we are to avoid a systemic collapse first throughout the trans-Atlantic region and then, of the world economy.

Learning from Cyprus and Detroit.

To the numerous bailouts of the "too big to fail" banks since 2008, we have now a new resolution policy from the tool box of the bankers: the <u>bail-ins</u> as practiced against depositors in <u>Cyprus</u> or against pensions of city employees in the case of <u>Detroit</u>, is equally proposed, in black and white, in the <u>Canadian budget</u> ("Economic Action Plan 2013").

In the United States, resolutions demanding the reenactment of the Glass-Steagall law have been introduced by a number of city councils and twenty five State Legislatures.

On Aug. 10, 2013 on the fiftieth anniversary of the Elysée Treaty, twelve mayors and elected officials from France and Germany gathered in Arzviller, France launching an initiative declaring that "the first step to be taken is to separate banks in order to prevent the financial criminals from doing further damage, because they know the state will protect them. This is known as the principle of the Glass-Steagall Act of Franklin D. Roosevelt, which we also had in Europe after 1945."

These developments typify a growing movement in the United States and internationally which demands immediate action by the U.S. Congress to reinstate Glass-Steagall. In the U.S. House of Representatives, Congresswoman Marcy Kaptur has introduced (with 78 cosponsors) Proposition HR 129 "The Return to Prudent Banking Act of 2013" to restore the Glass-Steagall law. In the U.S. Senate, there are two bills which have been introduced: S. 985 "The Return to Prudent Banking Act of 2013" introduced by Sen. Thomas Harkin, and a similar bill with 9 cosponsors, S. 1282 "the 21st Century Glass-Steagall Act of 2013" introduced by Senator Elizabeth Warren.

We urge you to sign the Appeal for a global Glass-Steagall below and also with us, mobilize the federal government of Canada to embark on a real nation building great project like the North American Water and Power Alliance (see video NAWAPA XXI Animated Overview). A 21st Century NAWAPA will utilize the qualitatively higher level of nuclear and the monuclear fusion power to manage the continental water flows required to improve the biosphere through large-scale reforestation of presently arid/desert regions, expansion of agriculture, industry, and increase the potential to su stain human and other forms of life. (see Nuclear NAWAPA XXI: Gateway to the Fusion Economy.)

What you can do:

- 1. Sign the Appeal for a Global Glass-Steagall included below.
- 2. Write a letter addressed to British Columbia's Provincial and Federal Representatives (MLAs and MPs) addressing the need for Canada to abandon the "bail-in" policy which protects the financial derivatives at the expense of the physical economy, and call for Canada to support a reenactment of a Glass-Steagall separation of the commercial from investment banking.
- 3. Write a letter to the sponsors of the Glass-Steagall legislation in the U.S. House of Representatives and the U.S. Senate calling for them to reenact Glass-Steagall. I have sent you an example of such a letter sent by 14 mayors in France to the U.S. Congress.

Appeal for a Global Glass-Steagall Now!

The following Appeal for a Global Glass-Steagall was issued June 17, 2012, for urgent action across the Trans-Atlantic region.

1. All nations of the Trans-Atlantic region must enact a law which would separate commercial banks from investment/speculative banking entities, based upon Franklin D. Roosevelt's Glass-Steagall bill of June 16th, 1933. Up until the beginning of the 1980's, the principles of Roosevelt's reform were in place in European nations, in the form of strict regulation, and ensured that the banking sector mainly took on the character of commercial banks, and access to private accounts for risky speculative operations was impossible.

As things stood before Glass-Steagall was dismantled in 1999 through the Gramm-Leach-Bliley Act, commercial banks must once again be completely separated from both investment banks and the insurance sector.

- 2. Commercial banks must be put under government protection, whilst the investment banks put their books in order without any help from taxpayers' money, which in practice means that toxic paper must be written off in the trillions, even if this leads to the insolvency of the banks themselves.
- 3. A National Banking system in the tradition of Alexander Hamilton, within the framework of a new Credit System, must provide long-term credit with low interest rates for productive investments, which would in turn increase the productivity of the economy by promoting an increase in energy-flux density, and in scientific and technological progress.
- 4. The reconstruction of the real economy should be facilitated through long-term treaties of cooperation between sovereign nation-states, which would launch well-defined infrastructure and development projects in the context of the Mediterranean and North-American plan for an Economic Miracle, seen as a necessary extension of the Eurasian Land-Bridge. These contracts represent a de facto new credit system, a New Bretton Woods system, in the tradition of Franklin D. Roosevelt.

The purpose of re-enacting Glass-Steagall and implementing a Credit System is by no means only an improvement of technical details in banking, but rather, how the economy can ensure the survival of humanity over a period spanning many generations into the future, whilst increasing the productive powers from one generation to another. Human beings must once again be at the center, and the very purpose, of economics.

We, the undersigned, direct our urgent appeal to governments and parliaments, that they fulfill their constitutional duty and protect the general welfare of the populations they represent, by immediately enacting Glass-Steagall banking separation into law.

PURPOSE: To seek Council's support for reinstatement of Glass-Steagall legislation.

RECOMMENDATIONS:

1. THAT the Finance and Civic Development Committee recommend Council support the Committee for the Republic of Canada in its efforts to introduce a global provision that separates commercial bank and investment banking activities as provisioned in the US Banking Act of 1933, commonly referred to as Glass-Steagall and,

THAT the Mayor on behalf of Council write a letter of support to the Committee for the Republic of Canada, P.O. Box 3011, Youville Station, Montreal, QC H2P 2Y8, in their appeal to enact global Glass-Steagall legislation.

REPORT

1.0 **BACKGROUND**

Correspondence received from Robert Hux, Committee for the Republic of Canada dated 2013 September 25, requests that Burnaby City Council join other municipal and state governments in signing a petition to appeal to global leaders to enact global Glass-Steagall legislation.

Glass-Steagall legislation refers to specific provisions of the US Banking Act of 1933 in which limitations were placed on commercial bank securities activities and restrictions were imposed to limit affiliations between commercial banks and securities firms. The legislation was introduced by Congressional sponsors, Senator Carter Glass of Virginia, and Representative Henry B. Steagall of Alabama.

The US Banking Act of 1933 established various prohibited actions and programs such as:

- prohibiting commercial banks from owning securities brokerage firms,
- establishing a temporary deposit insurance program under the Federal Reserve, and
- prohibiting interest on commercial chequing accounts and capping interest rates on savings accounts.

The intent of the letter from Robert Hux is to obtain support for the re-introduction of Glass-Steagall legislation which was ultimately repealed in the US in 1999. However, the intent of the petition is expanded beyond a global Glass-Steagall protocol.

2.0 FINDINGS

Supporters of Glass-Steagall legislation surmise that the original law was enacted so a repeat of the Great Depression would not occur, noting that the lack of sufficient separation between commercial banks and securities firms weakened the financial system which lead to the crash of 1929 and subsequent years of turmoil. And that the repeal of the Glass-Steagall provisions under the Clinton administration provided the precipice for which banking and securities activities operated in a state of collusion which resulted in the 2008 economic events and global recession.

There have been several proposals in the House of Representatives and Senate of the US and corresponding legislative bodies in other countries, namely the UK and France, for increased controls and mechanisms to safeguard clients and institutions. Support for the argument that a global act would provide for the necessary safeguards and separation between the firms involved in the current crisis has been growing. The idea being that a new Act would re-establish a firewall between commercial and investment banking, making the financial system more secure, stable and manageable as history has shown that 'self supervision' by the banks and security firms has not been in citizens best interest.

In general terms, introducing restrictions and applying separation between banking and securities activities would be a positive for industry and society for the same reasons the Act was introduced 80 years ago. Supporting such provisions is recommended.

However, the <u>Appeal for a global Glass-Steagall</u> petition as presented by Mr. Hux does not limit the City's support for separation of bank and security activities. The petition for appeal includes additional items such as:

- having commercial banks placed under the protection of the government and having the investment banks stand independently,
- the creation of a National Banking system for the provision of long-term credit with low interest rates for productive investments, and
- the reconstruction of the economy through the facilitation of treaties between nations.

Arguably:

- each bank and securities firm is a publically traded company and should not be backstopped legislatively by national governments,
- the goals and deliverables to shareholders are not always respective of the needs of the citizens,
- each institution, whether a bank or securities firm, provides a community and global service; however prudence and fiduciary responsibility of the leaders of these firms and the staff should ensure independence as an organization that is driven by profits and market share.

Global actions through government support for the occurrences in 2008 where based on analysis and needs at the time. Several leaders such as Shelia Bair, former Chairperson of the Federal Deposit Insurance Corporation (FDIC) and Alan Greenspan, former Chairperson of the Federal Open Market Committee (FOMC) warn of the regulatory controls and the separation needed by not only industry companies but the involvement of federal agencies in the events leading up to

2008 and future problems that will surface. A petition that ties government guarantees and unconditional support for all publically traded commercial banks requires thoughtful consideration. Legislative directives that ensure sound business practices are a means of supporting long term economic growth and stability. This can be done through limited market intervention without the need of various endeavors such as the creation of a national banking system. The ebbs and flows of economic cycles are embedded features of a participatory market, one that contracts and expands as new ideas and technologies come to market and older industry and processes that are less efficient fade away.

3.0 CONCLUSION

The Committee for the Republic of Canada has increased awareness of the efforts of foreign governments and legislatures in their appeals to reinstate Glass-Steagall legislation. Specific examples confirm these endeavours as twenty-six US state legislatures have introduced resolutions which call upon the US Congress to re-enact Glass-Steagall. A 271 strong contingent of French elected officials and economists signed a letter addressed to the US Congress and Senate requesting reinstatement of Glass-Steagall legislation which also included other initiatives such as state protection of banks, a national banking system, and a system of fixed exchange rates.

In the US House of Representatives, US Representative Marcy Kaptur introduced the "Return to Prudent Banking Act of 2013" which has presently garnered 76 co-sponsors. In addition there are two bills in the US Senate which call for the return to Glass-Steagall legislation.

A return to Glass-Steagall legislation for the US and introduction to the global community puts forth a foundational necessity that was identified after the Great Depression. The purpose of reinstatement is to support a stronger and more manageable banking system that protects the interests of depositors. However, additional stipulations in the petition proposed are secondary to Glass-Steagall and distinctly different, thus requiring further consideration.

4.0 RECOMMENDATION

It is recommended that the the Finance and Civic Development Committee recommend Council support the Committee for the Republic of Canada in its efforts to introduce a global provision that separates commercial bank and investment banking activities as provisioned in the US Banking Act of 1933, commonly referred to as Glass-Steagall, and the Mayor on behalf of Council write a letter of support to Committee for the Republic of Canada, P.O. Box 3011, Youville Station, Montreal, QC H2P 2Y8, in their appeal to the City and other municipal and state governments to encourage the enactment of global Glass-Steagall legislation.



- 5. This bylaw may be cited as "Fee Setting Bylaw #403, 2014"
- 6. Bylaws No. 335 "A bylaw to establish fees, rated and charges for Municipal services, rentals and sales" and No. 360 "A Bylaw to Amend Schedule D of Bylaw 335" and No. 369 "Municipal Building Rate Bylaw" are hereby repealed.


