BOARD HIGHLIGHTS

February 17, 2017 Board Meeting

Delegations:

Bob Payette, Chair of the Port Edward Historical Society, joined by Polly Pereira, Treasurer, Steve Milum, Restoration Manager, and Laurie Davie, Manager, addressed the Board with respect to an update on the operations of the North Pacific Cannery, which included a financial summary, operations summary, an overview of North Pacific Cannery events and an update on projected projects at the North Pacific Cannery in 2017.

The Port Edward Historical Society responded to questions posed by the Board.

The Chair thanked the Port Edward Historical Society for its presentation.

Board Business:

1. The Board resolved to support signing correspondence from the Canadian Independent Harvester's Federation to the Honourable Dominic LeBlanc, Minister of Fisheries, Oceans and the Canadian Coast Guard, with respect to legislating and regulating fish licenses for fishermen and fishing communities.
2. The Board resolved to provide a letter of support to the North Pacific Cannery for grant applications it will be making in 2017 to support the development of various restoration and interpretation projects at the cannery.
3. The Board resolved to provide a letter of support to the City of Prince Rupert for its application to the Port of Prince Rupert's Community Investment Fund for the completion of upgrades to Mariner's Park.
4. The Board resolved to hold its April 21, 2017 North Coast Regional District Regular Board meeting in Sandspit, B.C. at 7:00 p.m.
5. The Board passed three readings to the Vancouver Island Regional Library Loan Authorization Bylaw No. 612, 2017 and supported entering into an indebtedness agreement that would see the North Coast Regional District borrow, on behalf of the Vancouver Island Regional Library, \$1.5 million toward the construction and upgrades to library facilities in Masset, Sandspit and Queen Charlotte, B.C.
6. The Board resolved to submit comment on the proposed Aurora LNG project through the B.C. Environmental Assessment project evaluation process.
7. The Board appointed Director Bergman to serve as the North Coast Regional District representative on the North Coast Marine Planning Advisory Committee.
8. The Board held its second round of financial planning discussions on February 18, 2017.

Dear Mayor Ian Gould,

The Canadian Postmasters and Assistants Association (CPAA) is the voice of rural post office employees since 1902. It is the second-largest bargaining unit under the Canada Post umbrella; representing members who work in post offices in towns, reserves and villages throughout rural Canada. We are in touch with over 6 million rural customers on a regular basis. Most often we are the only federal presence and the hub of the community.

CPAA members, 95% of them women, operate 3,260 post offices across Canada; 226 of these offices are in your province.

We write to you today to share our concerns over the Federal Government Standing Committee on Government Operations and Estimates' (OGGO) report regarding Canada Post, released on December 13, 2016. If you have not seen it yet, you can access the report at the following web address:

Amongst the many recommendations made by the Committee, most of which we support, we note the absence of a recommendation on postal banking. In your province alone 61% of the communities do not have a financial institution, yet they have a corporate post office. Often your constituents have to travel long distances to receive banking services. If your citizens have to travel out of town for banking services, it is almost certain that they will also patronize other businesses in that town or city, thereby losing earning opportunities from your own town's businesses.

We at CPAA strongly feel that the resurrection of the postal bank, which was closed in 1969 when large banks were expanding in rural Canada, is a perfect fit for Canada Post. More importantly for the businesses and the citizens of your community, it is a means to ensure access to financial services. You may remember that prior to the OGGO's report, the Government had set up a Task Force to examine the challenges of Canada Post and to provide options for the future of the Corporation. The Task Force report¹, which preceded the OGGO's report, mentioned that 39% of Canadian businesses would use a postal bank. It also mentioned that 38% of Canadian citizens would use a postal bank.

According to the 2011 Census, Canada's rural population consisted of 6,329,414 citizens. What bank could not succeed with 38% of that number of customers?

If like us at CPAA, you feel that a postal bank would benefit your community, we ask you to write to Minister Judy Foote to voice your views and concerns. We recommend that you also copy your letter or email it to Ms. Karine Trudel, the New Democrat MP who sat on the OGGO Committee, as she was a strong supporter of the postal bank. 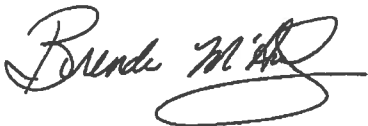

OPEN LETTER TO BC LOCAL GOVERNMENTS
ATTN: Mayor & Council, all BC local governments
January 25, 2017

Dear Sirs/Mesdames:

Re: We must hold fossil fuel companies responsible for climate change

Wildfires. Drought. Flooding. Rising sea levels. Climate change is already reshaping and impacting BC communities in profound and frightening ways. As unchecked fossil fuel pollution continues to push global temperatures ever higher, we are frightened for our communities, for communities around the world, and for the world we leave our children. These impacts are still more challenging for vulnerable groups - the poor, Indigenous people, women and children - who are often unable to respond to unexpected weather or other climate impacts.

But there is hope. If the fossil fuel companies - whose products are the major drivers of climate change - had to pay even a fraction of the associated climate costs, they would not be able to out-compete renewables and would pivot towards sustainable alternatives without delay. BC communities can play a key role in demanding accountability from the fossil fuel industry for the harm that they are causing our communities, and challenge the myth that the fossil fuel economy can continue business as usual despite the destruction it is causing to our atmosphere.

The fossil fuel industry is keen to avoid a conversation about its responsibility for climate change. Just 90 entities - primarily fossil fuel companies - have caused almost 2/3 of human caused greenhouse gas emissions, and just three - Chevron, Exxon Mobil and Saudi Aramco - are responsible for almost 10%¹. Like the tobacco industry before it, Big Oil relies on the perception that individual consumers are responsible for climate change while pocketing billions of dollars in profits from products that they know are disastrous for our atmosphere and communities around the world.²

BC and Canadian taxpayers will end up paying the costs of climate change in many different ways. But unless our communities demand that fossil fuel companies pay their fair share of these costs, this industry will continue pushing products that the world cannot afford to burn.

BC's local governments are well placed to play a global leadership role by demanding accountability. We can come together to start a new global conversation about the moral and legal responsibility of the fossil fuel industry for its role in fueling climate change.

We – as BC-based community groups – support the Climate Law in our Hands Initiative and are asking you to:

1. DEMAND FOSSIL FUEL ACCOUNTABILITY

It has been rare for anyone to even ask the fossil fuel industry to take responsibility for its role in causing the global crisis – and the local climate impacts like floods, wildfires and droughts. This avoidance of responsibility ends in BC – when you, and other local governments across the province, write to the world's fossil fuel companies asking them to take their fair share of responsibility for climate change.

This demand can take the form of a detailed invoice for climate costs or a letter simply enquiring as to the company's position on paying a fair share. It can be tailored to reflect the needs and capacity of each community.³

2. WORK TOWARDS A CLASS ACTION LAWSUIT

BC communities can demand accountability from the fossil fuel industry in a variety of ways, but if necessary, we may need local governments to demand accountability through the courts.

Lawyers at West Coast Environmental Law have exhaustively researched how a class action – a joint legal action brought by one or more “representatives” of BC's local governments – could be brought against major fossil fuel companies for their role in causing climate change.

We ask you to consider whether your municipality would be willing to launch a class action as a representative and/or how you might support a case launched by other local governments. BC communities need to come together and get behind this type of legal action. Bringing this case will make it clear that fossil fuel companies cannot avoid a legal conversation about accountability – and if we win, we will set a precedent that could change the world – putting us on a global path that will avoid more dangerous climate change.⁴

Conclusion

Both of these actions, as well as a general public discussion about the role of fossil fuels in our future economy, are most likely to move forward if our communities understand how we are being, and will be, impacted by climate change. We urge you to work with your citizens, climate scientists and other experts in a publicly transparent way to explore what needs to be done to prepare your community for climate change.

Whether we realize it or not, our communities are facing a tidal wave of costs, debt and disaster relief arising from the many effects of climate change. It is time to ask whether we alone are going to bear those expenses, or whether the companies that have made billions of dollars creating this situation also bear some responsibility.

By demanding that those who profit the most from climate change pay their fair share, BC local governments can dramatically reshape the global conversation about climate change and the fossil fuel industry. Community groups around BC will be calling on fossil fuel companies to take responsibility for their role in causing the climate crisis and we hope that you will join us.

We are writing to encourage your local government to access financial assistance from the B.C. Government Francophone Affairs Program (FAP), to support the delivery of French programs and services in your jurisdiction.

There are 70,000 Francophones and 300,000 Francophiles across British Columbia. One of the mandates of FAP is to deliver the Canada-British Columbia official Languages Agreement on French-Language Services. By partnering with FAP, local governments can access funding through the Official Languages Agreement for projects either with a French component or entirely in French.

Eligible projects must support service development, planning and delivery in one or more of the five priority areas identified in the Agreement: Health and Social Services, Economic Development, Arts and Culture, Justice and Communications. 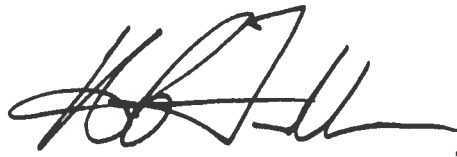

Dear Mayor Martin,

As per your notification regarding membership in the NCLGA, I respect the view that the Village of Queen Charlotte might be better aligned with the Association of Vancouver Island and Coastal Communities. Having said that, however, I wanted to write to you with all Haida Gwaii residents in mind, and encourage you to remain a member of the NCLGA for the following three main reasons:

- 1.) Advocacy for your residents: From ferry service and fish farms to Highway 16 upgrades, aboriginal reconciliation and the North West Resource Benefits Alliance, the NCLGA is working harder, year by year, on issues that have a direct impact on your constituents. A brief overview of the resolutions we have worked on for the past several years include issues specific to coastal communities, like the one below, which your Council sponsored, and was passed unanimously by the NCLGA membership at the convention in Fort St John, BC:

Liquefied Natural Gas Development (Village of Queen Charlotte)

WHEREAS Liquid Natural Gas (LNG) development in northeastern BC and proposed pipelines, terminal facilities, and tanker transportation from the north coast will have large, cumulative environmental, social and economic impacts;

AND WHEREAS this development is happening across BC impacting the land and communities of northern BC both civic and First Nation, without the means of meaningful consultation and involvement;

AND WHEREAS comprehensive planning and cumulative impact assessment have been lacking to date:

THEREFORE BE IT RESOLVED that the NCLGA requests that the Province of BC and First Nations convene and co-chair a Strategic Economic and Environmental Impact Assessment of LNG development in British Columbia.

AND BE IT FURTHER RESOLVED that the NCLGA requests that the Province and First Nations invite the Federal government to also participate in this joint planning process.

- 2.) Strategic Partnerships that benefit Haida Gwaii: As a regional organization, the NCLGA is strategically aligned with other major entities in the north which have a direct and meaningful impact on the people who live in your community. Just yesterday, in fact, I personally had a meeting with Cathy Ulrich, the CEO of the Northern Health Authority to discuss the northwest. We are also very closely aligned with Northern Development (in fact, our official meetings are held in NDIT's boardroom and usually include the participation of their CEO). There are others, of course, from the University of Northern BC to the Fraser Basin Council with whom we work closely and discuss service delivery, research and long term planning.
- 3.) You are part of a broad, integrated network that benefits greatly from (and encourages) your input. To put it bluntly, we need you! Northern communities share common realities that make unified action and a unified voice their best chance at progress. These realities are specifically northern, and do not exist as broadly or exclusively in any other jurisdiction in BC:
 - With the exception of Prince George, all NCLGA communities are considered very small with populations in the hundreds or low thousands.
 - NCLGA communities are also uniquely saddled with few opportunities to diversify their local economies while struggling with mounting infrastructure deficits.
 - Also, NCLGA communities are extremely remote, making commercial and personal transportation exceedingly difficult.
 - Lastly, there isn't one NCLGA local government without a close First Nation neighbour. In fact, all NCLGA communities have the highest proportion of aboriginal residents in the Province, in most cases by three or four times the average provincial ratio.

Without your input and support, your colleagues across this amazing region would lose a champion who understands and empathizes with their realities and struggles.

Please know that belonging to the NCLGA does not hinder your membership in any other organizations whatsoever. More importantly, each NCLGA member has an equal voice, regardless of size, location or

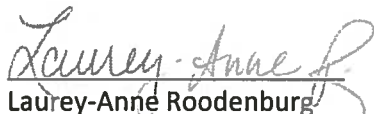
political perspective, and you have many tools at your disposal to ensure your membership is as beneficial as possible.

Your elected officials can run for positions on the NCLGA board, which entails a one year term and four all expenses paid trips to Prince George (plus per diems). As members of the NCRD, you have direct input into the Regional District's NCLGA appointee and can advise that member of your needs and suggestions at any time. As a member, you can request that the NCLGA Board hold one of its regular meetings on Haida Gwaii, or that a delegation meets with your council to discuss advocacy or, possibly, the next Northern Mayors and Chairs roundtable could be held in your community (our first ever was in Prince George last year). There are a lot of opportunities open to you.

The NCLGA does not have a lot in common with Victoria, Oak Bay or Nanaimo, but you could say we specialize in small, remote communities with limited budgets where indigenous rights, environmental stewardship and the pursuit of economic diversity are at the forefront of our day to day activities.

of Bylaw No. 438, 2017**

In accordance with Section 165(3.1) of the *Community Charter*, the Village of Port Clements (Village) is required to include in the Five Year Financial Plan, objectives and policies regarding each of the following:

1. The proportion of total revenue that comes from each of the funding sources described in Section 165(7) of the *Community Charter*;
2. The distribution of property taxes among the property classes
3. Permissive Tax exemptions

Funding Sources

Table 1 shows the proportion of total revenue proposed to be raised from each funding source in 2017. Government grants form the greatest proportion of revenue. The government grants that are included in this total include the following: \$440,000 for the small community Grant, and the community works fund.

User Fees and Charges make up the second highest amount for 2017.

The third highest source of revenue is Property Taxes.

Objective

- For the 2017 – 2021 years to incorporate a 0% tax increase annually as well as 0% increase for both water and sewer annually.
- Council has planned to incorporate local employment where possible, and encourage contractors bidding on works with the Village to utilize unemployed workers.

Table 2 outlines the distribution of property taxes among the property classes. The residential property class provides the largest proportion of property tax revenue. This is appropriate as this class also forms the largest portion of the assessment base and consumes the majority of the Village's services.

Policies

- Continue to maintain and encourage economic development initiatives designed to attract more retail and commercial businesses to invest in the community. Align the distribution of tax rates among the property classes with the social and economic goals of the community, particularly to encourage a range of employment opportunities.
- Regularly review and compare the Village's distributions of tax burden relative to other municipalities in British Columbia.

 - (c) such further instruments and agreements as may be reasonably required to carry out the agreements described herein; and by doing so, to bind the Corporation and create the security set out in such agreements.
3. Any one individual listed below as an **"Account Administrator"** is authorized for and on behalf of the Corporation from time to time to:
 - (a) execute and deliver all of the documents and instruments described in paragraph 2 above;
 - (b) execute and deliver any other documents and instruments that may be reasonably required from time to time to carry out the transactions contemplated by this Resolution, subject to such amendments as the Account Administrator may approve, such approval to be conclusively evidenced by the execution of the said documents or instruments;
 - (c) give CUETS Financial instructions and perform transactions on behalf of the Corporation in connection with the ongoing operation of the credit card account(s), credit facilities and/or other financial services contemplated by this Resolution;
 - (d) authorize any person or persons (each, an **"Authorized User"**) to access, from time to time, credit available under the credit card account(s) established by CUETS Financial for the Corporation;
 - (e) establish and, from time to time, change the amount of credit that each individual Authorized User may access under the credit card account(s) established by CUETS Financial for the Corporation; and
 - (f) settle the Corporation's credit card account(s) with CUETS Financial and receive from CUETS Financial, and provide receipt of, statements and any other items or correspondence from and to CUETS Financial in connection with the Corporation's credit card account(s).
4. CUETS Financial is entitled to rely on such documents, instruments, instructions and transactions as duly and validly authorized and binding on the Corporation. CUETS Financial does not need to make any further inquiry into the authority of any Account Administrator to bind the Corporation.
5. CUETS Financial be provided with a copy of this Resolution together with a certified list of the names of the current officers and directors of the Corporation and, from time to time, be provided with any changes to such list.

Re: Equipment installation

Background: The Canadian Hazards Information Services (CHIS) is the group in Natural Resources Canada responsible for maintaining the Canadian National Seismic Network. They have over 150 seismograph stations throughout the country that relay real time information to computer data centres located in Ottawa and Sydney, BC. The data is used to help with early warning systems such as the tsunami warning system. Other researchers use the data to create seismic hazard maps that are used to update national building codes.

In December 2016 CHIS contacted the Village of Port Clements in regards to running a test to ensure that a small unit installed on the roof of the Fire Department would communicate with their equipment recently placed across the Masset Inlet. In early February the testing had been satisfactorily completed and they now wish to move ahead with a permanent installation on the roof of the Fire Department. Per the attached agreement they are seeking a 10 year license to place the equipment on the roof of the Fire Department at a rate of \$300/year – this will more than cover the annual electrical requirements for the equipment which were calculated to be approximately \$28 per annum. The equipment is very compact and does not interfere with any other equipment located near it – specifically equipment on the Gwaii Tel tower.

I have concurrently notified the Fire Department that I will be seeking Council authorization to proceed with this installation.

Recommendation: I recommend that we allow CHIS to install the equipment on the Fire Department roof per their request.

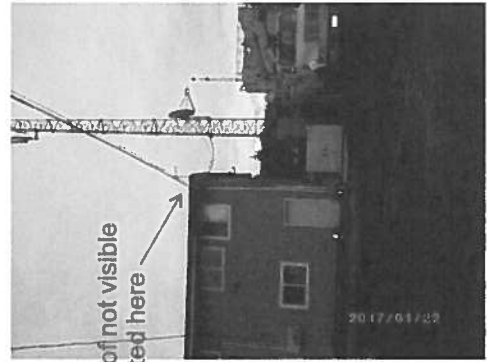
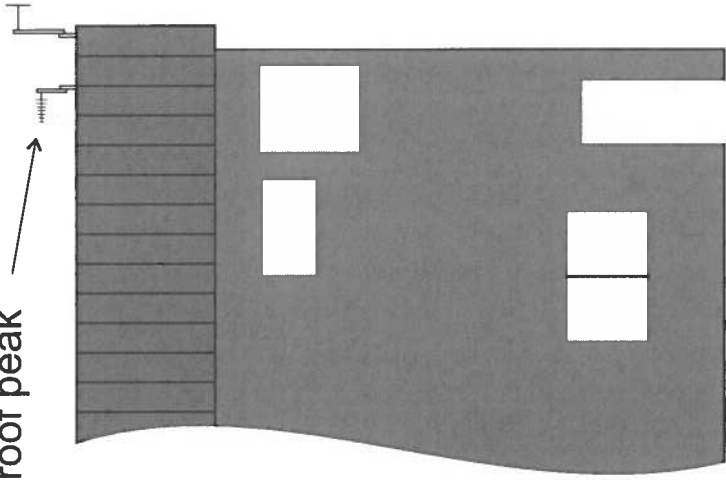

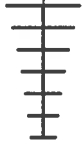
