## Dear Madam Mayor:

I am writing in response to your letter of October 27, 2008, which your Member of Parliament, the Honourable Jay Hill, forwarded to me on November 20, 2008, concerning the Employment Insurance (EI) program.

The EI program is currently designed to respond automatically and quickly to local labour market changes, taking into account the difficulty of finding employment. EI economic regions currently divide the country into 58 geographic regions intended to reflect areas of similar labour market conditions. The unemployment rate for each region is used to determine the number of hours a person residing in that region needs to qualify for EI and the number of weeks payable.

The program's variable entrance requirements system ensures that, as unemployment rates increase, entrance requirements are lowered and the duration of benefits increases. This results in equitable access across the country, regardless of the unemployment rate.

Regulation 18(2) of the Employment Insurance Act requires that the boundaries be reviewed at least once every five years for the purpose of determining if it is appropriate to make changes. The review of EI regional boundaries is a multi-step process that requires extensive analysis of labour market and geographic data produced by Statistics Canada in conjunction with the Census.


As you may be aware, on September 5, 2008, the Government indicated that the review of geographical and labour force data from Statistics Canada demonstrates that the current EI regional boundaries are working well overall, and confirmed that they will remain unchanged.

In addition, the Government announced that it would continue three pilot projects impacting Northern British Columbia for an additional two years. These pilot projects will test the labour market impacts of:

- calculating EI benefits based on the highest 14 weeks of earnings over the 52 weeks preceding a claim, to make EI benefit levels more reflective of full-time work earnings for those with sporadic work patterns (Best 14 Weeks pilot project);
- enabling individuals new to the labour market or returning after an extended absence to obtain EI benefits after 840 hours of work, rather than 910 , when linked with EI employment programs (New Entrant and Re-Entrant pilot project); and
- increasing the amount EI claimants may earn while on claim without a reduction in their benefits to the greater of $\$ 75$ or 40 per cent of benefits, rather than $\$ 50$ or 25 per cent of benefits (Working-While-on-Claim pilot project).

You may also be interested to know that the Working-While-on-Claim pilot project will be expanded nationally to all EI regions to allow the Government to test the impacts of increased earnings while on claim in urban and rural labour markets. Additional information on the EI economic regions and the pilot projects can be found at http://news.ge.ca/web/article-eng.do?nid=419019.

The purpose of EI pilot projects is to conduct a test for a defined period, and to allow the Government to assess the labour market impacts of new approaches that are designed to assist the unemployed. The continuation of these pilot projects will allow the Government to acquire additional data to support a more complete assessment of the labour market effects of these initiatives.

With respect to your comment about the accumulated surplus in the EI Account, allow me to explain that the EI Account is not an account containing cash, but an accounting method that keeps track of premiums and benefits.

I hope that my comments are helpful in addressing your concerns. Your views are appreciated and will help departmental officials to better evaluate the impact of the EI program on Canadians.

## Re: Employment Insurance Regional Boundaries

The Council of the District of Mackenzie has requested that copies of the letter sent to the Federal Government requesting a review of the employment insurance economic regions in northern BC to better reflect geographic and economic demographics, and the reply received from the Minister of Human Resources and Social Development, be sent to NCMA member municipalities and regional districts.

Currently there are six economic regions in the province, five of which are located within the southern portion of the province and Vancouver Island. The sixth economic region encompasses an area stretching from south of Williams Lake to the Alaska border, and from the Pacific Ocean to the Alberta border, approximately $70 \%$ of the geographical area of the province.

Council has asked the Ministry of Human Resources and Social Development to reconsider configuring these boundaries to more accurately reflect the reality of the state of the province. As per the attached reply, the Ministry has indicated that they are not willing to consider making any changes to the current boundaries.

As an example, lumping communities where the forest industry is the focus of the local economy (such as Mackenzie) and communities where the oil and gas industry is predominant (such as Fort St. John) is inherently inequitable as one industry is in an economic slump and the other in an economic boom.

Remote communities face more difficulties than those close to urban centers. Council has asked that the regions be based on geographical areas with similar industries and a resolution will be put forward to the upcoming NCMA conference.

We would ask that NCMA members write to the Ministry of Human Resources and Social Development asking them to reconsider the current boundaries.

Congratulations on your recent re-election and your newly-appointed position as House Leader. You have served the citizens of Mackenzie well during your elected career and we look forward to the continued support.

As you are probably aware, the Employment Insurance Program has British Columbia divided into regions which determine hours needed to qualify for benefits and weeks of benefits payable. Currently there are six economic regions in the province, five of these being in the lower mainland; with only one region (which incorporates Mackenzie) stretching from south of Williams Lake to the Alaska border and from the Pacific Ocean to the Alberta border. This one region encompasses approximately $70 \%$ of the geographical area of our entire province.

What we are asking of your government is to reconsider the economic regional boundaries in the province (and the nation). If one was to look at the "official" unemployment rate in Mackenzie at this time, they would discover it is about 10 percent, but as we both know the unemployment rates is much higher. One solution could be to have economic regions based on geographical areas with similar industries. As it now stands, the unemployed worker in Fort St. John and the unemployed worker in Mackenzie need the same number of insurable hours to qualify for benefits and would be entitled to the same weeks of benefit. We all know the unemployed worker in Mackenzie is facing much larger obstacles in finding work within 100 km of Mackenzie.

With a reported $\$ 51$ billion in the Employment Insurance surplus, we strongly recommend a review of the current Employment Insurance Regional boundaries. Canadians have contributed to this fund in good faith that it would be there in times of hardship.

Dear Mayor Delves:
I am writing in reply to your letter regarding mail delivery service to the Queen Charlotte Islands. I can certainly appreciate your concerns regarding the recent changes, and I regret the inconvenience caused.

I should first explain that it was Air Canada's decision to cancel its service agreements with Canada Post to provide domestic and international transport of mail effective September 2008. This included all flights with the regional carrier, Jazz, that used to provide mail service to the Queen Charlotte Islands on a space-available basis. While Canada Post has implemented a new air transportation network with another carrier, this airline does not serve all areas of the country, including the Queen Charlotte Islands.

We are very much committed to providing Canadians with efficient, reliable and accessible delivery service at all times. Given the demographics and geography of our country, providing service to some rural and remote communities can be a challenge. The Queen Charlotte Islands is one of many locations that are considered a remote site for the purposes of Canada Post's delivery standards. Our published delivery standards from Vancouver and other areas in British Columbia are eight business days for regular parcel mail, five business days for Priority Courier ${ }^{T M}$ and Xpresspost ${ }^{T M}$ items, and six business days for Lettermail ${ }^{T M}$. These service commitments have been in place for many years, and we will continue to meet them by using the BC Ferry services.

Please be assured we will monitor our delivery service to the Queen Charlotte Islands very closely. Should any residents of the Queen Charlotte Islands experience service outside our published delivery standards, we are asking that these incidents be reported to our Customer Service representatives at 1-800-267-1177.

Thank you for writing and giving me the opportunity to address this matter. I assure you we will continue our efforts to provide efficient and timely mail delivery to the Queen Charlotte Islands.

Dear Mrs. Mushynsky:
Today is Clinic Day at Port Clements and the doctor is in for clinic hours. I had a child in grade 6 slip in the classroom of Port Clements Elementary School and hit her head very hard - as it was a double hit; once on the table and then on the cement floor, I thought she should be checked out. In the past when accidents have happened the local health nurse and doctors have been more than willing to look at the child and suggest further care if required. That was not the case today. Apparently Port Clements' Clinic on the rare occasion when it is open does not service the needs of the school even in an emergency situation. After checking with Doctor Leslie, I was told by the nurse that the doctor was behind schedule and if the child needed emergency treatment we should call the ambulance or drive to Masset where she would be seen by Dr. Fawcett or the doctor on call. Doctor Leslie was with a patient and was behind schedule and could not see her and also did not have her chart here. The nurse relayed the information that Port Clements' Clinic does not take walk in patients. Three patients were in the waiting room and quickly offer to let her be seen by the Doctor ahead of them. We were all in disbelief as we were turned away from the clinic.

Who are we serving through our health system, the needs of protocol, Dr. Leslie or our children and community? Do doctors reset protocol on the fly? The community of Port Clements has been severely under-served by Northern Health and, Northern Healths' policies have driven more than one nurse out of the position. This is a continuation of an unacceptable level of commitment Northern Health has to the community.

I request that you look into this situation and re-evaluate the protocol around issues related to children and the school. I am particularly frustrated today, as the parent of this particular child is working in Skidegate and given the road conditions it seems extremely unfair to have that parent drive all the way here to pick up her child then drive to Masset and back. Common sense should prevail in these situations.

- Grants to assist communities with plan development, exercising and training;

- Public Safety Lifeline Volunteers (PSLV) and how they serve BC communities in PSLV programs such as search and rescue (air, land and inland water), emergency radio communications, road rescue, emergency social services and PEP air services, and;

Hello Gary:
Randy is out of town doing maintenance audits in the Okanagan so I will try to answer the questions you posed to him earlier this week.

1) The last major paving project on the section of Hwy 16 between Masset and port Clements was in 1987 according to our records.
2) Getting the longest life from this segment of pavement, as with any pavement in the province is a continuous process of progressive maintenance designed to address the deficiencies as they arise. Through our maintenance contractors we strive to achieve the least cost solutions to these deficiencies. Good maintenance practices over the years have involved activities such as pot hole patching, crack sealing, sand sealing as well as some overlay patch paving on this segment.
3) You are correct. The erosion repairs were at 7 different sites from Tlell south to the Village of Queen Charlotte and on Moresby Island, north of Sandspit.
4) The ministry does not have "useful life" specs per se. We use a pavement management concept that involves trying to maintain pavement through various means to stretch out its economically useful life. Across $B C$ we have a wide variation in climate, traffic levels and general quality of road base materials and drainage conditions that all contribute to how long a pavement surface can be maintained before it must be sealed, recycled or re-paved. On the Queen Charlottes we have found that, through sound maintenance practices, pavement life has often been extended beyond 35 years because of the mild climate and light traffic loads.

For reference to different stresses and conditions of pavement I refer you to our Pavement Surface Condition Rating Manual which can be found on line at http://www.th.gov.bc.ca/publications/const maint/2002 Pavement Surface Condition Rating Manual V2.pdf .

The manual describes pavement conditions based on 12 distress types within the following subgroups:

- Cracking - wheel path, joint, edge, transverse, meandering and alligator.
- Surface Deformation - rutting, shoving and distortion.
- Surface Defects - bleeding, potholes and ravelling.

The distress types represent the most predominant distress manifestations observed in British Columbia, focusing on those that progressively affect the pavement's ability to support traffic loads. Our maintenance contractors use this manual to assist them with pavement maintenance decisions that seek to extend the life of the pavement at the least cost. It is somewhat of a judgment call when we estimate that the present value of the future cost of maintenance is likely to exceed the cost of some other major treatment (such as a complete re-sealing, recycling or re-paving). It is then that the ministry creates a rahabilitation project to best address the needs of the road.
5) The work in Queen Charlotte has no bearing on the ranking of the future project between Port Clements and Masset. Our rehab program is established annually based on the changing needs of the inventory.

I trust this puts the issues better in context for you. As always, please don't hesitate to contact Randy or myself if you have questions or feel the need for any clarifications.

For the third year in a row, the Ministry of Highways has decided it won't pave the highway between Port Clements and Masset, despite promising to do so three years in a row, in 2007, 2008 and 2009.
That portion of the highway-and don't forget, it's a provincial highway and part of the Yellowhead Trans-Canada route, has not been paved since the summer of 1986 (when the pavers went as far south as the Tlell bridge). Twenty three years of patching is getting to be too long. Indeed, there are concerns that real deterioration will set in if it's not soon repaved properly.
There are also safety concerns, as parts of the road could be considered dangerous even at the speed limit. There's one other problem associated with the cancellation. A private company has a paving plant in Masset with the expectation it would be used for repaving the highway. Now, that plant is likely to be dismantled taken back to the mainland, leaving the three villages without a source to do their smaller projects.
Both Masset and Port councils are writing to the ministry, complaining about the cancellation. So has MLA Gary Coons.
The ministry ought to take their letters seriously. It should rethink this decision, make good its repeated promises and put the paving back on this summer.

Thank you for your e-mail of February 10, 2009 expressing concerns about the condition and the timing of a future paving project for Highway 16 between Masset and Port Clements. I agree with you that this road is very important for the mobility of users on Haida Gwaii. As such, we have been investing significantly in this road and others on Haida Gwaii for the past number of years. We have actually spent more than $\$ 20$ million on resurfacing 100 km of the existing 188 km of road. In addition, major erosion repairs were undertaken during 2004 and 2005 totaling $\$ 2.5$ million and we are well underway with a three year $\$ 450,000$ expenditure focused on road and drainage upgrades in the Village of Queen Charlotte. Completion date for this project is before the end of 2010.

You are correct that for the up-coming construction season we do not have plans to do additional paving on Highway 16 on Haida Gwaii as the remaining northern section, although showing some signs of aging has some remaining useful life. Instead, we are focusing next season's resources toward some higher northwest infrastructure priorities, such as a much needed bridge replacement at Oona River on Porcher Island and resurfacing of Highway 16 near Prince Rupert.

However, we will continue to closely monitor the condition of Highway 16 on Haida Gwaii and will look to resurface the remaining section when the current pavement reaches the end of its useful life.

## INTRODUCTION TO THE SUPPLEMENTARY ESTIMATES

Each year the government presents a budget to the Legislative Assembly. The budget includes the Main Estimates, which, in conjunction with Supply Acts passed by the Legislature, provide government with authority (voted appropriations) to spend money from the Consolidated Revenue Fund. If spending from voted appropriations is forecast to exceed that set out in the Main Estimates, Supplementary Estimates and another Supply Bill may be presented to the Legislative Assembly.

Where Supplementary Estimates increase the funding for purposes included in a vote description in the Main Estimates, that vote description may be referenced in the Supplementary Estimates. Where Supplementary Estimates provide funding for purposes that are not included in the vote descriptions of the Main Estimates, new vote descriptions are provided in the Supplementary Estimates.

These Supplementary Estimates provide funding from the Consolidated Revenue Fund in the amount of $\$ 622,000,000$ for operating expenses as set out in the Schedule of Appropriations to be Voted (page 4) for the following purposes:

Ministry of Advanced Education and Labour Market Development - $\$ 40,000,000$ to address an increase to government's liability for the public service long term disability plan arising from a recent actuarial valuation and the recent decline in the market value of investments supporting the plan;

Ministry of Community Development - $\$ 186,000,000$ for strategic investments in communities to encourage economic growth and create jobs to help offset the effects of the current economic uncertainty, and to provide local governments with greater flexibility to address immediate needs, including community safety;

Ministry of Finance - $\$ 83,700,000$ for funding to fulfill the Province's initial financial commitment towards the provision of security for the 2010 Olympic and Paralympic Winter Games and other financial obligations for the 2010 Paralympic Winter Games;

Ministry of Health Services $-\$ 120,000,000$ to provide funding to health authorities for the purpose of addressing increased demand and cost pressures related to the delivery of healthcare in the Province;

Ministry of Housing and Social Development - $\$ 30,000,000$ to fund the acquisition and renovation of rental buildings, including single room occupancy hotels, in order to provide addifional housing options for the homeless;
Ministry of Labour and Citizens' Services - $\$ 2,200,000$ to provide Internet connectivity to rural communities;
Ministry of Tourism, Culture and the Arts $-\$ 15,100,000$ for strategic one-time grants to support arts and culture projects in the Province, and provide for the conservation of the Province's historic sites;

Ministry of Transportation and infrastructure - $\$ 20,000,000$ to invest in significant road maintenance and rehabilitation projects in local communities across the Province;

Contingencies (All Ministries) and New Programs - $\$ 125,000,000$ for increased flexibility to accommodate the financial consequences of unanticipated events or pressures emerging from the current economic circumstances.

These Supplementary Estimates provide funding from the Consolidated Revenue Fund in the amount of $\$ 180,000,000$ for financing transactions as set out in the Schedule of Appropriations to be Voted (page 4) for the following purposes:

Contingencies (All Ministries) and New Programs - $\$ 80,000,000$ in capital expenditure funding for additional priority capital spending initiatives.

Ministry of Transportation and Infrastructure - $\$ 100,000,000$ in loans, investments and other requirements funding for an investment in the Transportation Investment Corporation related to the Port Mann project.

## Re: Strategic Community Investment Funds

The Province of British Columbia (Province) and the Union of British Columbia Municipalities acknowiedge that we are facing a global economic crisis and that strategic spending by British Columbia communities can help stimulate local economies, encourage growth, create local jobs and help offset the effects of the economic downturn.
In recognition of this, the Province is restructuring key local government transters, to provide Strategic Community Investment Funds (Funds) over the next two years. The Funds will temporarily replace the annual payments of small community, regional district and traffic fine revenue sharing grants for the 2009/10 and 2010/11 fiscal years.

Under the Funds arrangement the Province agrees to pay British Columbia local governments $\$ 232.4$ million by July 31, 2010. Payments will be made in three instalments. These will include an immediate one-time grant, along with a second instalment in July 2009 and a third instalment in July of 2010. Details of individual local government payment amounts are included in the attached Strategic Community Investment Funds Agreement (Funds Agreement). The Province will be asking the Legislative Assembly to approve funding for the first two instalments in spring 2009. The third instalment will be part of the 2010/11 budget, subject to the approval of the Legislature of that budget.
As the Funds are intended to support investments in local government services for smaller communities and regional districts as well as investments in policing and community safety, it is important to report to residents on how the funds are used. Local governments receiving funds agree to:

1. develop a plan that sets out the intended uses and performance targets for those Funds; and,
2. report publicly on that plan and progress made toward achieving the performance targets.

Both of these requirements can be accommodated within the legislated financial planning and annual reporting requirements, with only minor modifications to those reports.

In order to access the Funds, please sign the attached Funds Agreement to indicate your acceptance of the terms and conditions within and return to the Ministry of Community Development as soon as possible, and no later than March 13, 2009.

The Province cannot ensure payment of Funds to local governments submitting signed Funds Agreements after March 13, 2009.

In recognition of the short timeframe to sign and deliver the Funds Agreements, local governments can e-mail an electronic version of their signed Agreement and then follow this up by a hard copy original by mail.

## STRATEGIC COMMUNITY INVESTMENT FUNDS AGREEMENT

This Agreement made as of $\qquad$ , 2009,

## BETWEEN:

Village of Port C̣lements (Local Government)

## AND:

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA represented by the Deputy Minister of the Ministry of Community Development (the Province).

## WHEREAS:

A. The Province and the Local Government acknowledge that they are facing a global economic crisis and that faster; strategic spending by British Columbia communities can help stimulate local economies, encourage growth, create local jobs and help offset the effects of the economic downturn.
B. The Province agrees to strengthen its commitment to local governments by restructuring small community, regional district and traffic fine revenue sharing grants by providing Strategic Community Investment Funds (Funds) over the next two years.
C. The Funds are intended to achieve the objectives of supporting local government efforts to stimulate local economies and providing local governments with increased financial certainty in uncertain economic times while continuing to support investments in community safety for which traffic fine revenue sharing grants are intended.
D. The Province and the Local Government acknowledge the importance of reporting to residents on how the Funds are used.
E. The Funds will be provided using a flexible, objective based approach to enable the money to flow quickly to communities, while ensuring a strong accountability and reporting framework

NOW THEREFORE, in consideration of the mutual promises herein, the Local Government and the Province agree as follows:

## 1. PAYMENTS TO THE LOCAL GOVERNMENT FROM THE PROVINCE

Provided the Local Government agrees to comply with this Agreement, the Province will pay the Funds in the following amounts, for the purposes identified, on or before the date indicated.

## 2. CONDITIONS RELATING TO PAYMENTS BY THE PROVINCE

 Notwithstanding any other provision of this Agreement, the payment of money, or incurrence of an obligation or commitment, by the Province pursuant to this Agreement is subject to:(a) there being sufficient monies available in an appropriation, as defined in the Financial Administration Act (R.S.B.C. 1996, c. 138) (the "FAA"), to enable British Columbia in any fiscal year or part thereof when any such payment may be required, to make that payment; and
(b) Treasury Board, as defined in the FAA, not having controlled or limited, pursuant to the FAA, expenditure under any appropriation referred to in section 2(a).
3. ACCOUNTABILITY AND REPORTING TO RESIDENTS
(a). Local Governments receiving Funds will develop a plan that sets out the intended uses and performance targets for those Funds.
(b) .By June 30, 2010 and by June 30, 2011 the Local Government will report publicly on the plan under section 3(a) and progress made toward achieving performance targets for those Funds.

## 4. TERM

This Agreement shall commence on the date that it is fully. executed by both of the Parties and shall expire on July 31, 2011.

## SIGNATURES

This Agreement has been executed on behalf of the Local Government by the duly authorized Corporate Officer pursuant to a resolution of the Council or Board, and on behalf of the Province, by the Deputy Minister, Ministry of Community Development.

# Urgent Notice To Members Re: Strategic Community Investment Funds 

Please distribute to Chief Administrative Officer and Financial Officer

> Council/Board action required by all local governments eligible for Small Community, Regional District, and/ or Traffic Fine Revenue Sharing Grants by MARCH I3, 2009

The Province and UBCM have discussed a proposal to restructure key local government transfers to provide Strategic Community Investment Funds (SCI Funds) to eligible BC local governments. Details of the SCl Funds will be sent to all eligible local governments by the Ministry of Community Development, likely within the next few days.

This Notice to Members is provided in advance of those details in order to let members know about the nature of UBCM's discussions with the Province, to inform members of UBCM Executive support of the proposed SCI Funds, and to underscore the urgency of local government action in order to access these funds.

## The need for restructured transfers

The Province and UBCM agreed that faster, strategic spending by BC communities can help to stimulate local economies, encourage growth, create local jobs
and help offset the effects of the current economic downturn. Both also agreed that one way to achieve this objective would be to modify the timing of key local government transfers from the current annual installment approach, in order to provide greater certainty and earlier access to funding. In addition, both acknowledged that the Province will be challenged over the coming months to manage provincial spending priorities within the context of the current economic conditions and competing interests.

Consequently, the Province discussed with UBCM a proposal to deliver funding to local governments earlier than would be the case under the existing small community, regional district and traffic fine revenue sharing grant programs. The proposal is a temporary restructuring of these key local government transfer payments as SCl Funds aimed at stimulating growth and providing greater certainty to local governments.

Under the SCI Funds proposal, eligible local governments would sign a SCI Funds Agreement and commit to develop a plan and publicly report on SCI Funds. The proposal is subject to the approval of the required funding by the Legislative Assembly. The initial payment is included in the 2008/09 Supplementary Estimates, tabled in the Legislative Assembly last week. If the Legislative Assembly approves the Supplementary Estimates, the Ministry
of Community Development will implement the proposal.

## UBCM Executive Support

UBCM Executive considered the proposal and agreed to endorse it. In doing so, Executive considered both the certainty that the proposal provides with respect to transfer payments and the requirement for local governments to plan and report on the funding, to sign an Agreement for the funding, and to do so in extremely tight timeframes. While Executive is not ordinarily supportive of imposing requirements on transfers that have previously been unconditional, and acknowledges that these requirements may be seen as irritants by some local governments, it felt it had few options but to agree to the proposal. On balance, Executive felt the certainty provided by the proposal outweighed the additional requirements, particularly given the current economic and fiscal situation.

The Executive believes that the current economic downturn presents a real risk to local government transfer programs, at least over the short term. As a result, the Executive supported the funding commitment that the SCI Funds represents, believing it to be in the best interests of local governments, and then worked with the Province to ensure the requirements were as streamlined as possible.

## Proposed SCI Funds payments

Under the SCl Funds proposal, eligible local governments would receive three payments, between March, 2009 and July, 2010, which equal, in total, their allocations under the small community, regional district and traffic fine revenue sharing programs for the 2009/10 and 2010/II fiscal years, but with a higher proportion of funds delivered to the local government earlier than would otherwise be the case.

To be clear, the SCl Funds do not represent additional local government funding. They are, instead, a temporary restructuring of key transfer payments aimed at stimulating growth and providing greater certainty to local governments. The basis for these grant payments and the overall amount transferred to local governments under the Local Government Grants Act's Regulation will not change. The final year of the Province's four-year doubling of smali community grants will continue to be implemented and will be included in the SCl Funds package.

## Requirements related to the SCI Funds

SCl Funds will be delivered quickly, with only two strings attached. Local governments will need to "sign-up" for the funds, by signing a SCl Funds Agreement with the Province, and they will need to agree to plan for the funds and publicly report on their use and the results achieved. The SCI Funds Agreement will broadly state the purpose of the funds (i.e., for local government services; to defray the cost of local police enforcement), and will set out the planning and reporting requirements.

UBCM has worked with the Province in developing the SCI Funds Agreement and in determining how best to achieve our mutually held interests in maintaining local government autonomy and minimizing the administrative burden associated with the planning and reporting requirements.

Local governments will need to develop a plan that sets out the intended uses and performance targets for the SCl Funds. For reporting, local governments will need to publicly report on the plan and progress made toward achieving the performance targets. The timing of the SCl report coincides with legislated annual reporting requirements. Therefore, municipalities may choose to include the SCI Funds reporting in their annual report and regional districts may choose to include the SCI Funds reporting along with their annual reporting on regional district finances.

Alternatively, local government could prepare a separate SCl Funds plan and report and present it publicly before June 30 in 2010 and 201I. A template "SCl Funds Plan and Progress Report" was jointly developed by UBCM and the Province, and is attached for your information. While local governments are not required to use that template, it was developed in order to provide some guidance for what the report could contain, and to facilitate a streamlined process for reporting to the public.

## Signing a SCI Funds Agreement

Subject to approval of the Legislative Assembly, the first SCl Funds payment is expected to be delivered before March 31, 2009, to all eligible local governments signing a SCl Funds Agreement by March 13, 2009.

Consequently, UBCM strongly recommends that those local governments currentiy eligible for small community, regional district or traffic fine revenue sharing grants consider the SCl Funds Agreement at their next Council or Board meeting and, if Council/Board resolves to enter into the Agreement, to ensure that it is signed and delivered to the Ministry of Community Development prior to March 13, 2009.

Given the extremely short time frames to submit a signed SCl Funds Agreement, UBCM encourages Chief Administrative Officers for all eligible local governments to place an agenda item on their next Council or Board agenda in anticipation of receipt of applicable documentation from the Ministry of Community Development. If a Council or Board meeting is not scheduled prior to March 13, please give us a call to let us know the date of the next scheduled meeting. It may be possible for those local governments to submit their signed SCI Funds Agreement after the March 13, 2009 deadline date and still received funding prior to March 31 , 2009.

## Re: Strategic Community Investment Funds

A number of local government Financial Officers have contacted us to ask questions about the SCI Funds communication we sent yesterday. This will serve to clarify a couple of points that have been raised during those conversions.

## What happens if we choose not to sign a SCI Funds Agreement? Will we still receive our small community, regional district and traffic fine revenue sharing grants?

The funding for the first of the three SCI Funds payments is now included in the Province's 2008/09 Budget and the funding for the next two payments are included in Province's 2009/10 and 2010/11 Budgets.

The only way to access these funds is to sign an SCI Agreement and the reason there is urgency in signing the SCI Funds Agreement is that funding set aside in this year's budget must be delivered by the Province prior to March 31, 2009.

This year's funding cannot be carried over to the next fiscal year, and therefore will not be available to pay small community, regional district or traffic fine revenue sharing grants for those local governments not wanting to participate in the SCI Funds program.

Therefore, in order to receive grant funding under these programs, local governments must sign a SCI Funds Agreement.

What happens after the last payment of the SCI Funds? Will there be further payments in relation to small community, regional district and traffic fine revenue sharing programs?

The third year of the Province's Fiscal Plan (i.e., 2011/12) tabled in the Legislature last week includes funding for small community, regional district and traffic fine revenue sharing programs. Consequently, UBCM fully expects that payments under these programs would resume for the 2011/12 and future fiscal years.
