RE: Water Issues Delegation

During question period at the previous meeting Daryl Fish asked Council if there was going to be a reduction in the water billing for the months the village has been under boil water advisory.

Some information for Council to consider:

Since the boil water advisory water consumption has not decreased. Residents are still washing, cleaning and bathing.

The average person in the community uses 405 litres of water per day

If we were to look at the costs for water within the Village of Port Clements and a household of 1 person the charges would look as follows:

Residential water

\$19.00 per month \$ 0.63 per day \$ 0.001 per litre per day

Canada's food guide suggests that for healthy living each person should drink 2 litres of water per day which in the terms of the cost to a person would be \$0.06 cents per month is being used for drinking purposes.

While it is fair to empathize with residents that are complying with the boil water advisory and may be purchasing the water the water is still being used, from a financial view when the water system is not working properly the system costs more money to operate. For instance the cost of chlorine, shipping and excess staff time to manage, prepare notices, going door to door and field phone calls make up the bulk of our time.

Mr. Fish had requested that the water billing be reduced by at least 1 month and this is what that cost would look like to the village: \$4341.41 in lost revenue and additional staff time to change the billing for the period. Total cost to the Village approximately \$4500.00.

The average consumption of water in the Month of April was 410 litres per person per day

FINANCIAL PLAN 2010-2014

Small Community Grant Protection:

In 2009 the Small Community Grant Protection was increased to help adjust to the economic instability that began in late 2008. The change in that meant that we would be receiving less in 2010 to off set and return to normal in 2011.

At the end of 2009 the Village was able to save approximately 241,653 to carry forward to 2010. The Village will be withdrawing from its reserves this year the following:

\$451,356
of that funding
\$171,658 will be re-deposited into amortization of the Village's assets
Using the remainder from 2009 total withdrawal from reserves is \$38.045.00

Council intends to complete the following in 2010:

- Ditching
- Trail maintenance
- Alder and brush removal
- Maintenance on Fire hall and Clinic
- Town Clean up including Derelict vehicle removal
- Fire hall upgrades
- Cemetery reclamation

In addition to these listed items Council has also secured grant funding for the following:

- Sewage Lagoon and electrical upgrade
- NEW Concession Stands at the Community park
- Water Treatment upgrade
- Tourism Funding (ending in June)
- Barge and Storage feasibility study
- Wildfire protection planning

In addition there is approximately \$150,000 in upgrades being done through Small Craft Harbours.

A. Project Description

Ben Davidson will mentor and his apprentice, Haida Art Students at Queen Charlotte Secondary School in the design of 3 longhouse fronts. This time and these designs will be donated by Ben Davidson.

These Haida Art participants will then be given the opportunity to attend Swan Bay Rediscovery Camp in July of 2010. During this 8 day course they will learn Haida form line and paint the longhouse fronts. Currently Swan Bay has three traditional longhouses, a girl's longhouse, a staff house and a boy's house. These designs will reflect this information as traditional designs would be the crests of those who lived in them. These students will learn about design as well as protocol.

This project is estimated to take longer than the 8 day in camp course. The following camp participants will be given the same opportunity to finish painting the designs.

This project is estimated to cost \$29,258.78.

The program has many benefits: it increases cultural and environmental awareness, helps to establish cultural identity, enhances self-esteem and confidence, and encourages positive social interaction between youth of many differing cultures. Participants learn wilderness skills and marine skills, play games, meet physical challenges, receive teachings and personal support and get to experience a sense of community and connection to the earth that can empower them for years to come.

Our program's core vision is to instil cultural awareness and self esteem while immersed in Haida Culture. This year we have a Watchman Pole will be placed in front of our longhouses and corner post figures on our cook house. Part of our programming includes teaching a traditional artistic component such as weaving cedar and Haida language etc.

Our program is non-profit. We rely entirely on donations and funding proposals in order to offer subsidized programming opportunities equally to Haida Gwaii youth. We work together with the Archipelago Management Board, Parks Canada, Skidegate Band Council, Haida Gwaii Watchmen, Haida Heritage Centre and the Council of the Haida Nation.

This year we are offering several camps that vary from our traditional Rediscovery Camp such as: Form Line Design Mentoring Camp (part 1 in school, part 2 in camp); elders-youth weaving camp, Leadership/Survival Camp, and two other sponsored camps.

BYLAW NO. 381, 2010

Being a bylaw for the levying of rates for Municipal, Hospital and Regional District purposes for the year 2010.

The Council of the Village of Port Clements, in open meeting assembled, enacts as follows:

- 1. The following rates are hereby imposed and levied for the year 2010:
 - a) For all lawful general purposes of the municipality on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column "A" of the schedule attached hereto and forming a part hereof.
 - b) For Vancouver Island Regional Library purposes on the assessed value of land and improvements taxable for general municipal purposes, rates and appearing in Column "B" of the Schedule attached hereto and forming a part hereof.
 - c) For Skeena-Queen Charlotte Regional Hospital purposes on the assessed value of land and improvements taxable for Hospital purposes, rates and appearing in Column "C" of the Schedule attached hereto and forming a part hereof.
 - d) For purposes of the Skeena-Queen Charlotte Regional District on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in Column "D" of the Schedule attached hereto and forming a part hereof.
 - e) For purposes of the North West Regional Hospital District on the assessed value of land and improvements taxable for Hospital purpose, rates appearing in Column "E" of the Schedule attached hereto and forming part hereof.
- 2. The minimum amount of Taxation upon a parcel of Real Property shall be one dollar (\$1.00).
- 3. This bylaw may be cited as "Tax Rates Bylaw No. 381, 2010."

Rennell Sound boat launch no longer accessible

Islanders and tourists can no longer access the popular boat launch in Clapp Basin (Rennell Sound) due to the access road being washed out.

THE OBSERVER, THURSDAY APRIL 22, 2010

Larry Duke, engineering officer at the Ministry of Forests office said the road washed out last fall, but because it runs through private land, the government's hands are tied.

Clapp Basin is to the left at the bottom of the Rennell Sound hill, but within a few metres of the turn, the road runs three kilometres through private land.

Mr. Duke said the Forest Service has received several letters from islanders who use the site, but a solution is not in sight.

The area used to be a logging camp, he said, and over the years a makeshift recreational area has been created. It's designated as a recreational reserve

(holding it for recreational purposes), but this has no other status nor does the Forest Service have any obligation to maintain it. Mr. Duke says it's not a forest recreation site, mainly because the Forest Service has no control over the access.

The boat launch was put in place by the users, he says.

Queen Charlotte resident Brad Schultz, who uses the area for camping and fishing, says he heard a business had offered to fix the road, but the property owner said no.

He knows industry uses the boat launch to move supplies if they are working in the area, as do some fishing lodges. He also has seen 10-12 large recreational vehicles with boats using the area. These visitors come from off island every year, he said, and they will be very disappointed to learn it is inaccessible. It is the only boat launch on the West Coast.

Mr. Schultz said if a boat launch was available in another part of Rennell Sound, it might address the issue, but he said the area in question offers better conditions for launching. He wants the area to be declared a Forest Recreation site. It already has outhouses, a cement ramp and fresh water available.

Mr. Duke said he's trying to communicate with the land owner, but he's not sure if a solution can be found. Not only has the road been washed out by the ocean for half a kilometre, but it's also very old and may present other liability issues.

"We don't have the solution yet. There is nothing ready to get that access restored this summer," he said. People need to be aware of this and take that into account for their travel plans.


Program amendments in effect for the balance of the year are:
