Message from the Mayor

I would like to personally thank Pete and Roman for the dedication and focus shown while battling our recent water quality problem. There are many arm chair public works experts out there who willingly share their advice. They however are not accountable to Council or Northern Health. Much of our recent problems are related to aging infrastructure, service line and treatment plant. They are not related to the lack of effort from Public Works.

The recent chlorination of our water system was under a direct order from Northern Health under Provincial Regulation. The order was written after multiple water samples fail to meet regulatory benchmarks. It's interesting how Government Regulations call for weekly water testing from Municipal water system, while the bottled water we buy from retailers is considered to be a food product, which under Government Regulations require less stringent testing.

It is the goal of Council and Public Works to provide the best quality un-chlorinated drinking water to Port Clements. As mentioned above, of our aging infrastructure is in need of replacement. Water system projects are very expensive, like wise hard on the ledger sheet. The Village is currently working with Engineers on a new water treatment plant which will enable us to meet our goal. The treatment plant is estimated to cost \$1,075,000.00. The funds for this project are in place, grants from BC/Canada Infrastructure and Gwaii Trust. An additional well and an upgrade to the distribution system are also on the "to do" list.

The Village has several other projects that will commence shortly, re-roofing of the Health Clinic, construction of new concession stands at the park and upgrades to the sewerage lagoon. In addition School District 50 will begin demolition the old school. Rather than bring in an off-island contractor SD50 is training a local crew in asbestos removal to tackle the first stage of removing all asbestos materials from the interior.

Thank you for letter of January 27, 2010, regarding the Haida Gwaii Strategic Land Use Agreement (SLUA).

In your letter, you have indicated that many local professional foresters have concerns about the lack of field testing and layering of objectives associated with the SLUA. This issue was raised when the Joint Management and Technical (JMT) teams were meeting with stakeholders on Haida Gwaii. Some of this uncertainty was clarified by the JMT teams at open houses held during the week of January 18-23, 2010, and the comments provided during that time by the professional foresters and others will be considered by the Minister of Agriculture and Lands when he makes his decision to accept the order or to request further development of the Land Use Order (LUO).

You are correct in asserting that the SLUA commits to providing that "human well-being will be maintained through policies and initiatives designed to achieve socioeconomic benefits, including carbon values, and timber harvest levels that will support a viable forest industry." The extent to which the current draft order delivers on this principle will be another one of the factors considered by the Minister of Agriculture and Lands when he makes his decision regarding the LUO. With the release of the draft LUO, licensees currently have an opportunity to gain some operational experience with its conditions; voluntary implementation of the LUO prior to the objectives being approved is something that I would encourage.

In regards to your comments that O'Brien & Fuerst (O'Brien) have been left without an opportunity to bid on timber sales licenses (TSLs); BC Timber Sales (BCTS) strives to advertise a wide range of species profiles and volumes for their clients. I understand that recently TSL A85504 was posted, but O'Brien did not submit a bid. Two other TSLs that were advertised this year in Haida Gwaii were awarded to other licensees. In the next few weeks another TSL will be advertised, as well as additional sales planned for 2011.

Re: Northern Development Initiative Trust Presentation to Northern Caucus

It was unfortunate that due to scheduling conflicts you were unable to be present at the Northern Development Initiative Trust Presentation to Northern Caucus. While I'm sure your caucus colleagues will share the results of the presentation with you, I'm writing today to highlight my part of the presentation that was directly related to your Ministry.

Haida Gwaii Strategic Land Use Agreement (SLUA) and Timber re-Allocation

While the intent of the agreement is understood and optimistically I believe it will bring much needed stability to our local Forest economy, there are concerns with regards to implementation of SLUA and the re-allocation of the allowable annual cut.

Many of the local Professional Foresters have concerns centered on the lack of field testing and the layering of objectives which could render much of the forest land base as inoperable. They have shared examples of cut-blocks previously approved (while voluntarily applying EBM objectives) by the CHN and MOF that become economically inoperable when the Monumental Cedar and Riparian Zone objectives are applied verbatim. Keep in mind the intent of the Haida Gwaii Strategic Land Use Agreement (SLUA) is to provide for "Human well-being will be maintained through policies and initiatives designed to achieve socioeconomic benefits, including carbon values, and timber harvest levels that will support a viable forest industry". Before the SLUA objectives become law I ask that the concerns raised by the local Professional Foresters be reviewed and tested in the field.

Understandably the re-allocation of the AAC along with the creation new tenures has been an extremely challenging task for your Ministry. These challenges are having an immediate impact on local BCTS operators. The creation of the Haida tenure area transition BCTS out of the Log Creek area. BCTS then proceeded to prepare timber sales (75000 m3) north of Log Creek outside of the proposed forced Haida tenure area, the boundaries of the proposed Haida tenure were altered and the available cut-blocks were no longer available to BCTS.

As a result operators such as O'Brien & Fuerst Logging who this past year have been the only continuously operating forest business on Island (employing approximately 30 locals) have been left without an opportunity to bid on BCTS sales needed to support their pole peeling plant. The O'Brien's have shared several pieces of correspondence between their office and your Ministry, suggesting that volumes would be made available to accommodate a transition from historic BCTS areas. It appears the Ministry has fallen short on delivering this volume. Port Clements has residents who have not worked at their regular jobs for over fifteen months we can not afford any further job lost.

Community Forest

The announcement of a Community Forest shared between the non-aboriginal communities is greatly appreciated by the elected officials. We thank yourself and all of your staff who have worked to achieve this goal. We originally requested tenure, equal to the Haida's tenure so that there was parity amongst the Committees. We will continue to push for additional volume. Additionally we have concerns over the proposed partnership with BCTS. While we can see benefits of the partnership, the requirement of auctioning the volume under the BCTS system may not address our desire to keep the wood on Island for local manufacturers. I trust there will be further discussions on the Community Forest and how we can achieve our goals of supporting local value added manufacturing. Once again thank you for all that you have done to date on the Community Forest.

If you wish to discuss any of these issues in person I can make myself available to meet at your request.

The Council of the Village of Port Clements believes a clause by clause critique of the draft Land Use Order (LUO) will not resolve the concerns we have with the LUO. We understand the Haida Gwaii tenure holders have made comments and will make detailed submissions so we will leave that work to them and concentrate on the overall effects of the draft LUO as presented.

The draft Land Use Order is a set of measures, the objectives, designed to protect a set of resources. The Objectives will very likely be successful in protecting those resources but the Strategic Land Use Agreement (SLUA) contains a socio-economic objective as well the ecosystem base management (EBM) objectives. The authors of the LUO seem to rely on the AAC modelling of Andrew Fall for assurance that the SLUA socio-economic objective will be met. However after reading the draft LUO and after looking at large scale and block level maps most informed observers and this Council find it difficult not to draw the conclusion that the available forest will be fractured into small areas which cannot provide the economic harvest opportunities envisioned by the Strategic Land Use Agreement signed in Dec 2007. Therefore more work should be done to ensure that the model provides a clear picture of the results of LUO Objectives.

In addition, we have concerns that the model is only as accurate as the assumptions loaded into the model which are based on the objectives in the LUO. The comments provided by Haida Gwaii foresters used to applying rules in the field, which explain the technical problems with the LUO, indicate there is a disconnect between the application of the objectives on the ground and the assumptions of the model. The foresters believe that the application of the Objectives in the field will result in a shut down of the Haida Gwaii harvest. The model indicates that a harvest greater than the 800,000 m3 goal of SLUA is available. The problem with this disconnect is that the objectives, not the model become regulation and unless the objectives are revised, any problems with the draft objectives will became the new Haida Gwaii "rulebook" to be applied on the ground. The foresters view of the draft objectives is that they will result will be little or no economic opportunities for harvesting. If they are correct the socio-economic goals of SLUA will not be met.

One of the reasons for the problems with the objectives is the language of the definitions and objectives are prescriptive; similar to Forest Planning & Practice Regulations (FPPR) requirements, results or strategies from a Forest Stewardship Plan (FSP). This would be fine if the language was clear enough to be measurable and verifiable as required by Forest & Range Practice Act (FRPA). We suggest the draft LUO be reviewed by experts in BC Forest law who can provide guidance in creating clear objectives where the results of modelling and the results in the field are as similar as possible.

We are deeply concerned that the cumulative effect of these well intentioned objectives each designed to protect an individual resource will pile up to reduce the chances that cut blocks will pass the economic test. What is needed is the flexibility that is hinted at in the "intergovernmental process" and "adaptive management clauses" of the draft. Unfortunately these kinds of processes in the past have been adversarial and tended to take considerable time to complete. If these flexible processes don't quickly result in approved cut blocks the island workers will continue to drift away as the economy in the rest of Canada recovers.

Given that the major licensees have curtailed operations on Haida Gwaii due to market conditions. Is it not obvious that any addition economic constraint imposed by the LUO will shut down Haida Gwaii forestry completely until markets improve substantially? Any new rules need to be implemented very carefully to avoid such a shut down. In addition any new rules need enough flexibility to survive the next market cycle.

Most islanders familiar with forest operations know that to maintain operations through swings of the markets, the target of the harvest has to be adjusted to keep the selling price higher than the cost. Selling price has to be adjusted as costs have already been pared to the bone as evidenced by the number of contractors and forest companies in BC that are in financial difficulty.

There is little value in applying a new management regime that has the potential for closing operations. The idea of the new planning is to make the islands ecosystem and cultural resources sustainable; shouldn't the socio-economic objectives be sustainable as well? Shouldn't the resource of island forest workers and their families be sustainable as well? Getting full value from the harvest for island people should be the focus of planning.

As much value should be added before wood leaves. Island sawmills should be working. Local carvers should be working. Unused low value logs and debris should not be left to rot producing CO2. This fibre resource should be gathered along with the unused material from sawmills and pole plants and converted under controlled conditions to electric power to replace imported diesel.

The LUO should ensure that the 800,000 m3 cut is available and can it be economically harvested to provide island workers a good living while providing enough revenue to finance the schools, hospitals and other infrastructure required to make a living on these islands more attractive to young people looking for a good place to raise their families

The Council of the Village of Port Clements would be happy to help with any process that results in the vision described above. This would be a good example of the island planning protocol we all signed in action.



Education and Community Outreach

THE VILLAGE OF PORT CLEMENTS

BYLAW NO. 379

A bylaw of the Village of Port Clements to Amend the Official Community Plan No. 140, 1984

WHEREAS the Village of Port Clements is concerned about the effects of climate change on the community and has signed onto the BC Climate Action Charter;

AND WHEREAS in 2008 the Province of BC enacted Bill 27, the Local Government (Green Communities) Statutes Act requiring local governments to incorporate greenhouse gas emission reduction targets, policies and action plans into their official community plans by May 31, 2010;

AND WHEREAS section 877(3) of the Local Government Act requires official community plans to include targets for the reduction of greenhouse gas emissions and policies and actions proposed with respect to achieving those targets;

NOW THEREFORE, the Council of the Village of Port Clements in open meeting assembled enact as follows:

- 1. This bylaw may be cited as Bylaw No 379, A Bylaw to Amend the Village of Port Clements Official Community Plan:
- 2. The Village of Port Clements Action Plan for the reduction of greenhouse gas emissions is as follows:
 - i) Create an anti-idle policy to encourage idling vehicles to shut off their engines around Municipal buildings and encourage business owners in the Village to ban idling vehicles around their buildings.
 - ii) Plant trees throughout the community using grant funding.
 - iii) Reduce the number of Municipal buildings by building multi-purpose buildings and retrofit other Municipal buildings for energy efficiency.
 - iv) Upgrade water and waste water treatments.
 - v) Utilize technology by emailing co-workers rather than printing documents in an action to reduce the amount of paper being used.
 - vi) Use recycled paper if printing is a necessity.
 - vii) Ban bottled water from Municipal buildings and make water coolers available.
 - viii) Use ceramic cups and dishes, and reusable silverware whenever possible.
 - ix) Implement a "lights off" policy to ensure that all users and employees in Municipal buildings turn the light, heat and any other electronics off in rooms that they are not in.
 - x) Encourage car-pooling to work for Municipal employees and meetings.

3. The Village of Port Clements goals for the future greenhouse gas reduction are as follows: i) Upgrade filing system to reduce amount of paper. ii) Purchase laptops for each Council member for paperless agendas. iii) Teleconferencing and videoconferencing to reduce greenhouse gas from vehicles. iv) Create new building policies with energy efficiency aims at reducing greenhouse gases. v) Ensure that all contractors and suppliers working on behalf of the Village comply with all Municipal, Provincial, and Federal standards in regards to the environment. 4. The Village of Port Clements roles for the residential and commercial zones are as follows: i) Assist residents and businesses through the use of grants to upgrade homes and buildings for energy efficiency. ii) Encourage installing low flow toilets within residential and commercial buildings. iii) Install water metres on all properties to monitor water consumption. iv) Work with the Skeena Queen Charlotte Regional District to encourage recycling, reducing landfill usage. Encourage residential energy assessments in conjunction with BC Hydro. v) READ A FIRST TIME THIS 19TH DAY OF APRIL, 2010. PUBLIC HEARING HELD THIS _____ DAY OF _____, 2010 READ A SECOND TIME THIS _____ DAY OF _____, 2010. READ A THIRD TIME THIS ____ DAY OF , 2010. ADOPTED THIS ______DAY OF , 2010. Quarterly Policing Report Jan.1, 2010 - Mar. 31, 2010

INTRODUCTION

Please find enclosed a summary of the activities of the Masset RCMP Detachment encompassing the period of January 1, 2010 to March 31, 2010.

A commitment of the RCMP to the communities we serve is more effective communication. Being a strong proponent of open communication, three steps I have taken this quarter, as Detachment Commander, to more effectively communicate with our clients, partners and stakeholders includes partnering with the Village of Port Clements in maintaining a discussion forum on public safety on the Village of Port Clements Facebook site which affords the public the opportunity to learn about and engage in on-line discussions about safety related topics. Also, the RCMP Masset Detachment now disseminates news releases via facsimile directly to the Village of Masset, Old Massett Village Council, Village of Port Clements and Council of the Haida Nation in addition to the Haida Gwaii Observer. Finally, copies of the quarterly policing report are available to the public at the front counter of the Detachment. To date, this increased level of communication has met with favorable comments.

During this quarter (Q4), Masset Detachment responded to 479 calls for service and lodged 84 prisoners. This compares to 381 calls for service and 81 prisoners during the same period in 2009. Overall, calls for service rose by 26% and prisoners rose by 4% in the fourth quarter compared to the same period in 2009.

HUMAN RESOURCES

Masset Detachment consists of nine (9) Regular Members, two (2) Public Service Employees, one (1) Casual Employee and seven (7) guards. During this quarter, Masset Detachment was fully staffed but did experience three soft vacancies involving Members who were seconded to provide security at the 2010 Olympic and Paralympic games through the months of January, February and March. Also, Masset Detachment supported the All Native Tournament in Prince Rupert with Cst. OBODZINSKI attending to provide additional resources during this event. To supplement resources, Masset Detachment requested and was supported by North Coast Marine Services who traveled to Masset and assisted in providing operational support during their stay in late January and late February.

A business case continues to remain before the Province of British Columbia seeking two (2) additional Regular Members and one (1) Public Service Employee.

Transfer notices have been officially received confirming the transfers of Cpl. Jim DEHOOG (Courtenay), Cst. Mark SHAW (Lower Mainland Emergency Response Team) and Cst. Andrzej (AJ) OBODZINSKI (Central Island Traffic Services - Oceanside/Parksville) over the coming months. Their replacements have also been officially confirmed and will include Cpl. Andrew BAYLIS (from Dease Lake), Cst. Ryder BIRTWISTLE (from Chase) and Cst. Darrin MEIER (from Duncan). In total, Masset Detachment will be losing 28 years of policing experience through transfers out of masset while gaining 15 years of experience for Members coming to Masset. The net result will see Masset become 13 years more junior in service. This remains consistent with Detachments across the country and is an illustration of the trend in all work forces in Canada.

It is expected that Cpl. DEHOOG will be departing Masset in late May, while his replacement will not be arriving until July. The remaining transfers will likely not occur until after July 1, 2010, due in part, to a National leave restriction (June 15 - 30, 2010) affecting all Members of the RCMP throughout Canada due to security commitments associated to the G8/G20 in Ontario.

TRAINING

Due to commitments associated to the 2010 Olympics and Paralympics, Members of Masset Detachment were restricted in obtaining training opportunities during this quarter. Training that was able to be supported included one Member attending monthly Emergency Response Team training, one Member attending Operational Skills training and four Members receiving training on the water using the Detachment boat. Several Members locally took advantage of remaining

in our community and successfully completed various public safety related on line courses through the RCMP intranet.

There will be a resumption to previous levels of training opportunities in the next quarter.

FINANCIAL MANAGEMENT

The operating budget for 2010/2011 remains the same as the previous fiscal year. Masset Detachment will manage an operating budget of \$126,600. This budget is split between Provincial Policing (funded by the Province of British Columbia) and First Nations Policing (funded by the Government of Canada). Of the \$126,600. budget, the Province funds \$100,100. while the Federal Government funds \$26,500.

YOUTH / SCHOOL LIAISON PROGRAM

Masset Detachment is committed to the RCMP national strategic priority of Youth which is evidenced by the frequency Members interact with staff and students at each school within our policing jurisdiction. A sample of the school based activities Members have delivered to youth during the past quarter include: presentations on urban safety (for students attending the Olympics), personal safety, sportsmanship, citizenship, boat safety, heros and recruiting. Members also conducted Red Serge detail for the Mini Olympics (Port Clements), completed Identification Kits for students traveling to the 2010 Olympics (Chief Matthews), conducted a job interview of a student in support of Career Planning (GMD), participated in clam digging on North Beach (Chief Matthews), P.A.L.S. Program (literacy) (Tahayghen) and coaching Badminton (Tahayghen). Additionally, the Masset RCMP Detachment continues to maintain Cops Corner bulletin boards in Tahayghen and Chief Matthews as well as hosting ongoing contests entitled "Where's Trevor (Chief Matthews) and "Guess the Number" (Tahayghen).

Being cognizant of the influence RCMP Members have upon our youth through role modeling, Members are involved in community sports and social activities through coaching and refereeing outdoor soccer and the Junior Ranger Program.

Over the past quarter, Masset Detachment continued to commit to public safety involving schools through traffic enforcement efforts in school zones throughout the policing jurisdiction.

A review of the final data for the 2009/2010 Annual Performance Plan, demonstrates the commitment to public safety in increasing traffic safety through having achieved its target in the number of Checkstops conducted for the year. Police are also encouraged that while increasing the number of Checkstops conducted, there was a noticeable decrease in the number of impaired driving charges. It is believed this is attributable in part, to increased enforcement as well as education and awareness initiatives.

Though the Masset Detachment did not achieve its target in relation to charges under the Controlled Drugs and Substances Act, the RCMP has seen a significant increase in use of the Crimestoppers Program to report drug activity in our communities. With the support and assistance of our communities, together we will continue to work towards reducing drug abuse.

During the past quarter, the Masset RCMP Detachment conducted a number of consultations with Clients/Partners/Stakeholders in each community to seek valuable input on setting priorities for the RCMP in the coming year. As a result, the Annual Performance Plan for 2010/2011 is near completion.

COMMUNITY POLICING PROGRAMS

The RCMP commits to delivering a culturally sensitive and responsive police service to meet the needs of the communities we serve. This is evidenced through various community based programs supported by the RCMP Masset Detachment over the past quarter by attending:

- the Haida Health Center Breakfast Program
- the Caring Sharing Lunch held each Tuesday in St. Johns Church in Old Massett
- the Adult Drop In Program each Monday and Friday at the Elders Center in Old Massett
- the Soup Kitchen held each Saturday at the Old Fire Hall in Masset
- being an active participant on the Coordination for Community Safety Committee.
- being an active participant in the Healthy Communities Society which is the recognized Community Consultative Group designated through the Community Tripartite Agreement with Old Massett Village Council.

Recognizing that listening is an important component to communication, during the past quarter, the RCMP met with various Client/Partners/Stakeholders including:

- attending the Strategic Land Use Agreement held in Port Clements
- attending town hall meeting in Port Clements
- attending a public meeting hosted by the Member of Parliament, Nathan CULLEN
- meeting with the Ministry of Transportation & Infrastructure
- meeting with the Ministry of Children and Family Development

Members have continued over the past quarter to demonstrate their commitment to their community as evidenced through their involvement in coaching youth sports (outdoor soccer and badminton), attending community events including feasts, funerals and fund-raisers. The Masset RCMP also supported the Winter Picnic sponsored by the Transition House.

RECRUITING

Canada is a diverse country and the RCMP understands the importance of having a Force which is reflective of the people we serve. That said, the Masset RCMP Detachment is committed to promoting the RCMP as a career choice and demonstrated its commitment to this initiative during the past quarter through the following activities: I) Cpl. Dee STEWART, an Aboriginal Recruiter from Vancouver traveled to Haida Gwaii in January and conducted recruiting presentations at Tahayghen Elementary, Chief Matthews School and George M Dawson High School while also speaking to individuals who had expressed interest in law enforcement as a career; ii) Cpl. STEWART returned to Haida Gwaii in late March to host a public information session held at the Howard Phillips Hall. During this visit, Cpl. STEWART was also able to attend the Port Clements Elementary School and deliver a recruiting presentation; iii) Masset RCMP Detachment was active in promoting the Police Observer Program which saw four individuals who are interested in the RCMP as a career choice shadow our Members in their work to get a sense of the rewards and challenges associated to policing. Through continued efforts such as this, I am confident that we will be successful in moving towards providing a police service which more accurately reflects the diversity of our area.

As one can see, the Masset RCMP remains committed to providing a quality policing service to the people of Masset, Old Massett, Port Clements and the Northern portion of Tlell. A key link to continually providing quality policing is open and honest communication involving the people we serve. With that in mind, my door is always open to listen to the people, should you have any ideas, suggestions or feedback pertaining to public safety. I encourage you to stop by, have a coffee and discuss matters of public safety that affect you, me and our community.
