### GREETINGS FROM THE CHATHAM ISLANDS, NEW ZEALAND

It gives me great pleasure to be able to send greetings to you and your community from the Chatham Islands.

Our General Manager, Owen Pickles, and his wife, Lynette, speak fondly of their visit to Port Clements in 2007, and encourage us often to build on the relationship that is developing between us.

The year that is about to finish has been a bit of a 'roller coaster' for both me and my community. For me, I was honoured to have been elected Mayor by my Council following the retirement of my predecessor, Mr Patrick Smith, in January. Patrick had been Mayor since 1989 and a member of the Council since 1967, leaving big shoes to fill. I and my Councillors face the polls again in October.

Our biggest project during the year was the construction of a new wharf at the village of Owenga. Costing \$1.6m, the project was completed ahead of time and within budget, which was a very satisfying result.

Our disappointment was the lack of response from the New Zealand Government to our calls for help with solving some essential infrastructure problems. Electricity generation, airport upgrade and port protections are but a few of our big issues. These are beyond our local incomes to solve. The British Columbian model observed by Owen and Lynette would be very welcome here.

I was also interested to learn that our communities have an historical connection through the deeds of Lt William Robert Broughton and Captain Vancouver, who were the first European travellers to find the Chatham Islands, and who were later to explore British Columbia and the Charlotte Islands. I will send you a copy of a photo that is in our Museum confirming this, as a token of our relationship.

In closing, I would like to invite you to visit the Chatham Islands so that we may have the opportunity to repay the hospitality you afforded Owen and Lynette. We would love to see and meet you in person.



SUBJECT: Existing or Impending Lay-Offs of Forest Workers

DATE: July 1, 2010

Council should be aware, since early in May, 2010, when I reported the lack of approvals being issued by the Ministry of Forests, they issued one approval, Mamin 135.

At the end of this week, logging in TFL60 will be complete and all workers will be laid off. Employees of Edwards and Associates, LNR Excavating, Rias, Myles and all other contractors will be unemployed.

This means, in Port Clements, there is or will be a lay-off of 32 people, in Queen Charlotte 12 people, in Skidegate 10 people, and in Masset 9 people.

Although the Ministry of Forests has approvals on their desk without any problems with the applications, they cannot get the nod from the CHN who they have a duty to consult. MoF is reluctant to release the approvals until they get this nod.

Edwards and Associates and the other contractors are puzzled by the reluctance of the CHN to ensure a degree of community stability during this year of transition.

SUBJECT: Vancouver Island Regional Library Board Meeting

DATE: June 19, 2010

The Board approved the VIRL budget for 2010.....revenue/expenses of \$16,586,641. The budget included a community levy increase of:

1% for facility maintenance

• 1.25% for facility reserve

for a total of 2.25% increase

The Board has been restructured with the creation of an executive committee which will deal with much of the Board business and who will make recommendations to the Board for ratification. The Board, with 38 members is too cumbersome to discuss and make all the decisions required in a timely fashion.

Many of libraries in the district are inadequate and aged and becoming expensive to maintain. The Port Clements library is looked at being the ideal facility and similar opportunities are being searched for in all other communities. This led to the creation of a facilities master plan where the communities with the most inappropriate facility are the first to get upgrades. The Board does not have the ability to borrow funding for building new facilities but the Board did approve staff to explore other means of building new facilities.

Legal opinion was sought about members reporting in-camera items to their councils. The opinion given is in-camera items must be reported to councils only when the councils are in-camera.

The Protocol Table was asked about opportunity for public input at future protocol meetings. After discussion, it was assigned to Councillor Johnson and April Churchill to prepare recommendation(s) for public involvement at future meetings.

Mayor Kuluska reported BC Ferries has abandoned their plan for a Tsawassen run after the northern communities rigorously objected to it as it would have meant reduced service for the northern run.

Travis Glasman reported MIEDS strategy for:

- Agriculture on Haida Gwaii
- Trail building
- Regional economic development implementation plan

The report for an All-Island Recreation Centre is still in progress

Andrew Merilees reported the response from Canada Post to Mayor Pages letter complaining of mail service to the Islands. Moya Greene is no longer in charge of mail transport to the Islands. HGOPP will prepare a letter urging return of air transport of mail to the Islands. All communities are asked to do likewise.

The HGOPP was able to unanimously voice their objection to the Enbridge project.

Port Clements was asked to spearhead the Island Government initiative by applying to Gwaii Trust for funding. I responded to this request by saying I would take this to Council and our administrative staff. It was mentioned Gerry Johnson and Bill Beldessi had unsuccessfully applied for funding in the past and they may have information for this application.

The talk by BC Ferries of reducing Kwuna Ferry sailings was discussed. HGOPP will prepare a letter to the Minister of Transport stating any reduction of this core service is unacceptable.

Knotweed treatment and removal (both Himalayan and Japanese) was extensively discussed. Community public works personnel are urged to be aggressively attack this invasive plant to try to control the spread. A working group will be set up by April Churchill to prepare a plan to deal with Knotweed on island

### INTRODUCTION

Please find enclosed a summary of the activities of the Masset RCMP Detachment encompassing the period of April 1, 2010 to June 30, 2010.

Stemming from the community consultations of the last quarter in the development of the 2010/2011 Annual Performance Plan, the Masset RCMP Detachment consistently heard from our communities their concerns linked to drugs and its effects upon the health and well being of our citizens. In response to this community identified priority, the Masset RCMP Detachment seized the opportunity to forge new partnerships in the area of prevention and education through the delivery of the Preventing Alcohol and Risk Related Trauma in Youth (PARTY) Program and the development of a Community Prevention and Education Continuum. The PARTY Program will form one of the foundational pieces of Masset Detachment's Community Prevention and Education Continuum into the future. The Masset RCMP also met with many community Clients/Partners/Stakeholders in developing the initial Continuum. Enclosed at the end of this report is the Continuum as it looks today. It is important to point out that this Continuum is an evolving document and the Masset RCMP invite individuals, businesses and non government agencies who may have an interest in taking ownership of a component of the Continuum to give Sgt. Grant MacDONALD at call at (250) 626-3991 anytime to discuss. That includes new drug education programs other agencies may have available to deliver to our youth.

During this quarter (Q1), Masset Detachment responded to 449 calls for service and lodged 88 prisoners. This compares to 421 calls for service and 97 prisoners during the same period in 2009. Overall, calls for service rose by 6.7% and prisoners declined by 9.3% in the first quarter compared to the same period in 2009.

### **HUMAN RESOURCES**

Masset Detachment consists of nine (9) Regular Members, two (2) Public Service Employees, one (1) Casual Employee and seven (7) guards. During this quarter, Masset Detachment was fully staffed but did experience one (1) soft vacancy involving a Member who was seconded to provide security at the G8/G20 Summit in Huntsville/Toronto, Ontario.

During this quarter, Masset Detachment secured additional resources to supplement resource levels during community events drawing increased people to our community including Harbour Days (May) and Aboriginal Day (June). These additional resources included North District West

Traffic Services and North Coast Marine Services.

Inter-division transfers for the 2010/2011 fiscal year have commenced and have seen the following changes completed. Cpl. Jim DEHOOG and family have relocated to Courtenay/Comox Detachment and Cst. AJ OBODZINSKI and family have transferred to Parksville/Qualicum Beach. Transferring into Masset Detachment from Dease Lake was Cpl. Andrew BAYLIS and his wife, Dawn, who is a Nurse at the Northern Haida Gwaii Hospital and Health Center. The BAYLIS's arrived into Masset on June 18, 2010.

Future transfers will include Cst. Mark SHAW and family departing Masset on July 5, 2010, for a position with the Emergency Response Team in the Lower Mainland, the arrival of Cst. Ryder BIRTWISTLE and family from Chase to fill one of the First Nations Policing positions and Cst. Darrin MEIER and family who will arrive in Masset during the early part of August 2010.

A business case continues to remain before the Province of British Columbia seeking two (2) additional Regular Members and one (1) Public Service Employee.

### TRAINING

During this quarter there were few training opportunities afforded Members of Masset Detachment. This was due in part to Detachment management requiring resources to remain

local to facilitate transfers and the Member attending the G8/G20.

Training offered during this quarter included two (2) Members attending the Pacific Region Training Center in Chilliwack to attend the Police Records Information Management Environment (PRIME) supervisors course. This training enables senior Constables to be provided future developmental opportunities to Act in the role of the Operations N.C.O. during the absence of Cpl. BAYLIS. Also, Masset Detachment continued to support specialized training to one (1) Member to attend monthly Emergency Response Team training.

### FINANCIAL MANAGEMENT

The operating budget for 2010/2011 has not been officially finalized, however, Masset Detachment will be operating with an increase in funding from the Province to accommodate increased costs associated to Members being compensated for "on call" hours during quiet hours. Also, Masset Detachment will have its budget for First Nations Policing reduced by approximately \$5,000. Masset Detachment will endeavor to work within the allocated budget.

It is anticipated that more accurate figures will be available during the next quarterly report.

### YOUTH / SCHOOL LIAISON PROGRAM

Masset Detachment has continued to demonstrate its commitment to the RCMP national strategic priority of Youth as evidenced in part, by increased visits to all local schools. Overall, Members of Masset Detachment visited the four (4) local schools 220 times during the 2009/2010 school year which equates to an increase of 27.9% over the preceding school year (172).

A sample of the school based activities Members have delivered to youth during the past quarter include: a hot lunch program, coaching badminton, a bike rodeo, recruiting and attendance at various graduations of all schools in our area.

Cst. Trevor SHIELDS was instrumental in developing a partnership with School District #50, the Northern Haida Gwaii Hospital, the B.C. Ambulance Service and the Volunteer Fire Departments of Masset and Old Masset in delivering the very first Preventing Alcohol and Risk Related Trauma in Youth (PARTY) Program on Haida Gwaii. This is a dynamic, interactive injury prevention and health promotion program. PARTY involves Grade 10,11 and 12 students who observe the path of a trauma patient through the health care system from pre-hospital care to rehabilitation and sometimes death. PARTY uses five (5) key messages which includes: I) Buckle Up, ii) Drive Sober, iii) Wear the Gear, iv) Look First and v) Get Trained. Students are empowered to recognize risks and make informed, smart choices, building a culture of safety in all aspects of their community life, including home, school, recreation and work

Members continued to be actively involved in leadership roles with our youth through coaching and refereeing outdoor soccer with the Haida Gwaii Minor Soccer Association.

In late May, a team consisting of Members from the RCMP Drug and Organized Crime Awareness Section (DOCAS) along with a researcher, a community prevention coordinator from the East Kootenay Addictions Services Society and a Coroner from the B.C. Coroners Service visited Haida Gwaii to assist Masset and Queen Charlotte Detachments in developing a Community Prevention and Education Continuum (CPEC) for their respective community.

CPEC is a philosophically different way to approach prevention in communities. It is not a program but rather a way of thinking, a compilation of components that come together to propel a change in beliefs, promote greatness, develop assets, and engage the community in a common goal. As we move forward to the 2010/2011 school year, we will continue to solidify the components that will begin the shift from *changing behavior* to changing beliefs. Masset Detachment will provide updates on progress with the development of CPEC in future quarterly reports.

Also, in support of drug prevention and education, Masset Detachment participated in the Youth Health Fair held in George M Dawson in early April and the Haida Health Fair held at the Community Hall in Old Massett in June. Both events were very well attended and a lot of informative information was given to local youth and parents.

- being an active participant in the Healthy Communities Society which is the recognized Community Consultative Group designated through the Community Tripartite Agreement with Old Massett Village Council.

Recognizing that listening is an important component to communication, during the past quarter, the RCMP met with various Client/Partners/Stakeholders including:


- meeting with Victims Assistance Program Coordinator and Stopping the Violence Against Women Counselor
