Dear Heather Nelson-Smith:

Thank you for your letter to Minister Bell we received on May 25, 2010 regarding the landslide that occurred across private property in the Clapp Basin on Haida Gwaii. I understand that the landslide has since been cleared and that currently there is access to the boat launch and recreational area at the far end of the road.

While it is unlikely that the province will be able to expropriate this road right-of-way from the private land owner; representatives for the land owners have been receptive to other possible arrangements. One such arrangement might be a right-of-way agreement between the land owner and a user group which would bear the responsibility for the maintenance of the road.

While Ministry of Forests and Range (MFR) staff can facilitate these discussions, they will be most effective if a community-led user group participates in the process. I have directed staff from the Haida Gwaii Forest District to contact you and discuss the formation of such a group, and from there assist with dialogue between the group and the land owner.

Dear Mayor & Council,

I am following up on our July 7, 2009 correspondence requesting from you a letter of support as the BC Recreation and Parks Association (BCRPA) moves forward in addressing the urgent need for recreation infrastructure renewal throughout our province.

Last year we released the "A Time for Renewal" report, a culmination of 5 years of research, study and analysis of BC's indoor recreation facilities, which concluded that 68% of the province's infrastructure is over 25 years of age and in urgent need of upgrade or replacement. Its inability to keep up with the demands of a growing population and their changing needs as well as local and provincial environmental stewardship goals is putting healthy communities at risk. Our recreation infrastructure is reaching the crisis point for capital investment.

Our advocacy work around this issue continues as we meet with government officials to increase their awareness of the issue and secure their financial commitment and support. Essential to this work is the demonstration of support local governments have for the need to renew and replace these valuable community resources – for the benefits they bring to their own communities as well as to the province as a whole – and for the work the BCRPA is doing on behalf of all communities within BC.

Now is the time for renewal. Recreation has the capacity to improve the quality of life for *all* British Columbians. With your help we can ensure our recreation infrastructure remains functional and safe, continuing its role in improving our general health and wellbeing.

Please, help us as we work to turn this pressing need into a public policy priority. Your letter will support the urgency and importance of this issue and how it impacts all of us across BC.





A1: DEVELOPMENT OF A LIVABLE-INCLUSIVE COMMUNITIES STRATEGY

WHEREAS the Measuring Up The North Initiative (Phase 1) has been successful in helping BC communities assess and improve how livable, age-friendly, disability-friendly, universally designed and inclusive they are for all residents and visitors;

AND WHEREAS many time-limited initiatives such as MUTN Phase 1 and others in the Province have started the momentum but there is still a great deal more to do;

AND WHEREAS MUTN has developed tools and processes and learned lessons that could contribute to a provincial-wide initiative:

THEREFORE BE IT RESOLVED that UBCM work with the Province of BC to create a framework called the Livable-Inclusive Communities Strategy that communities can use as a guideline to plan for livable, age and disability friendly communities.

AND BE IT FURTHER RESOLVED that the Provincial Livable-Inclusive Communities Strategy include provincial funding and support as well as Provincial Awards that recognize and encourage business, community, local governments and individuals in their efforts.

Background:

The intent of the strategy: That the Province show through a strategy, a commitment to continue the momentum and support the efforts that have been taking place across the province ,and plan for new goals in regard to livable, age-friendly, disability-friendly communities for all residents AND visitors (ie to also capture accessible tourism efforts). Since many entities have already been involved for several years in a variety of efforts, this strategy would involve a range of partners working with the Province.

UBCM comments:

The UBCM membership has not previously considered a resolution calling for the Province to enact a Livable-Inclusive Communities Strategy be developed.

Measuring Up The North (NCLGA); Ministry of Healthy Living and Sport; Smart Growth BC, UBCM, and 2010 Legacies Now and other organizations recently collaborated to produce a resource for local governments that provides guidelines for making Official Community Plans more age-friendly and disability-friendly.

Clarification from the sponsor is requested as to the goal(s) of a Livable-Inclusive Communities Strategy and the organizations and / or activities that would be part of such a strategy.

<u>B34: SEGWAY - ALTERNATIVE MOBILITY DEVICE FOR PEOPLE WITH DISABILITIES</u> DISTRICT OF TUMBLER RIDGE

WHEREAS approximately one-half of all car trips are less than five kilometres long and involve only a single occupant;

WHEREAS the electric Segway Human Transporter is an environmentally-friendly, short distance type of vehicle;

WHEREAS in 2007 at the UBCM Convention, local governments and the province demonstrated their shared commitment to take action on climate change by signing onto the BC Climate Action Charter:

WHEREAS studies have shown that the Segway may be a good device for people with disabilities because it allows them to participate in social and functional activities in a manner that traditional mobility aids do not facilitate as well:

THEREFORE BE IT RESOLVED that the NCLGA and UBCM lobby the Provincial Government to amend the *Motor Vehicle Act* to allow for the use of the Segway Human Transporter wherever traditional mobility aids are permitted.

UBCM comments:

The UBCM membership has not previously considered a resolution requesting an amendment of the Motor Vehicle Act to allow the use of Segways wherever traditional mobility aids are permitted.

However, two other resolutions on Segways have been considered by the membership. Resolution 2003-B64 was endorsed and requested that provisions for Segways be included in the Motor Vehicle Act to permit and regulate their safe use. Members considered but did not endorse resolution 2009-B179, which requested an amendment to the Motor Vehicle Act to allow for the use of the Segway Personal Transporter on sidewalks adjacent to roadways.

Segways are considered motorized vehicles; however, they cannot be used on roadways as they do not meet provincial equipment safety standards, and cannot be operated on sidewalks adjacent to roadways. Segways can only be operated on private property that does not have public vehicle access or on a trail or pathway if allowed by a municipal bylaw.

This resolution requests that Segways be allowed wherever traditional mobility aids are permitted. According to ICBC, motorized wheelchairs can be used on sidewalks or roads, following the same rules as pedestrians

B35: ACCESSIBILITY DESIGNATION

CARIBOO REGIONAL DISTRICT

WHEREAS many members of our society are affected by accessibility limitations;

AND WHEREAS communities who strive to make accessibility a priority are often unrecognized and unknown to those who might utilize them:

THEREFORE BE IT RESOLVED that the NCLGA and UBCM lobby the Ministry of Healthy Living and Sport to implement a Provincial Accessibility Capital designation similar to the Forest Capital of British Columbia designation administered by the Association of BC Forest Professionals, and to award that designation to a community or region within British Columbia on a two-year basis.

UBCM comments:

The UBCM membership has not previously considered a resolution requesting that the provincial government create a Provincial Accessibility Capital designation, similar to the Forest Capital of British Columbia designation by the Association of BC Forest Professionals.

For the Forest Capital program, the Association of BC Forest Professionals selects one community to be the Forest Capital of BC, in an effort to celebrate the economic, cultural, natural and historic contributions forests make to community life and the health of the province. The winning community carries the title for a full year.

UBCM is not aware of existing provincial accessibility awards in BC, however some local governments, such as Coquitlam, have offered their own accessibility awards to highlight local business and community initiatives aimed at improving accessibility.
