Dear Ms. Nelson-Smith:

I regret the delay in replying to your letter regarding mail delivery to the Queen Charlotte Islands. Please be assured I understand very well your concerns about mail delivery to the Islands. Our Operations team has been addressing this situation for quite some time. We remain committed to providing the Island residents with excellent postal service and meeting our published delivery standards. For the most part, this will be through the BC Ferry Services.

As you know, we established two contingency transport plans last winter to address ferry delays caused by severe weather conditions. We transported via air any available Lettermail and Courier items awaiting dispatch from our plant in Vancouver if there was a delay with the BC Ferries of more than 24 hours and uncertainty as to the next scheduled crossing. This plan remained in effect until the beginning of June, coinciding with the start of the summer ferry schedule and the increase of the ferries' frequency of crossings between Prince Rupert and Skidegate. In conjunction with these schedule changes, we adjusted the other components of our ground transportation network to increase the transport frequency of mail to the Queen Charlotte Islands by one or two days during the summer months.

We also decided, after a further review, to continue our second contingency plan for the delivery of government services cheques. We transported via air all government services cheques to residents on the Queen Charlotte Islands. We are monitoring this situation to ensure the monthly delivery of these items remains a practical undertaking.

I wish to confirm that Canada Post did review the transportation of mail to the Islands through other airlines, including Pacific Coastal. Pricing is based on the projected weight of the mail and the requirement to guarantee the space on the carrier. These costs are incremental to the costs of maintaining our existing surface mail transportation network. Given this and other factors, we determined that supplementing our transportation network with another carrier is not a practical option.

Thank you for sharing your concerns with me. We will continue to work hard to provide a high level of service to residents on Queen Charlotte Islands.

# Council Members:

Thanks for looking into my issues regarding high-speed internet access. I am happy to know that this is concern for someone other than just me.

I will let quislands.net know that I am interested in their equipment.

That being said, though, it is rather frustrating that as a resident of Port, I am again on the bottom of the local priority list. We still don't have cell phone access. Our new hospital that we are a one-third partner in is further away than the one it replaced. We pay the same rates for internet as Queen Charlotte and they get over ten times the internet speed. (90Mbps vs. 6.8Mbps). Even Tlell gets more bandwidth. If GwaiiTel got the same \$50,000 in funding from the BC Government for Port in the first round of the Connecting Citizens Grant Program as the other communities of Haida Gwaii, why do I have to settle for less service and pay EXTRA for access to a governmentally funded infrastructure program? The GwaiiTel web-site says that tour local ISP's pay the same or a lesser than the rest of the province for access and yet the monthly customer rate is higher here than even Prince Rupert. I also see that GwaiiTel was conditionally approved for funding from Industry Canada on May 9<sup>th</sup>, 2010 for 884 more household connections. Why can't Port get another tower if the federal and/or provincial government is paying for these improvements? Who is getting this money? As of April 8th, 2010, funding for GwaiiTel was promised in the amount of \$100,000 for the Masset/Old Massett area for last-mile connections and they already have TWO ISP's competing for service. It's little wonder that the population of our community continues to decline. I understand that Mr. Pazarena has the right to make money as a business, but there are large sums of public money being spent on infrastructure to ensure that everyone here has the same ability to access high-speed internet, no matter where they live. I don't expect something for nothing, I just want the same opportunity as others receive.

I think that since the Village of Port Clements is a partner in the GwaiiTel society, we should be getting equal value for our money and that our ENTIRE community should receive the same opportunity for access as anywhere else on the Islands at the same price.



# ADOPTION AWARENESS MONTH

The Government of British Columbia has proclaimed November as Adoption Awareness Month. The Ministry of Children and Family Development is taking this month-long opportunity to raise awareness about children-in-care who are waiting for an adoptive home, and to recognize adoption as a valued way to build a family.

# KEY FACTS

- Children in the permanent care of B.C.'s Ministry of Children and Family Development may be placed for adoption through the ministry. Permanent care occurs when the courts have determined that the child cannot return to the care of their birth parents(s) and a Continuing Custody Order has been granted.
- For children in continuing custody the ministry makes plans for permanency. These plans can include:
  - > Adoption (including foster caregiver adoption: long-term caregivers are encouraged to adopt).
  - > Transfer of custody: this transfers custody of a child to someone with a significant tie to the child.
  - > Ensuring a child has life long connections with significant adults in their lives if adoption or other permanency options are not in the child's best interest.
- An average of 300 children find permanent families through adoption each year. Last year, 291 children- and youth-in-care of the ministry found permanent homes. Still, there are close to 1,200 children with adoption as their plan of care who are waiting for a permanent family.
- Many of the children available for adoption are school-age. They may be siblings who need to stay together. Some may have special placement needs due to difficult early childhood experiences, prenatal exposure to alcohol or drugs, learning delays, or other developmental challenges.
- Potential adoptive parents come from diverse backgrounds and have a range of life experiences.
   Anyone who is interested in providing a loving, nurturing home is encouraged to apply to adopt.
- The ministry strives to place children with families that preserve a child's ethnic and cultural heritage. As culture is essential to a child's positive identity formation and preservation, adoptive parents who reflect British Columbia's cultural diversity and adoptive parents who are willing to maintain life-long connections with the child's cultural community are needed.
- The number of Aboriginal children placed with Aboriginal families remains steady between 40 and 50 percent over the last five years an increase from the 27 percent it was in 2000/01.

# Provincial Industrial Property Tax Credit

Beginning with the 2009 taxation year, the Province of British Columbia (Province) introduced the Provincial Industrial Property Tax Credit (PIPTC), which entitled an owner of Class 4 (major industry) or Class 5 (light industry) property to a credit that reduced the provincial school tax payable on these properties by 50 percent. For 2011 and subsequent taxation years, this credit will be increased to 60 percent.

Sections 131.2 and 128(4) of the *School Act* provide for the PIPTC and require the credit to be presented on a separate line in the tax notice, marked clearly as a deduction from the amount of school taxes levied.

# Provincial Farm Land Tax Credit

In Budget 2009, the Honourable Colin Hansen, Minister of Finance, announced that the Province will provide a 50 percent Provincial Farm Land Tax Credit (PFLTC) for farm land (Class 9) properties. For 2011 and subsequent tax years, an owner of Class 9 (farm land) property is entitled to a credit that will reduce the provincial school tax payable on these properties by 50 percent.

Section 131.3 of the *School Act* provides for the PFLTC and requires that the collector of taxes for the municipality deduct the amount of the credit from the school taxes otherwise payable by the owner.

The Province has set out in legislation the manner in which the PFLTC is to be presented in municipal tax notices. Section 128 (4) of the *School Act* requires that property tax notices show the following:

- The total amount of school taxes levied on each property by the Province;
- The amount of any PFLTC to which the owner is entitled; and
- The net amount of school taxes payable after the deduction of the credit.

Similar to the PIPTC and to ensure full compliance with the legislation, we recommend that the PFLTC be presented on a separate line in the tax notice, marked clearly as a deduction from the amount of school taxes levied.

# Northern and Rural Area Home Owner Benefit

As announced in Budget 2009, a Northern and Rural Area Home Owner Benefit (NRAHOB) of up to \$200 will be available for the 2011 and subsequent tax years. To be eligible for the benefit, the home owner must meet the requirements of the basic and/or additional Home Owner Grant and the property must be located in the Province, but outside the Capital Regional District, Greater Vancouver Regional District and Fraser Valley Regional District.

In accordance with section 10(1)(a) of the *Home Owner Grant Act*, the collector of taxes for the municipality must insert the amount of the grant and the amount of tax remaining due after deducting the grant from current year taxes on the tax notice. With the addition of the NRAHOB, municipalities within the eligible areas will need to make the following changes to their tax notices as specified by the Minister of Finance:

- Include the amount of the NRAHOB in the amount of the grant shown on the tax notice;
- Amend the wording of the grant amount line from "Home Owner Grant" to "\*N&R Home Owner Grant"; and
- Include a note at the bottom of the notice that reads:
  - \*N & R Home Owner Grant is the longstanding Home Owner Grant combined with the new Northern and Rural Area Home Owner Benefit of up to \$200 that is available in northern and rural areas.

It is also important to note that the NRAHOB is still subject to the existing minimum tax threshold and grant phase-out provisions.
