You have probably been seeing a lot of material floating around about the **Official Community Plan** over the past 9 months.

Staff, Council and interested public have been working on creating an updated plan since June of 2012 and we are at our 5th, and hopefully last, revision of the plan.

The updated plan is available on our website or at the Village Office for the public to review.

This is your last chance to have input into the plan.

The Official Community Plan Bylaw will go before Council for first reading at the March 18th Council meeting.

Anyone with concerns or comments about the plan should contact the office prior to the end of February so that your thoughts can be considered when the Bylaw is being finalized.

Just so you know, once the Bylaw is in place it doesn't mean that we can't make changes to the plan if necessary. Official Community Plans and Zoning Bylaws are two types of Bylaws that are quite secure in nature meaning that it requires public consultation in order to amend them but this does not mean that they can not be amended should important information come to light at a later date.

The Official Community plan is a living document and will be reviewed via a public process approximately every 5-6 years.

The Village application for a piece of Crown Land in the Industrial Park for the fa-

- cility has been tentatively approved
- The Village has completed an Archeological Impact Assessment of the area
- MIEDS & The Village were successful in an application to Northern Development Initiative Trust for \$20,000 towards a business plan for the project
- The Village has applied to Gwaii Trust for additional funds for the business plan
- The business plan will be completed by the end of February—this will give us the necessary information to plan our next steps.

# **Utility and Property tax balances**

Please be advised that any outstanding amounts on your utility account as of December 31, 2012 have been transferred to your property taxes as arrears and began accumulating interest as of January 1, 2013.

201 2 Property tax amounts outstanding as of December 31, 2012 have been transferred to arrears and began accumulating interest as of January 1, 2013.

Any balances that were in arrears as of December 31, 2012 have been transferred to delinguent.

Property tax accounts which have a delinquent balance as of September 13. 2013 will be advertised in the Observer for the 2013 tax sale which will be taking place on Monday September 30, 2013 this year.

# Parking at the Multi **Purpose Building**

Please refrain from pulling into and parking in the only disabled parking space located that the Multi purpose building. It has become an issue with people using it as a drop off spot for visiting the library and the school. There is plenty of parking available and this spot should not be abused. This spot is also governed by the RCMP and carries a 109.00 dollar fine for improper use.

In addition this space should also not be blocked.

## Some info on Taxes

How are taxes calculated? The formula for calculating taxes on property is tax rate times assessed value. The tax rate is expressed as a dollar amount on every \$1.000 of assessed value. If the tax rate for residential property is 4, this means that taxes of \$4 are charged on every \$1,000 of assessed value, Property valued at \$100,000 would thus be charged taxes of \$400 (100  $\times$  \$4).

The British Columbia Assessment Authority determines the assessed value of property for tax purposes. The Authority is established under provincial legislaity. The Village is not involved in determining assessed values. Taxation on property is a primary source of municipal revenue. The provincial *Community* Charter sets out in detail the

regulations for property taxation. The amount of money to be raised through taxation is set by Council through the budget process. Other aspects of the taxation process, such as the due date for taxes and the penalty on late taxes, are regulated by the Community Charter. Council does not have the authority to adjust the taxes on individual properties. The taxes are set by the tax rate which applies to that class of property. For instance, if the tax rate for residential property is 4, then all residential properties must be charged this rate.

tion and is independent of the municipal- What is included on my annual Tax Notice? Tax Notice includes ALL property taxes - those imposed by the District and those imposed by other governing jurisdictions. School Tax, Hospital, Regional District, BC assessment,

MFA and VIRL (Library) are collected by the Village and then remitted to the appropriate authority.

These tax levies are not set by the Village of Port Clements but are collected by the Village on behalf of those governing jurisdictions. This is more efficient and economical than each of these tax authorities sending individual tax notices. Port Clements Council sets the rates for District taxes only.

The annual Tax Notice has the Home Owner Grant Application form attached. This form must be completed EACH YEAR to claim the grant, if eligible.

If you are 55 or older you may qualify to have your property taxes deferred or if you are unable to pay your taxes you may qualify for the Hardship Property deferment program. Drop in or call the Office for more information.
