### **IS OUR WATER SAFE?**

. . . . . . . . . . . . . . . .

Recently there were concerns raised about trihalomethanes (THM) in our water supply as a result of our chlorination process. This article shows our levels as compared to the Drinking Water Safety Guidelines (DWG) and outlines some information provided to us by Northern Health who hold our permit for the supply of drinking water. Drinking Water Guidelines indicate that 100 ug/Litre is the safe allowable limit. Below are our limits first at the water treatment plant and second at the end of Bayview south.

July 2010	50	68
March 2011	39	45
Nov. 2014	24	29

As you can see our numbers decreased significantly after the water plant upgrade but have always been well within the safe limits.

### What are chlorinated disinfection by-products?

Chlorinated disinfection by-products are compounds that can form when the chlorine used to disinfect drinking water reacts with naturally occurring organic matter (e.g., decaying leaves and vegetation). Disinfection is an essential component of public drinking water treatment.

The health risks associated with disinfection by-products are much less than the risks from consuming water that has not been adequately disinfected. There are many types of

chlorinated disinfection by-products (DBPs); the most common of these are

trihalomethanes (THMs) and the haloacetic acids (HAAs).

### Aren't disinfection by-products a health concern?

All chemical disinfectants used in drinking water can be expected to form disinfection by-products,

which may affect human health. However, scientific data show that the benefits of disinfecting drinking water are much greater than any health risks from disinfection by-products. While



every effort should be made to reduce concentrations of disinfection byproducts to as low a level as reasonably achievable, any method of control used must not

compromise the effectiveness of disinfection.

# What are the possible health effects from THMs in drinking wa-

Some studies suggest a link between reproductive effects and exposure to high levels of

THMs. However, an increase in the concentration of THMs could not be linked to an increase in risk, suggesting the need for more research. THMs have been associated with slightly elevated levels of bladder and colon cancer, but no direct link has been determined.
