## **Emergency Planning Committee Update**

The Port Clements Emergency Planning Committee, in conjunction with other island entities, held a training session in Port Clements on January 21 & 22 in regards to Planning for Community Disaster Recovery. 11 people from Port Clements and other communities had an opportunity to meet, train and brain storm around Emergency Management on Haida Gwaii and Disaster Recovery in particular.

Community Disaster Recovery has many different connotations. It is often viewed as the method by which a community is returned to normal - or the new normal as things may never actually get back to the way they were prior to the emergency (only 70% of people evacuated from New Orleans in 2005 have returned as of 2015). Canadian Standards Association defines it as activities and programs designed to return conditions to a level that is acceptable to the community following an emergency or other event. Emergency Management BC defines it as community actions to limit losses, reduce suffering, and restore the psychosocial and economic viability of the community. Recovery actions can extend for years after the incident itself.

One important element to instill in the Disaster Recovery plan is to ensure that if you have to replace things that have been lost due to an event that you think in a holistic manner. This ensures that what you replace is designed in such a manner as to lessen the impact should a similar emergency happen again in the future - rebuild better so that you are building resilience as well as replacing a piece of infrastructure.

Short term recovery typically involves activities such as assessing damage, establishing a public information system, providing temporary housing and securing safe food, water and sanitation. Long term recovery is marked by a gradual return to normal routines and restoration of the community's social fabric along with the structural repairs of infrastructure damaged or lost. Long term recovery should include improvements that promote sustainability and resilience for the community.

As a result of this course Port Clements will be updating our Emergency Plan to create a more robust section covering the recovery portion of Emergency Management. The updates will be incorporated into the plan for our November 2017 annual review of our policy.

Our Emergency Management committee generally meets guarterly. Port Clements is also part of the All Island Emergency Committee which meets twice per year. Anyone interested in learning more about the Village's Emergency Planning Committee is welcome to call, drop by or email us with questions or to request to be notified when the next meeting will take place.

# New Dog Bylaws

As of January 1, 2017, Dog Bylaws No. 434 & 435 come into effect. All Port Clements residents will be required to license their dogs. A one-time fee of \$15 which will include a tag number being assigned to the dog. After initial licensing, owners can purchase a replacement tag for \$5. The following fines will be issued for the following:

# Pet Owners Responsibilities & the Law

Our office has been receiving several complaints about pets wandering the community. Other than receiving fines enforced through our new Bylaws 434 & 435, pet owners should be aware that there could be civil and criminal liabilities associated with their pets.

A CIVIL LIABILITY occurs when the pet, when not under control of the owner, causes damages to another person or a person's property. Such damages could be from a vehicle striking the pet on the road/highway, a pet attacking someone else's pet, a pet attacking a person or a pet destroying property.

A CRIMINAL LIABILITY occurs when a pet has killed or injured a person. If a pet owner allows their pet to wander in the community the pet owner, if convicted, could face a jail term of up to life imprisonment. In a case where a pet has injured a person the pet owner, if convicted, could face a jail term of up to 10 years in prison.

This potential bylaw will impact **ALL TREES** within the municipal boundaries of Port Clements. Currently there is no bylaw that addresses managing trees within the municipal boundaries. Therefore, this bylaw could be used to identify and manage Heritage Trees as defined by the bylaw. Trees identified will be provided protection measures and limited alteration measures dependent on the permission granted through the VOPC. The potential bylaw would also be enforced through fines.




