Grant Application for Sunset Trail Improvement Project

#### **BACKGROUND:**

Sunset Trail is approximately a 2 km trail located within Sunset Park was constructed during the year 2000. This trail is constructed of crush rock and has 6 bridges.

## **DISCUSSION:**

Councillor Gould proposes that Council invests more money into maintaining the RV campground and Bird tower. Proposed works would be to brush out and bringing fill in to cover areas that often have standing water. Council can apply for grant money to help cover the costs with re-decking the bird tower, upgrading the stream crossings along the trail and fixing portions of the trail by removing brush or improving the trail running service. Originally, Council agreed to apply to the Rural Dividend's funds for this project; however, the Province reallocated those funds to address the forest industry crisis in 2019.

Councillor Gould now proposes that Council submits a smaller application for a \$100,000 project to the Major Contributions Grant which is due January 23, 2020 at 4 PM. The grant application must be a minimum of \$50,000 application with a minimum of 50% equity requirement. This program supports applications revolving around all levels of community infrastructure and planning. The goal of these projects should be building safer, healthier, more attractive and desirable communities, respecting and incorporating culture where appropriate, in an effort to enhance everyone's lifestyle. The eventual goal is to make the communities at large a more desirable place to work, live, play, and visit. The Sunset trail meets many of these items and the proposed matching funds would need to be partly funded by the Community Works Fund ("Gas Tax Fund"), the Northern Capital & Planning Grant and brushing/clearing would have to be covered by Municipal reserves or through the Major Contributions grant shared cost. The 2020 budget has not been approved yet; however, Council can apply for grant money to help cover the costs with re-decking the bird tower, upgrading the stream crossings along the trail and fixing portions of the trail by removing brush or improving the trail running service.

Applying for this fund will require Public Works to monitor the contract and the CAO to administer the contract and reporting. If Council permits this application and funding is successful, it would limit the amount of other Council strategic initiatives for the 2020 year.

## **CONCLUSION:**

The Sunset trail project costs approximately \$100,000 of which \$50,000 will be received from the Major Contributions Grant if Gwaii Trust Society approves the funding application. If successful in the application, Council would be required to commit a minimum of \$50,000 towards the project and these costs would need to come from the Community Works Fund, the Northern Capital & Planning Grant and possibly from Municipal reserves.

The trail has grown more popular since it was extended in 2017 so that it leads to the exhibition grounds of the Port Clements Museum. It has also become the venue for an annual 6 km running race during Port Clements' Canada Days.

The project will also strengthen Port Clements' ability to market itself as a tourist destination, which benefits the local economy by increasing stays at Sunset Park Campground, local hotels and B&Bs as well as by increasing use of local grocery stores, restaurants, and other services. The project also restores a trail that brings visitors to the Port Clements Museum, one of the town's key attractions.

# Notes on the Annual Allowable Cut Determination

In the paper provided by the HGMC November 15, 2019 the results of the recent Timber Supply Review are summarized, as well as the current Tenures and recent forestry related activities on Haida Gwaii.

The base case scenario describes the assumptions used in modelling the base case, and the document provides estimates of the impacts of several known alternative assumptions to the overall harvest levels recommended. Basic assumptions include adherence to the current Land Use Order, the Reconciliation Protocol established with the Province, the various Protected Areas, Cedar Stewardship Areas, etc. This scenario results in a reduction in AAC from 940,2430m3/year to 842,781m3/year, a reduction of 10.3%, which would be required to maintain a stable volume of harvest into the future providing no further constraints on harvest are introduced.

Concerns the Village of Port Clements has regarding the set of assumptions used to construct the base case scenario are:

- 1. The assumptions are only assumptions and do not consider either future restrictions or the ability of forest companies to extract value from areas currently identified as non-economic. Examples are the table on page 22 of the Discussion Paper which shows the impacts of assumptions around goshawk populations that could impact harvest by up to another 18.2%, or the experience around the timber supply to the Abfam mill which was considered uneconomic in the 1970's but now would generate significant bonus bids. Even with planning as detailed as this set of reports the future is uncertain.
- 2. The assumptions around community goals, which we hope will be addressed by this public review.
- 3. The contribution to the economy of different tenure types and their specific impact on the total forestry sector contribution to local and Provincial economies.
- 4. Allowances for the impact a community forest will have on the TSA.
- 5. Rotation periods need to be managed to maintain the value of our forests in the long term. With different areas and different forest types requiring different rotation periods, we will have to adapt on a more site-specific basis. It will be difficult to plan a long-term stable cut within the TSA, as it encompasses multiple biological and geographic regions and is accessed by multiple operators.
- 6. Sustainable harvest of Cedar. Western Red Cedar is the driver of our forest industry on Haida Gwaii, and it seems unlikely to change in the foreseeable future unless we accept pressures to overharvest that resource now by telling ourselves "the other species will be



worth more in the future". While that might be true, costs may also be higher, and we will still need the value of the Cedar to make our forestry economically sound. Harvest of Cedar should be regulated as a percentage of cut in each partition, and carry with it the requirement to harvest the balancing amount of other species, so if the cut in a jurisdiction is 200,000 m3, and the allowable Cedar cut is set at 40%, there would be a Cedar cut of 80,000 m3 and a cut of 120,000 m3 of whitewood before further Cedar could be taken. The purpose of this would be to stabilize employment to more continuous operations and encourage the search for higher value uses for our whitewood.

In assessing the total impacts to the Village of Port Clements and the Province of BC we need only to look at the impacts the recent changes to the forest sector have had on our economy. The population of Port Clements has seriously declined in almost direct proportion to the availability of timber sales within the TSA. A constant supply of about 200,000m3/year supported several small contractors and set a fairly high bar for the value of wood, which in turn caused the area-based tenures to have an increased value assigned to their extractions. It helped the transition from large operations with integrated logging and milling towards custom cut operations that currently can produce high value from the resource. There have been no studies on what an optimum level of cut is for these market-based operations, but there is clearly a floor below which this system cannot operate as recent job losses clearly demonstrate.

The TSR applied to the area of the proposed Community Forest resulting in a 39.6% reduction highlights the effects of what more detailed analysis may cause in some specific areas. In the TSA as a whole, a large reduction could leave the market-based sector with a cut that is not sufficient to maintain local operations. This would leave cost determinations for other tenures with inadequate or wildly skewed data and reduce both employment and revenue to the Province both directly and indirectly. It would destroy the ability of smaller operators to maintain the personnel and equipment needed to conduct responsible forestry and leave us with inadequate, underfunded, and ultimately unsafe operations on Haida Gwaii. And it could well be the death of Port Clements as a Village, erasing 100+ years of working people making a living here.

In conclusion, the Village of Port Clements would recommend that the HGMC apply the base rate calculation with adequate provision for the maintenance of sustained Cedar harvest. We would also recommend that any future reductions in the AAC be subject to demonstration that such reductions will address a specific goal, and the proposal include planning for monitoring and reporting on the effects of the change. If these changes are not accomplishing anything, include a sunset clause that eliminates them. And further, that when the Chief Forester and the minister meet over the AAC, the Minister review all tenures and adjust so the allotment to market logging is not further reduced, but cuts are derived from other tenure classes.
