Highlights

New grants

Haida Gwaii COVID-19 Emergency Response Grant (New)

Gwaii Trust Society

Expected range of \$1,000 to \$25,000, no equity and no cap (\$250,000 budget)

Open intake

- Funds local governments and non-profits
- For projects that keep Haida Gwaii people safe, healthy, fed, sheltered and connected during the pandemic
- Not for capital projects
- Priority goes to residents who are vulnerable or have financial need
- Partnerships encouraged

Grants with COVID-related changes

FCC AgriSpirit Fund

Farm Credit Canada \$5,000 to \$25,000

April 10, 2020 (Extended)

- Funds infrastructure or sustainability projects in rural communities
- Local governments and non-profits that partner with them can apply, so long as they've not received AgriSpirit funding in four years
- Often used for fire equipment

Social Connectedness Grants

Plan H

Up to \$5,000 (15 available in B.C.)

July 15, 2020 (Extended)

- Offers up to \$5,000 for projects that improve social connectivity and involve partnerships between local government, the regional health authority, and community stakeholders
- Preference goes to projects that seek equity, address the social determinants of health, and aim to have a lasting effect

2020 Healthy Communities Grants

Plan H

Up to \$25,000 (Five available in B.C.)

July 15, 2020 (Extended)

- Offers up to \$25,000 for health-focused projects that feature equitable public participation
- Preference goes to projects that seek equity, address the social determinants of health,
 and aim to have a lasting effect

IMAGINE grants

Northern Health Authority
Up to \$5,000

April 10, 2020 (Extended from March 31) and September 1

- Funds lasting community projects in nine areas (healthy eating and food security, physical activity, injury prevention, tobacco-free communities, positive mental health, prevention of substance harms, healthy early childhood development, healthy aging, healthy school action)
- Open to a long list of community organizations and local governments
- Preference to projects that involve partners

Regional Community to Community Forum Program

Union of B.C. Municipalities

Up to \$5,000 and 50% of project cost

Sept. 4, Dec. 4 (April intake cancelled)

- Funds Regional C2C Forums, which aim to increase understanding and improve overall relations between First Nations and local governments.
- Forums are not limited to a pair of neighbouring communities an all-islands forum that includes Haida and civic communities would be eligible.
- Eligible applicants can apply once per intake.
- Suggested topics include reconciliation, emergency management, service planning, economic development, community development, and infrastructure planning.

Grants upcoming

UBCM Asset Management Planning Program

Union of B.C. Municipalities

Up to \$15,000 and 50% of project costs

Applications reviewed April 24, 2020 and Sept. 11, 2020

- Helps local governments fund asset management plans, long-term financial plans, corporate capacity assessments, risk assessments
- Does not cover routine planning, feasibility studies, or capital assets
- Funding permitting, UBCM will also offer subsidies for asset-management training in 2019

Evacuation Route Planning

Union of B.C. Municipalities (Part of B.C. Community Emergency Preparedness Fund)
Up to \$25,000 in 100% funding

Due April 17, 2020 (Notice in 90 days)

- Funds local governments to do evacuation-route plans
- Eligible costs include mapping, test exercises, amendments to existing plans, presentations as well as consultant fees, staff and public info costs
- Emergency Management BC scores applications in a technical review higher scores go to applications that can show, among other things 1) evidence of local hazards, threat levels, and previous evacuations; 2) challenges to evacuation; 3) consideration of large-scale scenarios (see guide for full list)

Canada Post Community Foundation

Canada Post

Limited to \$5,000 for school/PAC/sports team/rec facility projects, otherwise \$25,000 May 28, 2020

- Open to schools, sports equipment okay
- Project should expand capacity rather than maintain a program
- Highly competitive

Port Clements follow up - questions from April 9 call with Minister Robinson

This message is being forwarded to you on behalf of Nicola Marotz, Strategic Advisor, Local Government, Ministry of Municipal Affairs and Housing

Dear Mayor Daugert,

Thank you for Port Clements's participation in Minister Selina Robinson's April 9 regional call with mayors and chairs regarding Covid-19 issues and impacts.

During that call, Port Clements raised the issue of whether the province is considering doing more testing for COVID.

The following is an excerpt from the updated COVID Testing guidelines http://www.bccdc.ca/health-professionals/clinical-resources/covid-19-care/lab-testing found on the BC Centre for Disease Control website. The guidelines outline recommendations for testing in specific settings and circumstances:

- Testing is available for all patients who need it, but not everyone requires a test. Testing is not required if a patient
 has no symptoms, mild symptoms or is isolating at home because they are a contact of a confirmed case or a
 returning traveller.
- At this time, any physician or nurse practitioner can order a test for COVID-19 based on their clinical judgment.
 Individuals can also be referred for testing by calling 8-1-1. Testing should be focused on individuals for whom the results will change the clinical care they receive or the public health management of their case.
- Broadly, testing is recommended for groups that are more vulnerable to complications due to COVID-19, or people
 who care for these vulnerable people.
- . B.C. is currently testing those with new respiratory or gastro-intestinal symptoms who are:
 - 1. Residents and staff of long term care facilities
 - 2. Patients requiring hospitalization, or likely to be hospitalized including pregnant individuals in their 3rd trimester, patients on hemodialysis, or cancer patients receiving radiation or chemotherapy.
 - 3. Part of an investigation of a cluster or outbreak.
- COVID-19 testing is also recommended for individuals with a fever and a new (or worsening) cough or shortness of breath who are:
 - Health Care Workers
 - Residents of remote, isolated or Indigenous communities
 - People living and working in congregate settings such as work-camps, correctional facilities, shelters, group homes, assisted living and seniors' residences
 - · People who are homeless or have unstable housing
 - Essential service providers (e.g. first responders)
 - Returning travellers identified at a point of entry to Canada.
