9. REPORTS & DISCUSSIONS

Mayor Daugert: Attended two teleconferences with the Protocol Table. One being a letter describing actions they wish to take to keep Haida Gwaii safe from COVID-19. Another letter was to Premier Horgan, which he was not invited to, which he identified his exceptions to – concerned that it was asking the Premier to intervene in a Federal matter, and did not seem to be an appropriate way to get a meeting with the Premier.

He also attended a teleconference for the NCRD meeting which deal with COVID-19 and discussion on the Provincial Campground at Sheldon Bay. NCRD had reached out to the Province requesting about upgrading and maintaining the road to Sheldon Bay, but the Province said they could not do anything as it was part logging road. The logging companies identified that they were not in the business of supporting Provincial sites. Various parks also said that they have nothing to do with it. So, everybody dodged taking it on. This was disappointing as they have a campsite with a road where incidents of logging have left it almost non-accessible to traffic. The NCRD is pursuing it and asking why they have a Provincial Campsite, why the

Province does not strike an arrangement with the logging contractor to maintain the road as it is an essential part of the campsite to be able to get there.

There were a lot of 'No' letters at this meeting. The Oona River Community Hall Upgrades and the First Nation Kitchen Site were rejected as the grants were oversubscribed.

Attended a lot of calls on COVID-19 and for information.

Councillor Kish: Nothing to report.

Councillor Gould: Attended VIRL meeting via Zoom. They are looking at answering a lot of questions, looking at their options at providing services to small communities and exploring drop-offs and other activities that other libraries are undertaking. Their online services have seen a 200% increase and they are aiming to streamline it further.

Councillor Cumming: Participated in the budget meetings.

Councillor Falconbridge: Attended budget meetings, spent lots of time studying COVID-19 reports from around the world and reading up on Provincial and BC Health Services daily updates on the situation as well as the local regulations, such as from CHN.

CAO Decock: Moving forward with COVID-19, still operating EOC at level 1. During this whole new business structure, we are still evolving on how we will move forward and how it is going to look like — it is still uncertain. Still trying to figure out how to move forward with Unified Command, the All-Island Haida Gwaii Emergency Operations Centre. As we work together with those communities we are dealing with transportation of off-island workers to our community as there are specialty services and dealing with other requests from the community if we get one. For example, a recent traveler who came to our community.

Regarding professional development she has completed one of the requirements - 7 habits for effective management and am working on implementing that training. Also working on completing some of the performance improvements tasks as identified by Council.

Also, busy with the budget. Going forward will move on to taxation and that will require figuring out and applying the new ministerial orders. There is a new tax due date for penalty application. Business property classes will need to have a later date of September 30th, so we will need to figure out how this will look for these businesses when printing off the document. Teaching our Finance Manager how to do this with these new rules.

The next thing is to complete the Annual Report. We can submit our bylaws before the May 14th deadline. We still have an extension until the end of June to do it, but we met it ahead of time. Digital reporting requirements may be one of those things that will need an extension – not sure, not sure how difficult it is to get this information from our accounting software in reports for BC Assessment.

The Annual report. Wanted to identify that our auditor is still working on our financial audit and it is still to be approved. We have an extension on it as well – the extension was given across the Province. Due to the travel restrictions our auditor opted not to come to Haida Gwaii for safety. Once approved we will have it ready for Council. He has not given an ETA on when it will be complete.

Lots of changes with COVID-19 as they come along and how we operate as a municipality. Trying to figure out how to provide services at a local level, while assisting Northern Health and EMBC.

We did get approval for our office improvement project to build new shelves, cupboards, and counter space in the main office and in the storage room. She was able to get more quotes and track down more carpenters.

Re: Checkpoint Incident and Isolation of Elected Official

Thank you for notifying our Council of the interactions that occurred between Councillor Kazamir Falconbridge and the Skidegate Checkpoint on Thursday, April 30, 2020. As our Council wants the Haida Gwaii State of Emergency — Emergency Measures to be adhered to, this issue was discussed at the regular Council Meeting held on May 4, 2020.

Councillor Falconbridge identified that he had read the Haida Gwaii State of Emergency document that was published on April 1, 2020 to ensure he was going to follow the emergency measures that are in effect on Haida Gwaii. The order states the following about Self-Isolation:

"SELF-ISOLATE WHEN RETURNING FROM TRAVEL Everyone returning to Haida Gwaii from any location must self-isolate for 14 days upon returning. Those coming to Haida Gwaii to conduct essential service work are exempt if self-isolation is not possible and they do not exhibit COVID-19 symptoms. Essential service workers must follow physical / social-distancing measures and hygiene guidelines."

Also, the notice identifies essential service work includes ambulance services. Councillor Falconbridge is a BC Ambulance essential service worker. As we understand, Councillor Falconbridge was operating under his interpretation of the Haida Gwaii State of Local Emergency document and identified to the checkpoint that he will follow the order but will not self-isolate because he is an essential worker and will follow the order as it is written.

Consequently, Councillor Falconbridge's response caused concern to Unified Command (we are not sure what was said or what actions were taken by Councillor Falconbridge or the checkpoint staff). We do not want this type of misunderstanding to happen again.

To avoid this we would like to see clarification with the Haida Gwaii State of Emergency document that addresses local essential service workers who may have to leave and return to Haida Gwaii. We feel that such clarification would be helpful for the checkpoint workers as well as for all residents of Haida Gwaii. We are hoping that this will result in the desired compliance of self-isolation and physical distancing measures to reduce the impacts of the Covid-19 pandemic for all who live on Haida Gwaii.

We also hope that moving forward, if a similar incident like this occurs, we ask that our EOC is notified the same day it occurs rather than several days after the fact. That way we can immediately respond and address the issue within our community.

BACKGROUND:

In 2014, local governments of Northwestern BC formed the Resource Benefits Alliance to negotiate a new funding agreement with the province to ensure that Northwest benefitted from the economic development activity in the region.

In 2019, the BC Government funded \$100 million to Resource Benefit Alliance communities, which the Village of Port Clements received \$2.085 million to conditionally fund Northern Capital and Planning.

DISCUSSION:

In May 2020, the BC Government announced that it will be investing another \$75 million to the Resource Benefit Alliance of which \$50 million was provided directly to local governments to help address their infrastructure needs, which the Village of Port Clements has received \$338,000.

To date, the total amount of funds received is \$2.423 million. The conditions of this fund are limited to planning or capital projects. The following table provides a list of deposits, expenses and committed funds to be used for future capital projects.

Although the BC Government did share revenues from resource development activities within the Northwest, the Northwest Resource Benefit Alliance continues to work to obtain a community-specific benefit agreement for a continual shared benefit related to resource development for the region.

CONCLUSION:

The Village of Port Clements has received \$2.423 million for the Northern Capital and Planning Grant from the BC Government to assist with social and infrastructure needs that arise out of the economic developments within the Northwest. Of this fund, \$273,838.51 has be used for the Sewer Lagoon expansion and fire hall re-enveloping projects. Council has committed \$1,008,450 of the fund towards the Sewer Lagoon expansion project.

Province invests in northwest economic development, healthy communities

VICTORIA – The Province is further investing in B.C.'s North to support healthy community growth during major resource development and build infrastructure to meet the needs of people in the region.

"Northern B.C. is rich in natural resources, but its strongest asset is its people," said Premier John Horgan. "We are proud to work in partnership with northern communities. These funds will help address the social and infrastructure needs that arise out of the many exciting economic developments underway in those communities. We are investing in northern jobs, roads and public services — and most importantly, in northern people."

The Province is investing a total of \$75 million through two programs:

- The 2020 Northern Capital and Planning Grant provides \$50 million directly to local governments to help address their infrastructure needs and as they prepare for major resource and economic development.
- Another \$25 million will be available to communities as they prepare for major economic
 development through the B.C. Northern Healthy Communities Fund, which will be administered
 through the Northern Development Initiative Trust. The fund will be available to local governments,
 First Nations and non-profits in the region to support local delivery of critical services, such as health
 and mental health care, housing and child care.

"The need to invest in northern B.C.'s infrastructure and community services is vital, and this funding has a new and significant role to play in contributing to our province's economic recovery, especially in light of COVID-19's impacts on B.C.'s people, communities and economy," said Carole James, Minister of Finance.

This funding is in addition to \$100 million provided through the Northern Capital and Planning Grant to communities in the northwest in 2019. It is part of ongoing dialogue between the Province and B.C.'s northwest and north-central communities on how to support the region over the longer term.

"People are at the heart of strong, resilient communities and this funding is part of our continued commitment to invest in the hard-working people of the North," said Selina Robinson, Minister of Municipal Affairs and Housing. "We have been listening to northern communities about their need to be ready to seize the opportunities presented by expected growth and resource development. With this funding, they will be able to plan to tackle both the infrastructure and socio-economic needs their communities are facing."



The Northern Capital and Planning Grant and the B.C. Northern Healthy Communities Fund will contribute to a resilient B.C. economy and will complement the \$1.5 billion set for economic stimulus as part of B.C.'s COVID-19 Action Plan.

Quick Facts:

- Through the Northern Capital Planning Grant, eligible local governments can expect to receive the following based on their populations and base assessments:
 - Municipalities with more than 8,000 people will receive between \$5.2 million and \$6.6 million.
 - Municipalities with fewer than 8,000 people will receive between \$300,000 and \$3.7 million.
- Regional districts will receive between \$400,000 and \$1.6 million.
- The B.C. Northern Healthy Communities Fund will be distributed by the Northern Development Initiative Trust through an application process.
