**Dear Mayors and Chairs:** 

Thank you for taking the time to join Minister Josie Osborne and Minister Lisa Beare for the May 2021 regional calls. As Minister Osborne and Minister Beare said, these conversations continue to be a great opportunity to hear from you about the key issues and opportunities that you are working on in your communities. This email answers some of your questions and details links and resources for some of the topics raised.

The May 2021 calls were focused on connectivity. Working to connect all people in BC – regardless of where they live – is a priority for our government. Communications technology in all its rapidly changing forms is embedded into all aspects of our day-to-day lives as it enables a broad spectrum of possibilities including access to healthcare, education, culture, public safety and economic activity, as well as day-to-day social interactions during the challenging times of the pandemic.

Building on the Province's most recent investments totalling \$180 million, Budget 2021 establishes stable base funding of \$40 million over the plan to further invest in the Province's connectivity strategy. This will provide better high-speed internet and cell coverage to help connect more people in rural areas and remote communities. (See more Budget 2021 highlights below.)

There were a number of themes that came up during the calls including inaccurate federal data on broadband internet speeds, cell coverage along highways, redundancy, and low earth orbit satellites (LEOS) as an alternative to ground infrastructure. Providing the same level of access, quality and affordability in rural and remote areas as in urban areas is a key priority for the provincial government and we are working towards that goal.

Communities have raised concerns that the federal data on broadband Internet speeds, which is used to determine eligibility for connectivity funding programs, may not accurately reflect the broadband Internet speeds experienced in homes, businesses, and other locations at the community level.

The Ministry of Citizens' Services, UBCM, and Northern Development Initiative Trust are responding collaboratively to these concerns with an <u>independent study</u> of differences between the broadband Internet speeds experienced in some BC communities, and the 50/10 Mbps speed identified on the federal government's National Broadband Internet Service Availability <u>Map</u>. The study which is underway, will produce factual information on Internet speeds in rural and remote communities, supporting analysis and informing dialogue between the Northern Development Initiative Trust, Indigenous and local governments, Internet service providers, the Province, and the federal government. Data gathering and analysis will occur over the spring and summer months, with reporting of study results expected in fall 2021.

A key step in this process is to identify which communities in BC have noted inconsistencies between the 50/10 Mbps Internet speed that federal maps indicate should be available, versus actual Internet speeds currently experienced by residents and businesses in the area.

Local governments with reports of Internet speeds lower than the 50/10 Mbps speeds shown on federal maps, are invited to self-identify by contacting Reiko Tagami, Policy Analyst, UBCM to request to be included in the study.

Local governments wishing to participate in the Internet speed study are encouraged to complete a <u>questionnaire</u>, providing contextual and background information about Internet speeds experienced in their community. For the purpose of this study, local governments can improve the accuracy and depth of the Internet speed data for their area, by having their residents, businesses, and other community stakeholders complete the CIRA Internet speed test. More information on the Internet speed questionnaire & performance data can be found <a href="here">here</a>.

#### **BC Budget 2021 Highlights**

On April 20, 2021, Finance Minister Selina Robinson tabled the 2021 provincial budget in the legislature. Budget 2021 includes significant new funding commitments of interest to local governments, including those for mental health and substance use; housing affordability and homeless populations; economic recovery; childcare, and broadband connectivity. Due to COVID-19 pandemic impacts, the budget projects deficits of \$9.7 billion this year, \$5.5 million next year, and \$4.3 million in the year following. For more information see provincial government's <u>Budget 2021</u> or <u>UBCM BC Budget Highlights</u>.

#### Mental Health Funding and Substance Use

The budget allocates \$3.1 billion over three years to improve health and mental health care, including \$500 million to continue to expand mental health and substance use services. \$330 million over the fiscal plan provide a full spectrum of substance-use treatment and recovery services, including \$152

million for opioid treatment. There will be 195 new substance use treatment and recovery beds in communities throughout the province to help more people get on a path to recovery.

#### Housing Affordability and Homeless Population

The budget provides additional funding to expand the HousingHub program to construct 9,000 more rental homes for middle-income house holds and families over the next 3-5 years.

In addition to continued investments in the Homes for B.C. Supportive Housing Fund, the Province is partnering with the federal government through the Rapid Housing Initiative to convert existing buildings into supportive housing, and to support development of modular housing to expedite housing solutions for homeless or other vulnerable populations.

The budget allocates funding to extend supports and services for people experiencing homelessness and includes funding to help maintain more than 3,000 temporary emergency shelter and hotel spaces that have been secured during the pandemic. Funding is also provided to extend the additional 650 urgent shelter spaces, rent supplements, and supportive housing sites used to support recent decampments efforts in Vancouver and Victoria, with on-site health and other supports.

#### Economic Recovery

Budget 2021 continues to prioritize investments that help BC respond to the pandemic and to prepare for a strong recovery. These investments build on the over \$10 billion that has been provided to support people, businesses and communities since the pandemic began. The budget provides a record \$26.4 billion in taxpayer-supported capital investments that are expected to create over 85,000 jobs over the three-year plan. These investments will ensure the right infrastructure is in place by making critical upgrades to hospitals, schools, and highway and transit projects.

#### Childcare

The budget included a \$233 million increase in base funding over three years for childcare to create new spaces. This will more than double the number of \$10-a-day childcare spaces and contribute to raising wages for early childhood educators. New federal funding will help BC to build on this commitment.

#### **Infrastructure Funding**

Public announcements for the Investing in Canada Infrastructure COVID-19 Infrastructure Resilience Stream are expected next month. We understand that you are all interested in finding out the decisions. Ministry staff are working with our partners at Infrastructure Canada to finalize approvals at this time. Please stay tuned for further announcements.

In addition, Budget 2021 includes provincial funding commitments of \$41 million over the fiscal plan, or \$247 million over the next six years to maximize federal contributions and continue to support local governments, not-for-profit entities and First Nations in accessing community infrastructure funding. The ministry will be communicating further details on the Investing in Canada Infrastructure Program (ICIP) application process for new intakes in the fall of 2021.

#### COVID-19 Update

The strengthened <u>province-wide restrictions</u> that came into effect on March 29 are still in place through to May 25, including that everyone should stay within their local communities. Travel restrictions for non-essential travel in BC are also in place until May 25. Read the travel restrictions <u>here</u>.

Dr. Henry stresses that although a high number of people are being vaccinated every day, it will take some time before all of us can let our guard down and right now, we all need to continue doing the things that prevent transmission of the virus.

#### **Vaccination Roll Out**

Dr. Bonnie Henry and Minister of Health, Adrian Dix, urge everyone to <u>register</u> online or call 1-833-838-2323 for vaccination as soon as possible. Getting vaccinated will help stop transmission and infections in vaccinated people are generally milder compared to those in unvaccinated people.

Starting today at 7 p.m. (Pacific time), booking invitations will begin for people who are registered and are born in 1996 or earlier (25 and up). On Saturday at 7 p.m., booking invitations will begin for people who are registered and are born in 2001 or earlier (20 and up) and on Sunday at 7 p.m., booking invitations will begin for people who are registered and are born in 2003 or earlier (18 and up). We encourage you to share this information with your residents.

#### **Home Owner Grant Centralization**

As a reminder, effective 2021 all home owner grant applications must be submitted directly to the BC provincial government through a secure online application. **Municipalities no longer need to and should not accept any applications.** There are no changes to program eligibility criteria.

Homeowners can apply for their current year or their retroactive home owner grants 24/7 online at gov.bc.ca/homeownergrant or they can call toll free: 1-888-355-2700 Monday to Friday from 8:30 am to 5 pm to speak with an agent. We encourage you to share this information with your residents.

The next regional calls will be in June. Ministry staff will be in touch with you about the June date, time, and meeting information. Our tentative plan after June is to take a summer break from these calls and restart them in September.

# Request for Meetings prior to UBCM

Meeting with Katrine Conroy, Min of Forests, Lands, Natural Resource Operations and Rural development

Reason for meeting: Port Clements and all the Communities of Haida Gwaii have been impacted by a lack of clear direction on forest harvest policy in the Haida Gwaii Forest District. Although the current Land Use Order defines much of the framework for agreement, harvest levels have been a fraction of the Annual Allowable cut. Market priced sales have not been offered for years, and local manufacturers and builders have no have access to timber. Currently, with an AAC of over 800,000cu. Meters, we could supply lumber to construct over 10,000 homes, yet we are bringing in lumber from off-island to try and mitigate our housing problems. This situation appears to be what the Province wishes to address with Premier Horgan's Announcement on June 1, 2021.

**The request**: That Minister Conroy direct staff to expedite meetings between her Ministry, BC Timber Sales, The Council of the Haida Nation, and MIEDS to end the impasse on market based harvesting in TSA 25 on Haida Gwaii.

#### Meeting with BC Hydro

**Reason for meeting:** As Port Clements attempts to transition to the current economy that uses internet and other forms of electronic communication to conduct business, the lack of stable power is becoming a roadblock to advancement. Since the beginning of 2021 we have experienced [xx] unplanned interruptions. Each of these interruptions has resulted in costs to individuals, businesses, and local government. The internet goes out, servers need to go through a time-consuming self-check and reboot afterwards, and the school and public buildings need to restore their heat.

The request: That BC Hydro either provide us with a timely plan for eliminating these outages or financial assistance in sourcing and installing power back-ups for essential systems so we are able to maintain consistent services in our community.

Reduced Rental Rates - Haida Gwaii Recreation Request

#### **BACKGROUND:**

For several years, the Haida Gwaii Regional Recreation Commission (Haida Gwaii Rec) has held a Summer Day Camp in Port Clements. Typically, they request an in-kind donation of Seniors Room and Community Kitchen from the Village, as the daily rental rates for the typically 2-week rental are higher than their budgets can afford for this program.

In previous years, Council has donated in-kind use of the facilities as well as potential janitorial fees that may be incurred from the rental.

#### DISCUSSION:

Haida Gwaii Rec has requested that Council provide a reduced weekly rental fee of \$150 for the camp for 2021 and beyond.

The Village's room rental fees are set out in the Fee Setting Bylaw. As they are set by bylaw, they cannot be amended by a Council resolution, so Council cannot easily give the requested rate reduction. The bylaw itself would have to be amended or rescinded and replaced to change its rates, which is a longer process to go through.

The simplest way to approach this request, if Council were amenable, would be to continue what Council has previously done and provide free use of the space as an in-kind donation. Council cannot extend an in-kind donation on a permanent basis, so Haida Gwaii Rec would have to request an in-kind donation each year that they intend to hold a camp.

Dear Council,

On behalf of Haida Gwaii Regional (HG Rec) Recreation Commission, I write to you to request in-kind support from Council to use the senior room, kitchen and outdoor play spaces for HG Rec's annual summer day camps. Port Clements camps are tentatively scheduled for July 26-30 (5 days) and Aug 3-6 2021 (4 days). It is understood that HG Rec has a day-rate of \$75/day for space use at the multiplex. We would require the space from 8:30-4:30 M-F for camp set-up, implementation, and take-down. For 9 days of camp over 2 weeks (no camp on BC Day) this would total \$675. This is beyond what we can afford for the community, given the low attendance rates and maximum allowable this year due to COVID-19 protocols.

Our staff wages are funded by Gwaii Trust Society and Canada Summer Jobs. Our registration fees cover rentals, mileage and billeting for staff, healthy snacks, materials and supplies, and instructor facilitation fees. This year we will charge \$80 for a 4-day week of camp, \$100 for a 5-day week of camp per child to cover these costs and support an engaging and fun camp, while still being accessible and affordable childcare for families. There may be room to support/subsidize individual campers as well. Attendance at the Port Clements camps is historically on the lower end and in COVID times, the maximum number of attendees in our camps this year each week is capped at 10. We are partnering with local instructors and Local Food to School to provide engaging programming and healthy snacks, all of which our registration fees help to cover. We're not looking to make profit on our camps, only to break even and keep our youth and families supported!

Our request to Council is for a weekly rental fee for HG Rec of \$150.00 for our camps (total; \$300 for 2 weeks) for 2021 and beyond. We understand that camps in past were poorly supervised and this led to damages/untidiness in the space. We apologize for past inconveniences and want to assure Council that we are committed to greater supervision of young staff going forward. We have hired Tia Nicol of Port Clements to lead camps and mentor the 2<sup>nd</sup> coordinator. The Rec Coordinator will be in attendance at each camp to support and supervise throughout. HG Rec will provide Village staff as well with an itinerary of the camp happenings, so we can be mindful of others in the space. We will have an EHO-approved COVID-19 Safety Plan on-site, provided to your staff, and on our website at <a href="https://www.hgrec.com/covid-19/">www.hgrec.com/covid-19/</a>.

With an emphasis on outdoor programming, our hope is to spend most of our time venturing the Bumper Golf course, going on scavenger hunts, and doing activities outside as much as possible. Should damages occur, we're aware of the costs to be paid to the Village for janitorial services or as compensation. We aim to be trustworthy and supportive users of the facility, mindful of the space being for Seniors first and foremost. #### **BACKGROUND:**

The Village of Port Clements has organized a Village Cleanup (usually in Spring) since at least the late 90s/early 2000s. It is a Council event (not a municipal service) held with the intention of sprucing up the town for the tourist season, hosting summer events such as Canada Days, as an incentive for property owners to clean up their properties, and to prevent dumping on Village properties. The other municipalities on Island also often have their own annual cleanup.

The event is held in April or May, sometimes split between the two. The Cleanup event is associated with the "Spring Cleaning" tradition, so it is held in the Spring though it is rarely held in March or June. It also typically accommodates 'Spring Break' and the Easter and Victoria Day Long weekend as less residents would be in town and able to participate in the event.

There is no set format to these Cleanups. The notice for the event goes around town and volunteers are notified of when it is happening. It is not mandatory for staff to assist or participate in it as it is not part of regular operations, held outside of regular work hours, and not under the purview of any Council Committees or Commissions. If volunteers choose to participate then they have the discretion to choose how to organize themselves and how they will be assisting others which is not typically overseen by staff. Sometimes staff have also volunteered with the activity, but it is not part of their job duties.

Often the Village would organize the event with the Islands Solid Waste Landfill for containers to be brought to a location of Village property and then, once full, haul the containers back to the Landfill which is repeated as necessary in the scheduled time frame. Residents are expected to make their own arrangements to bring their waste to the containers and put it in them themselves, though volunteers usually assist residents with this. The main day of the event is a Saturday (with the hauling of containers back and forth) with one container left over Sunday that is picked up on Monday.

In 2019, at the strong recommendation of Islands Solid Waste, the Village organized two "free tipping day" on the first Saturday of April and May. In this set up, residents brought their garbage to the landfill directly with the tipping fees being covered by the Village.

In 2020, with the onset of the COVID-19 pandemic, no municipalities on Haida Gwaii held cleanups.



In 2021, both the Village of Queen Charlotte and Port Clements did not plan to hold a cleanup and have not held one. The Village of Masset did hold a Spring Clean-up in May.

#### **DISCUSSION:**

Council does not have an obligation to hold a Cleanup event, but it regularly chooses to undertake it almost annually. Currently, the "free tipping day" format recommended by the Island Solids Waste and utilized in 2019 has been very successful and easy to use. The old formats of the Cleanup are also not in line with current Public Health Orders regarding gatherings/events.

As it is not a municipal service, but a Council event/project, Council identifies if they intend to hold the Cleanup for the year during the discussions and setting of the annual budget. If Council does not give direction to hold the event, and if it is not accounted for and budgeted for then the Cleanup is not held. Previous administration has identified this need for direction when Cleanups were last discussed in 2019.

The Cleanup event is accounted under beautification, withs its expenditure accounted for in the beautification budget line. This year when setting this budget item, holding a cleanup was not discussed as part of it. The 2021 beautification budget is \$1,500 dollars and has incurred no expenditures at this time. Unless there are other beautification expenditures already planned that cover this amount, then the budget could cover a cleanup expenditure.

The "free tipping day" format of the Cleanup held in 2019 was very successful. It saw significantly lower costs incurred, being a 59% reduction in cost from 2018 expenditure and a 46% reduction to 2017 expenditures. It also addressed other concerns of non-residents taking advantage of the cleanup to dump their own significant waste materials at the expense of Port Clements' Taxpayers, as had been regularly observed by residents. Other issues, such as overflowing bins and waste left beside them are also eliminated with this cleanup format.

Staff contacted the Landfill to confirm what the options for holding a Cleanup in 2021 are (if they have restrictions due to the ongoing pandemic), they strongly reiterated their recommendation for the "free tipping day" format, as it is less of a disruption to their activities and is easier for them to handle. They also identified that as they are open 6 days a week, they would prefer not holding the tipping day on the first Saturday of multiple months, but 2 days in a row of a single month.



Prior to the 2019 cleanup, the Village received a few negative complaints regarding cost (if it was an appropriate use of taxpayer dollars/Village resources), mess left behind and exploitation by non-residents. Other residents have also reached out and identified that they enjoy the Cleanup as a 'sign of spring' and that they find it beneficial to the community and hoped that it would continue to be held. Some have provided suggestions to hire someone to offer loading/unloading support or vehicle access to residents who need further assistance.

#### **CONCLUSION:**

Council did not direct a Cleanup this year, nor was it included in 2021 plans. It may also not be appropriate to hold it during the ongoing pandemic as it does encourage non-essential travel and more contact opportunities, though the Province is tentatively moving forward with reopening plans. Tentatively things may be "back to normal" by September 2021. However, September is also the start of storm season and bad weather.

It may be more appropriate to hold off on the Cleanup until 2022 and holding it in the usual springtime months of April and May.

The "free tipping day" format is recommended by Island Solid Waste and is also recommended by Village Staff.

STRATEGIC (Guiding Documents Relevancy – Strategic Plan, Official Community Plan)

A liveable, attractive community that enhances the quality of the life of residents is an essential idea within the OCP. The Annual Village Cleanup can be seen to be in that spirit, though it is not a strategic priority nor mentioned

in the OCP.

FINANCIAL (Corporate Budget Impact)

A 'Free Tipping Day' arrangement with the Landfill reduces costs and complications. A Cleanup is possible in the 2021 budget for beautification as the budget has been set for \$1,500 that has not yet been used. Unless there is already a commitment to use that budget for a purpose, then it is

available for use.

ADMINISTRATIVE (Workload Impact and Consequence)

A set 'Free Tipping Day' arrangement at the Landfill would reduce administrative time spent on organizing this event and fielding questions from the public on its scheduling. Public works would also see a negligible reduction in workload from the time spent cleaning up Village properties that the Containers are usually stationed at (typically volunteers deal with

most of the Cleanup).

#### **RECOMMENDATION**

That if Council wants a 2021 Cleanup that it utilizes the "free tipping day" format and choose two consecutive dates to hold it on. Otherwise, the recommendation is to revisit having a Cleanup in 2022.

**RE: Regular Report on Current Operations** 

#### BACKGROUND:

The CAO/Acting CAO updates Council at the Regular Council Meetings on current operations and challenges.

#### DISCUSSION:

The report is not an exhaustive list of operational activities that have occurred since the last update or are occurring, but to provide a general informational update and identify notable occurrences in current operations for Council.

#### Administration:

- o Provincial Appointment Book and Meeting request for the 2021 UCBM Convention registration is open for the meetings with Premier, Cabinet Ministries and Provincial Ministries and agencies.
- Vibrant Communities Work Plan is being finalized
- Firehall flooring project is near completion.
- o Annual report is being drafted and must be completed, advertised as per our requirements, before June 30th. A Special Meeting will be scheduled next week on June 10th or 11th.
- o John Antil, from ICIP grant funding for the Sewage Lagoon, informed us that we should be notified in June as to the Sewer Lagoon grant application.
  - o Public Health Order in effect until otherwise revoked. Restrictions on events and gatherings, new phase 1 regulations in place, followed by phase 2, 3, 4 as per the Province.
  - o It is extremely important that people remain vigilant with hand washing, wear masks in indoor public spaces, keep their circles small and only travel for essential purposes.

#### Finance:

- o Purchasing/ordering/reporting/completion of grants continues for several projects.
- o Tax notices were mailed out May 27<sup>th</sup>, however the due date listed 2020 instead of 2021. It has been corrected. New notices were sent out with a letter explaining this issue. I will contact MuniWare to see if they can program a warning that the due date is inconsistent with the tax notice.
- o Reporting requirements to LGDE has been done.
- o The Provincial initiation of a new system for centralization of the Homeowners Grant and Property Tax deferral is going smoothly.

#### **Public Works:**

- Sewer pump maintenance ongoing. Sewer pumps arriving soon.
- Well 3 completion plans continue. Working with CAO on this.
- Brushing for Froese Lighting Install is ongoing.

R-1

- O Work on level & crushed portion of the Public Works Yard project has been completed. Main grubbing of area in progress. Bonus: found evidence on 1<sup>st</sup> or 2<sup>nd</sup> well location, and information on valves, work is helping with historical locates.
- Effluent test results from Norlab for the 2021 months of January, February, March and April have been very good. Not only do they meet Provincial Standard, but also meet the stricter Federal requirements. The Village is currently no longer out of compliance.
- o Water results continue to be good.
