THAT whereas BC Hydro's 2021 Annual report identifies that Port Clements suffered an average of 20.7 interruptions in 2021, averaging over 3.5 hours, and further, that these figures do not appear to include the dozens of short duration interruptions customers experience and that these numbered are the worst in our service areas, Council requests staff to write a letter to BC Hydro with copies to MLA Jennifer Rice and Minister Lisa Beare identifying:

- The frequency of the reported incidents
- The anecdotal higher frequency of short duratiOon incidents
- The severe impact on retail business
- The impact on safety of residents
- The impact on attracting work from home and knowledge-based business
- The impact on students engaged in remote learning, public meetings and events requiring power As this problem is a concern that has been identified numerous times in past years by correspondence and meetings but appears to be increasing rather than being under control, we feel it is time for BC Hydro to provide a clear plan to move towards a solution. The letter is to include additional information provided by Councillor Cumming.

R-1—INFO - Regular Report on Current Operations - CAO Marjorie Dobson

Mayor Daugert: March 23rd, 2022, attended All-Island protocol meeting, 2 presentations on the table. The first, by Mark Baggely and Missy MacDonald was about mental health and the need for a 24-hour local crisis line. The current line is only staffed by a single person for the entire Province and has frequent times when service is not available in a timely fashion including a time of personal crisis that resulted in a loss of life. The second delegation was from the Ministry of Transportation and Infrastructure (Highways) regarding their response to coastal erosion and winter maintenance. They pointed out the very recent work on shoreline erosion in Sandspit and identified it as an ongoing concern they are responding to it as required. Regarding winter maintenance, Highways does not offer a prescriptive set of rules, but sets objectives for the contractors to meet, then evaluates that response through an audit process. March 29th, 2022 attended a viewing of proposed repairs to the Bird Tower in Sunset Park with Engineer Hossam Ammar. Also in attendance were Councillor Gould, Public Works Superintendent O'Donoghue, CAO Dobson, and Project Manager Mushynsky. Areas of deterioration were identified and Hossam promised to contact us after he had an opportunity to research some of the concerns. April 1st attended a TEAMS meeting with Engineer Assam, Project Manager Mushynsky, CAO Dobson and Deputy CAO Cumming regarding the Bird Tower. The difficulty of determining the extent of rote is a solid wood column was discussed, with the engineer offering to investigate further if there were non-destructive tests available before we4 could plan a path forward.

Councillor Cumming: Nothing to report, next week is Emergency Management Commission meeting on April 12th at 7:00 PM and Port Clements Recreation Meeting on April 14th.

Councillor Falconbridge: Note of restart of Canadian Rangers Cadets program in Port Clements.

RE: REVIEW AND COMMENT OPPORTUNITY – PROPOSED PERMANENT FOREST SERVICE ROAD DEACTIVATION

A recent review of Forest Service Road inventories within the Haida Gwaii Natural Resource District has identified potential candidates for permanent deactivation. These roads have been found to be surplus to industrial requirements or contain structures that are approaching the end of their service life.

We invite you to review these roads and provide comments to the Haida Gwaii Natural Resource District. Surplus roads are located in the following operating areas:

Proposed Forest Service Road Permanent Deactivation - Operating Areas

- Mosquito Lake (2.6km)
- Survey Creek (0.7km)
- East Yak (0.8km)

- Masset Inlet (5.4km)
- Lake Main (3.0km)
- Farm (0.2km)

The ministry does not have the ability to maintain surplus roads. If any stakeholders identify roads that should remain open and be maintained, the ministry can reassign the maintenance obligations to them through the issuance of an applicable tenure. Roads which are not reassigned to new tenures will be scheduled for permanent deactivation.

Permanent road deactivation places a road in a self-maintaining state. Drainage structures are removed and natural water courses re-established. Vehicular access after the completion of deactivation works is not always possible.

The opportunity to comment will end on May 31, 2022. Unless reassigned to a new tenure, permanent road deactivation works will be scheduled to commence in the summer of 2022.

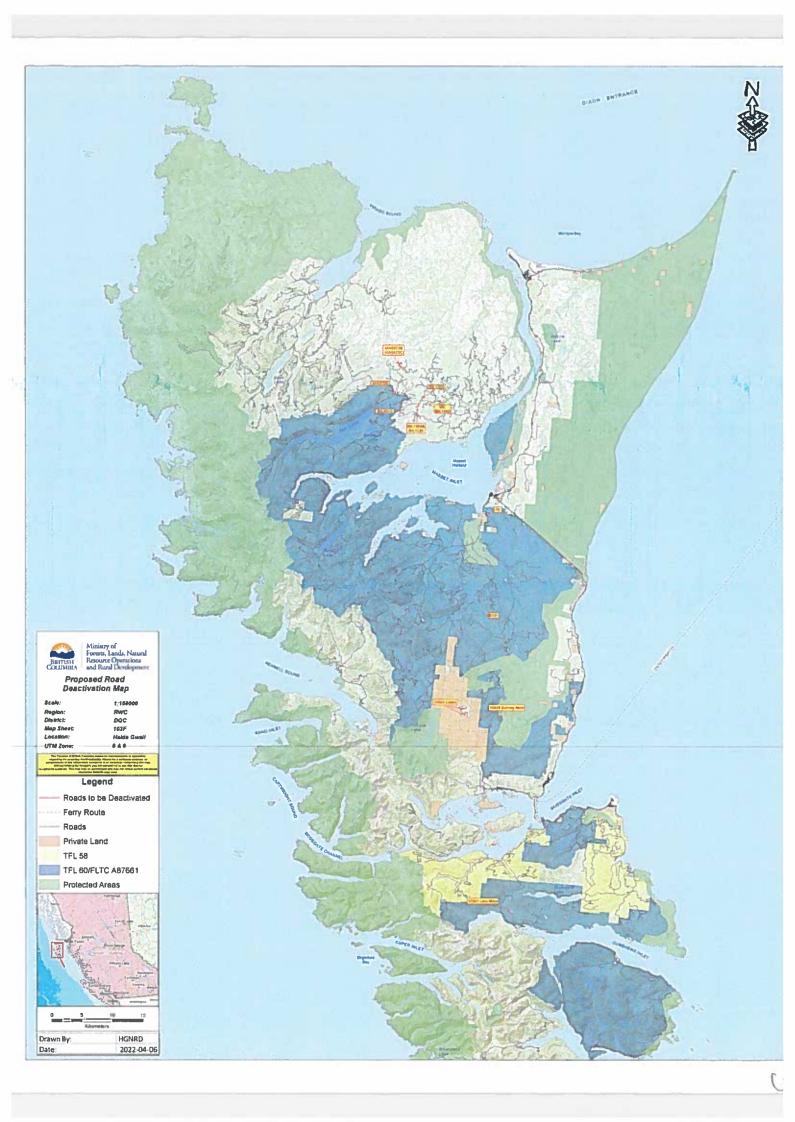

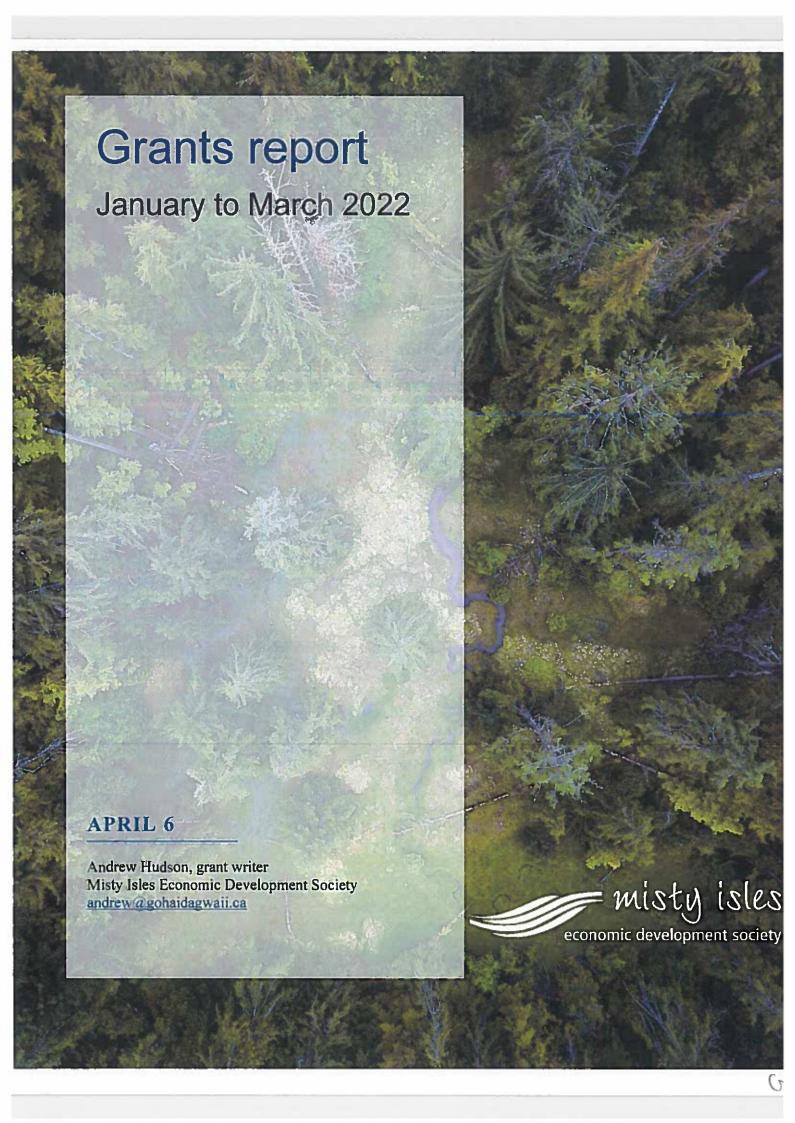

Highlights: New or upcoming grants

Canada Community-Building Fund

Union of B.C. Municipalities

Allocations vary - not a competitive grant

Funding received twice per year

30 June 2022 for Strategic Priorities Fund (100% funding up to \$6 million)

- The Canada Community-Building Fund has two streams relevant to Haida Gwaii: the Community Works Fund, and the Strategic Priorities Fund
- It was formerly known as the Community Works Fund, and the Gas Tax Fund
- The Canada Community-Building Fund is allocated to all local governments twice a year
- Eligible project categories include local roads, bridges and active transportation; drinking water; wastewater; community energy systems; public transit; solid waste; recreation and sport infrastructure; cultural infrastructure; tourism infrastructure; disaster mitigation; broadband connectivity; brownfield redevelopment; regional and local airports; short-line rail; short-sea shipping; fire halls and fire stations; and capacity building
- The Strategic Priorities Fund funds large-scale 1) capital or 2) capacity building projects that are regional or innovative projects that boost economic growth and productivity, or a clean environment, or strong cities and communities
- Sample SPF capital project streams include public transit, roads, bridges and active transportation, community energy systems, drinking water, solid waste, wastewater, local and regional airports, short-line rail, short-sea shipping, broadband connectivity, brownfield redevelopment, disaster mitigation, tourism and cultural infrastructure, recreation and sport infrastructure, and fire hall infrastructure
- Sample SPF capacity-building projects include asset management, long-term infrastructure planning, and integrated community sustainability planning

Childcare BC New Spaces Fund

Ministry of Children and Family Development

Up to \$3 million (100% funding) for public-sector organisations, Indigenous governments Up to \$1.5 million (100% funding) for Indigenous not-for-profit societies Up to \$1.5 million (90% funding) for other not-for-profit societies, including providers Next intake spring/summer 2022

- Funds new childcare spaces priorities include spaces for low-income families, children with support needs, Indigenous children, families new to Canada, parents 25 and younger, Black and other children of colour, Francophone children; also spaces co-located with a K-to-12 or public post-secondary school; spaces accessible to
- disabled children and families; projects with a provincial cost less than \$40,000 per space
 Infant/toddler spaces have increased priority this round, as do spaces licenced for children 0 to 5 and school-age children (School Age Care on School Grounds is now
- an eligible type)
 Eligible applicants include local governments, school boards, health authorities, public post-secondary schools, Indigenous governments, and not-for-profit societies
- Applicants must be willing to apply for the provincial Child Care Operating Funding program, the Child Care Fee Reduction Initiative, and Early Childhood Educator Wage Enhancement programs once spaces become operational
- Not eligible for unlicensed child care spaces, spaces licensed for occasional child care, child minding, recreational care, preschool, family or in-home multi-age care; must create new child care spaces



Projects under \$50,000 must commit to operating for 5 years, projects up to \$500,000 must commit to operating for 10 years, and those over \$500,000 must commit to operating for 15 years

CleanBC Communities Fund (Investing in Canada Infrastructure Program)

Governments of B.C. and Canada

No cap, up to 73.33% funding for local governments, 65% for non-profits

- Funds new direct-current fast charger stations see website for details on different funding amounts available for DCFCs with various output capacities
- Open to local governments, non-profits, businesses, utilities, or public-sector organisations that own or have 10-year minimum lease for charging station
- Aims to fill gaps in rural and northern areas
- Cannot be stacked with Natural Resources Canada's Electric Vehicle and Alternative Fuel Infrastructure Deployment Initiative or Zero-Emission Vehicle Infrastructure

Community Connectedness Grants

PlanH

Up to \$5,000 each

1 June 2022 (Notice in July)

- Funds Indigenous and local governments to work with health authorities and other partners on projects that foster community connectedness
- Projects should start 1 September 2022 and finish by September 2023
- Examples include hosting a facilitator as part of a program development or an Official Community Plan; developing plans for food systems and food security; including social connectedness in an Official Community Plan

Environmental Damages Fund

Environment and Climate Change Canada
Grant amounts vary by location, recent rulings
20 April 2022 at noon PST

- Funds, in priority order, projects that 1) restore the natural environment and conserve wildlife; 2) improve environmental quality; 3) research and develop environmental restoration and improvement; or 4) educate and raise awareness about issues affecting the health of the natural environment
- Account funded by fines, court orders, and voluntary payments by offenders



 Open to NGOs, Indigenous organisations, academic institutions, provincial or local governments

Green and Inclusive Community Buildings

Infrastructure Canada

Small and medium retrofits of \$100,000 to \$3M receive 80% funding

Second intake coming soon for new construction

- Funds new builds and retrofits that provide greener, more resilient public buildings to underserved communities (all but select projects should cut emissions by at least 25%)
- Eligible applicants include local/Indigenous/provincial governments, non-profits
- Projects must start and end between 1 April 2021 and 31 March 2026
- All retrofits must submit a building energy profile using RETScreen software (free, developed by Natural Resources Canada)
- Maximum funding levels on granted on a marginal-dollar basis (i.e. A new build of \$5 million would receive 80% funding for \$3 million, 60% funding for \$2 million)
- Projects larger than \$250,000 are funded through contribution agreements (applicant pays costs upfront, gets reimbursed subject to conditions)
- Most or all funding for projects under \$250,000 is provided on signing a grant agreement

Healthy Public Policy

Up to \$15,000

1 June 2022 (Notice in early July 2022)

- Funds local and Indigenous governments to develop healthy public policies
- Examples include integrating equity into existing policy, or starting a feasibility study of a healthy public policy in the community
- Projects should start 1 September 2022 and finish by September 2023

Heritage Legacy Fund

Heritage BC

Up to \$25,000 (conservation) or \$10,000 (awareness) or \$7,500 (Indigenous partnership) in 50% funding

29 April 2022 (17:00 PST), with eligibility check before 22 April

- Funds heritage awareness, heritage conservation, and Indigenous partnership projects by local governments, registered non-profit societies, self-governing First Nations, school boards, and registered federal charities
- Heritage conservation projects preserve, rehabilitate, or restore a heritage place (complete within 18 months of award)
- Heritage awareness projects research, document, present, or publish information about heritage resources (complete within 18 months of award)
- Indigenous partnership projects further reconciliation with Indigenous peoples through collaboration (complete within two years of award)

- Funds Regional C2C Forums, which aim to increase understanding and improve overall relations between First Nations and local governments.
- Forums are not limited to a pair of neighbouring communities an all-islands forum that includes Haida and civic communities would be eligible.
- Eligible applicants can apply once per intake.
- Suggested topics include reconciliation, emergency management, service planning, economic development, community development, and infrastructure planning.

Strengthening Communities' Services

Union of B.C. Municipalities

Up to \$50,000 in 100% funding for communities with less than 5,000 people 22 April 2022

- Funds local governments and Treaty First Nations to improve services, reduce community concerns, improve coordination, and increase capacity to help improve the health and safety of unsheltered homeless people living in public or private spaces, including reducing the risk of COVID-19 or other disease transmission
- Applicants must demonstrate evident need and show how the need has been exacerbated by COVID-19; provide solutions that address urgent and immediate need and do not create ongoing long-term financial obligations that can't be supported by the applicant; finish within a year of grant approval

UBCM Asset Management Planning Program

Union of B.C. Municipalities (UBCM)

Up to \$25,000 in 50% funding

6 May 2022 and 30 September 2022

- Helps local governments fund asset management plans, long-term financial plans, corporate capacity assessments, risk assessments, condition assessments
- Does not cover routine planning, feasibility studies, or purchasing capital assets
- Canada Community Building Funds and FCM Municipal Asset Management Program grants can be used to cover the 50% community contribution, along with in-kind contribution and cash contributions

2022 First Quarter Progress Report on the Strategic Plan

RECOMMENDATION(s):

That Council receives this report on the goals, objectives and targets outlined in the Village of Port Clements 2021 – 2025 Strategic Plan.

BACKGROUND:

Council requires regular updates to review progress on their Strategic Plan to make any adjustments needed to ensure deliverables can be accomplished within identified timelines.

On April 19, 2021, Council adopted their 2021-2025 Strategic Plan outlining their targets and capital priorities for the next five years. On January 17, 2022, Council adopted their Updated Strategic Plan 2021-2025. This report provides updates on each of the Council's four Strategic Priorities for the first quarter of 2022.

SUMMARY OF RESULTS:

In the 2022 Strategic Plan, Council set a total of <u>19 core services</u> targets and <u>14 Council initiative</u> targets to be completed this year (i.e. by the end of 2022). Of those, **10%** (3) are **COMPLETE**, **56%** (18) are **IN PROGRESS**, and **34%** (11) are **NOT STARTED** or **ON HOLD**.

RE: Regular Report on Current Operations

BACKGROUND:

The CAO/Acting CAO updates Council at the Regular Council Meetings on current operations and challenges.

DISCUSSION:

The report is not an exhaustive list of operational activities that have occurred since the last update or are occurring, but to provide a general update and identify notable occurrences in current operations for Council.

Administration:

- CAO and Public Works foreman attended orientation done by representatives from the Federal government relating to compliance with Wastewater.
- o Work continues to be in compliance with Provincial governments conditions of permit for Drinking water and Wastewater
- O Critical Infrastructure:
 - (a) Sewer Lagoon Project- Area is cleared of logs, and the second phase including residue survey grubbing and burning are expected to begin within the next week. The concern of increased cost still lingers
 - (b) Well #3 Construction & Connection We have been receiving quotes, and a contract will be awarded soon.
- o Golden Spruce Trail Study: Permission from funding agency has been given to change scope of work if needed.
- Funding for the following is approved:
 - (a) Community Park Upgrade
 - Seaview Ramp & wheelchair Platform

Finance:

- Year-end rollover
- o Work on next phase of budget upcoming tax rates bylaw and 5-year financial plan bylaw

Public Works:

- o Continuing work in support of Bird Tower/Sunset Trail upgrades with project manager.
- O Continuing support to engineers and administration for wastewater lagoon upgrade. Log hauling complete. Phase II of "grubbing and burning" to commence. CAO and PW had a successful teleconference with reps from DFO enforcement as well as federal Wastewater Systems Effluent Regulation administrators, result being DFO pleased with progress and WSER admins conclude that our reporting meets their criteria, their remaining concern is that the new lagoon meets the Total Suspended Solids and Biological Oxygen Demand levels set out in the regulations.
- o Froese light bases have been completed. Necessary to allow concrete to cure for a minimum of 2 weeks before final install of light posts. Should be complete at end of April.
- One event of excessive water distribution flow has been detected over a 24-hour period. A leak was suspected, but not located. Subsequent daily flow settled back down to a reasonable average level, so suspicion is now excessive use during 24 hr period.
- o Northern Health Environmental protection Officers (Drinking Water Officers) completed a site visit reviewing Well upgrade and testing procedures. Awaiting on report with any recommendations.
- Working with CAO and various key players to sort out initial planning on works surrounding recent successful funding packages. Continued concerns around local capacity (available contractors, as well as PW capacity for additional projects).
