Had an In-camera meeting to discuss Community Forest, for advice & what was possible with it.



Dear Ms. Dobson,

Thank you for your April 11, 2022 letter on behalf of the Village of Port Clements regarding the reliability in your community. I acknowledge your frustration and appreciate the opportunity to address your concerns.

The distribution circuit that supplies power to your community serves approximately 400 customers. This circuit consists of approximately 62 km of overhead line and 4 km of underground cable, running from the Masset Diesel Generating Station along the Yellowhead Highway to Port Clements. We've inspected the line and note the geography exposes this circuit to strong winds and heavy vegetation. Recent logging activity has left a narrow band of windrow trees adjacent to our power line, causing more outages as these trees fail and disrupt service.

We are working hard to improve the service to your community. Last year, I understand your mayor met with BC Hydro at the Union of BC Municipalities so we could better understand how these outages are impacting your residents. As a result of this meeting, we've developed an action plan. Our Distribution Planners will conduct a study of the circuit serving Port Clements so we can identify potential system improvements that could increase service reliability. This study is expected to be completed by December 2022.

We will also augment our vegetation management on Haida Gwaii. As you may be aware, we currently have two vegetation crews working on the Island. We have identified 174 hazard trees for removal, and we will prune approximately 23,000 metres of vegetation that could grow into the line and cause outages. This work is expected to be complete by June 2022, ahead of the autumn and winter weather.

It is important to remember that, despite our best efforts, power outages are most often caused by factors beyond anyone's control, such as wind, lightning, motor vehicle accidents, animals, and unexpected equipment failure. Hello Mayor Daugert & CAO Dobson,

I would like to thank you for our discussion on April 14th, 2022 regarding the sole payphone in Port Clements. For your awareness, the past 3 years of data for the payphone in Port Clements demonstrates a strong downward trending in use, with no recorded calls being made in over 730 days.

With the discontinuation of the payphone at the Bayview Market, there are a couple of options that may be of interest to you and your community:

- To address some of the challenges that may face more vulnerable populations or those with limited
 communications access, I have attached the link to our <u>Mobility for Good Program</u> that is available to
 ease access to a mobile device and low priced rate plan. We offer free refurbished smartphones and
 plans for youth leaving foster care and Indigenous women at risk or surviving violence. There are also
 subsidized plans and the option to buy a discontinued device from our Mobile Klinik for low-income
 seniors.
- We have low cost options to install a business phone services within public centres specifically in the public library and/or public office. For approximately \$20/month, a business and/or municipality can have a dedicated line with limits set to restrict long distance calls, incoming calls, etc. If this is an agreeable option, I would be happy to connect you with the business team that looks after these inquiries. Please note, I have inquired whether similar services have been provided to libraries across the province and thus far, only found examples of high speed internet services.

If your community would like to keep the decommissioned phone for display purposes, in part for its shared piece of technology history, I would be happy to connect you with the team looking after this. Further, as part of the payphone decommissioning, TELUS is donating \$1,000 on behalf of the community to automatically support TELUS Friendly Future Foundation to fund health, education and technology focused charitable programs for you in communities across Canada. The TELUS Friendly Future Foundation is an independent registered charitable organization that is committed to helping build brighter futures for youth through their support of health, education and technology programs.

Please feel free to reach out to me with any additional questions and if you would like me to connect you with the business team.

Golden Spruce Trail Extension Study

BACKGROUND:

One of Council's strategic priorities for 2022 and approved grant projects is the Golden Spruce Trail Extension Study.

DISCUSSION:

The project was originally intended to be undertaken and completed in 2020; however, the project was delayed with the start of the global pandemic and capacity challenges. The project is relatively small compared to other projects with a budget of \$11,150 with \$10,000 being covered by the grant received.

The project must be completed, including reporting to the grant agency, by March 31, 2023; so, this project is scheduled in the strategic plan to be undertaken and completed in 2022.

The scope of the project is to assess the feasibility of extending the Golden Spruce Trail up a portion of the Yakoun River to connect with the Village's Sunset Park Trail.

In its application, the project was identified as expected to take roughly 2 months of work. A consultant would be hired to produce the feasibility study, with the deliverables expected to include the assembly of existing maps and trail plans, site walks and hikes to scout possible trail routes, and providing a business case and final proposed mapping. The feasibility study is expected to specifically include listing options for extending the Golden Spruce Trail and connecting it with the Sunset Park Trail to create an improved destination trail.

In the time since the project has been delayed, it has been brought up by a few Council members that potentially the project scope should be changed away from being a feasibility study on extending the Golden Spruce Trail, to becoming a feasibility study on extending trails within the Village's boundaries. This is primarily due to recent changes with the GayGahlda (Changing Tide) Framework for Reconciliation signed between the Haida nation, British Columbia, and Canada; there is the view that realizing the trail extension is unlikely given that the proposed areas of its development would cross protected areas (Yaaguun Gandlaay) and crown lands that are under the management of this new agreement. The previous Yaaguun Gandlaay Management Plan identified that trails were an approved activity/facility within the area, and it is uncertain how the new framework impacts this.

Staff reached out the grant body and confirmed with them that they are open to the possibility of changing the scope of the feasibility study from extending the Golden Spruce Trail to looking at extending the trail system with Village boundaries. Staff have identified this in the Regular Report on Current Operations to Council, however, Council has not clarified if it wants to change the project scope or for staff to just continue with the existing project. Staff would like that clarification for certainty.



Staff believe it would be better to leave the project's scope on the Golden Spruce Trail extension, as the feasibility study would confirm if the extension was possible or not in the current management environment or other feasibility factors; that is the purpose of such a study. Currently the impact of the new management agreement is an assumption, not a known fact, even if it may be a reasonable one to have. Having certainty is better for Council to make decisions on.

This is particularly the case when it is likely, even if set aside on this occasion, that interest in extending the Golden Spruce Trail to connect with the Village's Sunset Park Trail will continue unless it is known to be explicitly infeasible. The potential tourism and economic development benefit to the community has been a focus for many years.

A feasibility study is also not a commitment or agreement to build the extension. It is part of the first stage of when considering committing or not to undertake such a project. The study would provide essential information and look at potential opportunities for ways to build such an extension if it could be pursued. It would also be a very beneficial or required document for possible grant applications for such a project.

Having solid information is a better value for Council's long-term planning and development considerations. Even if the project was confirmed as infeasible, it would identify what limitations or barriers make it that way, and then if those circumstances change in the future, it can be re-evaluated. In the meantime, Council would be able to clearly prioritize its resources and planning to other areas without having its attention split to this project (which is easier done when it is solidly known that the project is infeasible and why it is, especially over many years).

CONCLUSION:

Council approved the current scope of project on the Golden Spruce Trail Extension, and staff will proceed with the project as currently approved unless Council identifies that it wants the project scope change. Staff recommend leaving the project scope as it is.

STRATEGIC

(Guiding Documents Relevancy – Village Policies)

In the Village's Official Community Plan, it is identified that the Village has the objective to enhance qualify of life by providing adequate and safe infrastructure and promoting a range of age-friendly recreational opportunities, which trails would be considered a part of. Further it is committed to pursuing and supporting tourism initiatives such as parks and walking trails, and providing a system of such parks, trails, and creational areas. In either case, if the project's scope was changed or not, such feasibility study would feed into these objectives.

FINANCIAL

(Corporate Budget Impact)

The project has a budget that is majorly covered by the \$10,000 grant that was approved. If the project is not completed before the March 2023 deadline, then the Village loses the grant funding.

ADMINISTRATIVE

(Workload Impact and Consequence)

Changing the scope would likely result in more administrative work to clarify the scope change: what it consists of and where to focus the project within municipal boundaries. It would also require submission to the grant body for the scope changes to be approved – at this time they are just open to the potential to change. This potentially could delay the timeline.

RECOMMENDATION:

That Council provides clarification to staff on whether they want to pursue a scope change with this project or not.

RE: Regular Report on Current Operations

BACKGROUND:

The CAO/Acting CAO updates Council at the Regular Council Meetings on current operations and challenges.

DISCUSSION:

The report is not an exhaustive list of operational activities that have occurred since the last update or are occurring, but to provide a general update and identify notable occurrences in current operations for Council.

Administration:

Workplace observation

I have been observing employees and facilities over an extended period and believe s that the Village staff is an excellent little group. They are dependable, dedicated, and motivated.

Regarding general operations, this goes beyond the regular municipal services, and as such requires much more than the normal input from our regular staff.

The village like other communities on the island is faced with the challenges to comply with Provincial as well as Federal governments regulations regarding Drinking Water and Wastewater

The calendar year of 2022 is laden with projects targeted for completion in 2022, (great for the community). However, for some projects the preliminary work was not done, nor any funding sources targeted. Also, the absence of a provision for project management personnel for some of these projects results in village staff having to do the work. As a result, the staff is thinly stretched.

The Critical Infrastructure Projects (Sewage Lagoon and Well Construction & Connection) along with other minor projects is being impacted by the irregular market situation. Apart from the scarcity of some specialized skills, cost will exceed budget. By extension, there's concern particularly for the added funding that will be required to complete the Sewage Lagoon project that has a budget of \$3,425,832.00.

After sharing my observations with my superiors individually, and in an unofficial manner, I was inspired by their comments

There is much to be done, and while "several targets" is on the agenda, and therefore will not be ignored, special emphases will be placed on the completion of following projects: Sewage Lagoon, Drinking Water facility including the Drinking Water Emergency Response and Contingency Plan, Official Community Plan now called Integrated Community Sustainability Plan.

I have learnt and continues to learn about the Village of Port Clements in general, and the Operations of the Village in particular.

Municipal & Other Levels of Government

(i) Administration fee from Funded Projects
Response from Gwaii Trust indicated that we can apply Administrative Fee to our applications – (see attached)

Other agencies including Provincial: An approach is yet to be decided

(ii) Integrated Community Sustainable Plan (ICSP) or Official Community Plan (OCP) – Important components to the plan is being reviewed including the present Zoning, and Sub-division bylaws Also, being reviewed are plans from other communities that are more recent and includes the added components that address climate change and sustainability. Information continues to be sought relating to consultant support. Soon, the community will be given a 'teaser' that will initiate the thinking process concerning the ICSP. Note however, that this is not part of the engagement activity, but intended to give them the idea that the village will be working on this plan and will require their participation very soon.

(iii) Critical Infrastructure status

- (a) Sewer Lagoon Project- There has been no change since the report of May 2, 2022.
- (b) Well #3 Construction & Connection One of the prospective contractors for the panel construction visited the site last week. Within the next two weeks, a contractor will be selected for the panel construction.

(iv) Other Projects:

- Community Park Upgrade: Village staff has been preparing the grounds of the tennis court for repairs. The staff has decided to source the materials for the re-paving of the court and do the work which is more cost effective than bringing contractors from off island.
- Seaview Ramp & Wheelchair Platform: No changes since the report of May 2, 2022.
- Sunset Park Revitalization, Tourism Advocate Projects: Activities are progressing

Finance:

- Audited Financial Statements is completed and adopted
- o Financial Plan and Tax rate bylaws are adopted
- Utility Bills and Tax Notices will be out during this month of May

Public Works

- O Continuing work in support of Bird Tower/Sunset Trail upgrades with project manager. Waiting for assessment from qualified contractor regarding all bridge's structural members to determine level of rebuild required. i.e.: re-decking/re-railing vs. complete replacement. Receiving and assisting in placement of structures built for "Swimming Hole" area, as per project manager. Improvements to trail approach to bird tower have been completed by contractor.
- Continuing support to engineers and administration for wastewater lagoon upgrade. Waiting for completion of required Waste Residue survey, to move on to next phase.
- o PW crew tasked with prepping sports-court for resurfacing as part of funded upgrades to community park. Ongoing. Material quotes are being received for review by admin.
- Supporting admin with finishing up carried over funded projects, i.e. PW yard, Firehall interior upgrades.
- o Assisting Small Craft Harbours/DFO with electrical upgrades to Port Clements SCH. Electricians are currently on-site.
- Well completion project electrical quotes incoming. One of three received.
- PW Superintendent will be off island for 1 week beginning May 13 for Water and Wastewater training

Thanks for your patience.

Gwaii Trust does have a policy around administration fees. Below you will find what is listed in the General Grant Guidelines and in the Standard Rates on this topic.

- Gwaii Trust General Grant Guideline on Administration
 - Applicants can apply for administrative costs related to the implementation and reporting of an approved project. More information on what administrative costs can be applied for can be found in the Gwaii Trust General Grant Guidelines and Standard Rates. No administrative costs are eligible if administration of the project is a paid element of the person's employment or to cover expenses related to the application stage.
- Gwaii Trust Standard Rates for Administration
 - o Project Administration (for requests under \$50,000) Up to 15% of the Gwaii Trust ask
 - o Project Administration (for requests over \$50,000) Up to 10% of the Gwaii Trust ask

The policy relating to administration fees was reviewed and adjusted for the 2022 granting year based in part on feedback we had previously received from the Village of Port Clements. Our policies aren't reviewed more than annually, so there won't be any changes to what is outlined above for the remainder of the calendar year.

I hope that helps to clarify things.
