9. REPORTS & DISCUSSIONS

R-1—INFO -- Regular Report on Current Operations - CAO Marjorie Dobson

Mayor Daugert: MIEDS has begun interviewing for executive position, and one outstanding applicant has applied but the board is discussing whether they will be looking further or accepting the one application. Protocol Table held a non-meeting last Wednesday (no quorum - CHN, Skidegate, Old Masset not in attendance), so left Terms of Reference discussion to new Councils and representatives. Daniel Fish gave update on Solid Waste Management Plan which will be visiting Old Masset on 24th and Daajing Giids on 25th of this month for public input. Marine Public Area network public consultations - done between provincial, federal and indigenous nations on the coast to create protected areas on the north coast to enhance and maintain biodiversity - will be doing public engagement sessions. Their website has very thorough information, and they have not varied terribly from the marine planning that was done locally (changed what they call the classifications and zones, but not the actually intent). Offers some further restrictions on recreational and commercial fishing on the Islands, but if 20 years they have this kind of access that will be good as it does respect and maintain access. Main issue is that under Haida Constitution and other first nations constitutions they legally cannot be excluded from harvesting resources in their traditional territories, anywhere. It will take a balancing act of convincing the leaders in the nations to respect this plan. It is out there and if anyone has a strong interest in utilizing the fisheries in any way, he recommends looking at their open houses. In the Old Masset community hall on the 24th and in Daajing Giids in the Eric Ross Room from 3:00 PM - 8:00 PM on 25th. Has a NCRD teleconference scheduled on October 24th.

Councillor Whitney-Gould: Nothing to report, except that they held the 1st Vibrant Community Commission meeting recently for the new term.

Councillor Gould: walked the trail study area with the consultants, Patrick and Ivy. VIRL budget was reasonably contentious with such a percentage increase when most Directors came from Councils directing no budget increases. On October 13th the VIRL local branch will be handling a strategic planning session in Port Clements, which is open to the public to attend. In other communities there is a bit of resistance for having shared multipurpose facilities for libraries, however, this format has been very viable of a form in our community, a small community, and would like to see the VIRL board look at that aspect especially with the increasing costs of standalone buildings.

Councillor Cumming: Identified that Museum is on its winter hours and related attendance numbers.

Councillor Falconbridge: Nothing to report.
